A BILL ENTITLED

1 AN ACT concerning

2 **State Finance – Delinquent Federal Funds**
3 **(Federal Obligations Enforcement Act)**

4 FOR the purpose of reserving jurisdiction with respect to certain federal land in the State
5 under certain conditions; authorizing the Central Collection Unit of the Department
6 of Budget and Management to collect a certain amount of delinquent federal funds;
7 authorizing the Central Collection Unit, under a certain circumstance, to collect
8 certain federal funds owed to the State, place liens on federal property in the State,
9 and direct the Comptroller to withhold certain payments to the federal government;
10 authorizing the Board of Public Works, by a majority vote, to determine the federal
11 government to be delinquent in federal funds owed to the State under a certain
12 circumstance; requiring certain delinquent federal funds to be referred to the Central
13 Collection Unit; authorizing the Comptroller to withhold State payments to the
14 federal government for certain delinquent federal funds referred by the Central
15 Collection Unit; and generally relating to delinquent federal funds owed to the State.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That the Laws of Maryland read as follows:

25 **Article – General Provisions**

26 6–202.

27 Notwithstanding § 6–201(a) [or], § 6–203, **OR § 6–204** of this subtitle, for the
28 purpose of enforcing the civil or criminal laws of the State, the Governor may enter into an
29 agreement with the United States to establish full or partial concurrent jurisdiction of the
30 State and the United States over any land in the State held by the United States.

32 **FOR FEDERAL FUNDS DETERMINED DELINQUENT UNDER § 10–208 OF THE**
33 **STATE FINANCE AND PROCUREMENT ARTICLE, THE STATE RESERVES**
34 **JURISDICTION WITH RESPECT TO LAND THAT THE UNITED STATES OR ANY UNIT OF**
35 **THE UNITED STATES LEASES OR OTHERWISE HOLDS IN THE STATE WHEN THE**

1 FEDERAL GOVERNMENT IS FOUND NOT IN COMPLIANCE WITH COURT DECISIONS
2 UPHOLDING FEDERAL CONGRESSIONALLY APPROVED SPENDING.

- 5 (a) In this title the following words have the meanings indicated.
- 6 (b) “Department” means the Department of Budget and Management.
- 7 (c) “Secretary” means the Secretary of Budget and Management.

8 3–206.

- 9 (a) The Attorney General is legal adviser to the Department.
- 10 (b) (1) With the advice of the Secretary, the Attorney General shall assign at
11 least 1 assistant Attorney General to the Central Collection Unit.
- 12 (2) At the request of the Governor, the Attorney General shall assign to the
13 Department:
- 14 (i) at least 1 assistant Attorney General; and
- 15 (ii) any other assistant Attorneys General authorized by law to be
16 assigned to the Department.
- 17 (d) Each assistant Attorney General who is assigned to the Central Collection
18 Unit shall devote full time to the duties with that Unit and may have no other duties.

- 20 (a) (1) Except as otherwise provided in [subsection (b)] **SUBSECTIONS (B)**
21 **AND (D)** of this section, paragraph (2)(ii) of this subsection, or in other law, the Central
22 Collection Unit is responsible for the collection of each delinquent account or other debt
23 that is owed to the State or any of its officials or units.

24 **(D) THE CENTRAL COLLECTION UNIT MAY COLLECT DELINQUENT**
25 **FEDERAL FUNDS DETERMINED UNDER § 10–208 OF THIS ARTICLE IN AN AMOUNT UP**
26 **TO THE TOTAL OF DELINQUENT FEDERAL FUNDS OWED TO THE STATE.**

- 28 (a) In carrying out its responsibilities, the Central Collection Unit may:

1 (1) (i) institute, in its name, any action that is available under State
2 law for collection of a debt or claim; or

3 (ii) without suit, settle the debt or claim;

4 (2) for all debts or claims collected on or after June 1, 1992:

5 (i) in addition to the outstanding principal and interest, assess and
6 collect from the debtor a fee, which may not exceed 20% of the outstanding principal and
7 interest, sufficient to cover all collection and administrative costs; and

8 (ii) prior to crediting any amount to any agency which refers a debt
9 for any purpose, withhold a fee sufficient to cover all collection and administrative costs;

10 (3) waive or reduce any fee assessed under paragraph (2) of this subsection;

11 [and]

12 (4) certify a debt or claim and the debtor responsible for the debt or claim
13 to:

14 (i) the Comptroller for income tax refund interception in accordance
15 with Title 13, Subtitle 9 of the Tax – General Article; and

16 (ii) the State Lottery and Gaming Control Agency for State lottery
17 prize interception in accordance with § 3–307 of this subtitle; AND

18 **(5) IF THE BOARD OF PUBLIC WORKS DETERMINES THE FEDERAL**
19 **GOVERNMENT TO BE DELINQUENT IN FEDERAL FUNDS OWED TO THE STATE UNDER**
20 **§ 10–208 OF THIS ARTICLE, IN CONSULTATION WITH THE ATTORNEY GENERAL:**

21 **(I) COLLECT FEDERAL FUNDS OWED TO THE STATE;**

22 **(II) PLACE LIENS ON FEDERAL PROPERTY IN THE STATE; AND**

23 **(III) DIRECT THE COMPTROLLER TO WITHHOLD PAYMENTS TO**
24 **THE FEDERAL GOVERNMENT AS PROVIDED UNDER § 4–115 OF THE STATE**
25 **GOVERNMENT ARTICLE.**
