2 **Business Regulation – Maryland Franchise Registration and Disclosure Law –**
3 **Alterations**
4 **(Franchise Reform Act)**

5 FOR the purpose of altering the period of time within which the Securities Commissioner
6 in the Office of the Attorney General may exercise a power under certain provisions
7 of law governing the sale of franchises; ~~requiring the Securities Commissioner to~~
8 ~~require that a certain franchise registration exemption be indexed to inflation or~~
9 ~~deflation based on a certain index~~; altering the period of time within which an action
10 for liability under a certain provision of law pertaining to franchise offers for sale
11 must be brought; prohibiting a franchisor and certain others from inhibiting the
12 right of franchisees to associate for certain purposes; providing that an action may
13 be brought against a certain franchisor under certain circumstances; establishing
14 the Maryland Franchise Disclosure Document Renewal Fast-Track Review Pilot
15 Program and generally relating to the Maryland Franchise Registration and
16 Disclosure Act.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 5 That the Laws of Maryland read as follows:

18 (a) The General Assembly finds that:

19 (1) FRANCHISING HAS PLAYED A ROLE IN THE STATE’S ECONOMY BY
 20 ENABLING RESIDENTS TO OPEN AND OPERATE BUSINESSES IN THE STATE ~~UNDER~~
 21 ~~ESTABLISHED SYSTEMS AND BRANDS;~~

22 (2) the widespread sale of franchises [has], WHILE OFFERING
 23 OPPORTUNITIES TO STATE RESIDENTS, ALSO INVOLVES COMPLEX AGREEMENTS
 24 AND SUBSTANTIAL INVESTMENTS THAT CAN CREATE AND HAVE created many
 25 investment and business [problems] RISKS FOR FRANCHISEES, FRANCHISORS, AND
 26 SUBFRANCHISORS; and

27 [(2)] (3) franchisees [have suffered substantial] MAY SUFFER losses
 28 when the [franchisor or its representative] FRANCHISEE has not BEEN given complete
 29 AND ACCURATE information about:

30 (i) the NATURE OF THE franchisor–franchisee relationship;

1 (ii) the **TERMS AND OBLIGATIONS OF THE** franchise agreement;
2 and

3 (iii) the business experience **AND OPERATIONAL PRACTICES** of the
4 franchisor or its representative.

5 (b) The intent of this subtitle is to:

6 (1) give each prospective franchisee necessary information about any
7 franchise offer;

8 (2) [prohibit the sale of franchises if the sale] **PROMOTE HONESTY,**
9 **TRANSPARENCY, AND ACCOUNTABILITY, ~~AND FAIR DEALING~~ IN THE OFFER AND**
10 **SALE OF FRANCHISES;**

11 (3) **PREVENT PRACTICES THAT** would [lead to] **RESULT IN** fraud or a
12 likelihood that the franchisor's representations would not be fulfilled; [and]

13 [(3)] (4) protect the franchisor–franchisee relationship; **AND**

14 (5) **SUPPORT THE CONTINUED GROWTH OF FRANCHISING AS A**
15 **BUSINESS MODEL IN THE STATE.**

17 (a) (1) Whenever the Commissioner finds that a person has violated or is about
18 to violate this subtitle or a regulation adopted or order passed under it, the Commissioner
19 may order the person to cease and desist from the further offer to sell or sale of the franchise
20 until the offer or sale complies with this subtitle.

21 (2) After passage of a cease and desist order, the alleged violator may
22 submit to the Commissioner a written request for a hearing.

23 (3) The hearing shall begin:

24 (i) within 15 business days after the Commissioner receives the
25 request for a hearing; or

26 (ii) at a later date, with the consent of the alleged violator.

27 (4) Unless there is a timely hearing, the cease and desist order is rescinded.

28 (b) (1) Whenever the Commissioner finds that a person has violated or is about
29 to violate this subtitle or a regulation adopted or order passed under it, the Commissioner
30 may sue in the circuit court to enjoin the violation or enforce this subtitle or the regulation
31 or order.

1 (2) The court shall:

2 (i) determine if a violation of this subtitle has been or is about to be
3 committed; and

4 (ii) if so, pass any order the court considers necessary to prevent the
5 violation or remove the effects of the violation and prevent it from continuing or being
6 renewed in the future.

7 (3) The court may exercise all equitable powers necessary for this purpose,
8 including:

9 (i) injunction;

10 (ii) revocation, forfeiture, or suspension of the charter authority or
11 privileges of a business organization operating under the laws of the State;

12 (iii) dissolution of a corporation or association organized under the
13 laws of the State;

14 (iv) suspension or termination of the right of a corporation or
15 association organized under the laws of another state or country to do business in the State;

16 (v) restitution;

17 (vi) restraining order;

18 (vii) award of damages to be paid by a franchisor or subfranchisor to
19 a person injured by a violation of this subtitle; and

20 (viii) appointment of a receiver or conservator.

21 (4) The court may not require the Commissioner to post bond.

22 (c) The Commissioner may not exercise a power under this section more than [3]
23 5 years after the violation occurs.

30 (A) THIS SECTION APPLIES ONLY TO:

31 (1) A FRANCHISEE ~~OR FRANCHISOR~~ WHO IS A RESIDENT OF THE
 32 STATE; OR

1 **(2) A FRANCHISED BUSINESS THAT OPERATES OR WILL BE OPERATED**
2 **IN THE STATE.**

3 **[(a)] (B)** (1) A person who sells or grants a franchise is civilly liable to the
4 person who buys or is granted a franchise if the person who sells or grants a franchise offers
5 to sell or sells a franchise:

6 (i) without the offer of the franchise being registered under this
7 subtitle; or

8 (ii) by means of an untrue statement of a material fact or any
9 omission to state a material fact necessary in order to make the statements made, in light
10 of the circumstances under which they are made, not misleading, if the person who buys or
11 is granted a franchise does not know of the untruth or omission.

12 (2) In determining liability under this subsection, the person who sells or
13 grants a franchise has the burden of proving that the person who sells or grants a franchise
14 did not know and, in the exercise of reasonable care, could not have known of the untruth
15 or omission.

16 **[(b)] (C)** The person who buys or is granted a franchise may sue under this
17 section to recover damages sustained by the grant of the franchise.

18 **[(c)] (D)** A court may order the person who sells or grants a franchise to:

19 (1) rescind the franchise; and

20 (2) make restitution to the person who buys or is granted a franchise.

21 **[(d)] (E)** (1) Joint and several liability under this section extends to:

22 (i) each person who directly or indirectly controls a person liable
23 under this section;

24 (ii) each partner in a partnership liable under this section;

25 (iii) each principal officer or director of a corporation liable under this
26 section;

27 (iv) each other person that has a similar status or performs similar
28 functions as a person liable under this section; and

29 (v) each employee of a person liable under this section, if the
30 employee materially aids in the act or transaction that is a violation under this subtitle.

(2) However, liability under this subsection does not extend to a person who did not have knowledge of or reasonable grounds to believe in the existence of the facts by which the liability is alleged to exist.

(A) ALL FRANCHISEES HAVE THE RIGHT TO JOIN A TRADE ASSOCIATION CONSISTING OF OTHER FRANCHISEES OF THE SAME FRANCHISE AND TO PARTICIPATE IN THE TRADE ASSOCIATION FOR ANY LAWFUL PURPOSE.

(B) A FRANCHISOR MAY NOT, DIRECTLY OR INDIRECTLY, THROUGH ANY OFFICER, AGENT, OR EMPLOYEE:

(1) RESTRICT OR INHIBIT THE RIGHT OF A FRANCHISEE TO JOIN A TRADE ASSOCIATION CONSISTING OF OTHER FRANCHISEES OF THE SAME FRANCHISE; OR

(2) PROHIBIT THE RIGHT OF FREE ASSOCIATION AMONG FRANCHISEES FOR ANY LAWFUL PURPOSE.

17 (A) IN THIS SECTION, “PROGRAM” MEANS THE MARYLAND FRANCHISE
18 DISCLOSURE DOCUMENT RENEWAL FAST-TRACK REVIEW PILOT PROGRAM.

19 (B) (1) THERE IS A MARYLAND FRANCHISE DISCLOSURE DOCUMENT
20 RENEWAL FAST-TRACK REVIEW PILOT PROGRAM.

21 (2) THE COMMISSIONER SHALL ADMINISTER THE PROGRAM.

22 (C) (1) THE COMMISSIONER SHALL ESTABLISH A STANDARD FOR THE
23 REVIEW AND APPROVAL OF INCOMPLETE FRANCHISE DISCLOSURE DOCUMENTS,
24 INCLUDING FRANCHISE DISCLOSURE DOCUMENTS THAT WERE NOT SUBMITTED FOR
25 PARTICIPATION IN THE PROGRAM.

26 (2) THE COMMISSIONER MAY USE A TECHNOLOGY SYSTEM TO ASSIST
27 THE REVIEW OF DOCUMENTS AS REQUIRED UNDER THIS SECTION.

28 (D) THE COMMISSIONER SHALL ADOPT REGULATIONS TO CARRY OUT THIS
29 SECTION, INCLUDING REGULATIONS ESTABLISHING REQUIREMENTS AND

1 PROCEDURES FOR THE SUBMISSION AND APPROVAL OF FRANCHISE DISCLOSURE
2 DOCUMENTS.

3 (E) ON OR BEFORE SEPTEMBER 30, 2031, THE COMMISSIONER SHALL, IN
4 ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT ARTICLE, SUBMIT TO

 12 the end of September 30, 2032, Section 2 of this Act, with no further action required by the
 13 General Assembly, shall be abrogated and of no further force and effect.
