A BILL ENTITLED

1 AN ACT concerning

2 **Criminal Law – Interference With Access to or Egress From a Religious**
3 **Facility – Prohibition**

4 FOR the purpose of prohibiting a person, acting alone or with others, from preventing
5 another from entering or exiting a religious facility; and generally relating to access
6 to or egress from religious facilities.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Criminal Law**

21 (a) (1) In this section the following words have the meanings indicated.

22 (2) (i) “Medical facility” means:

1 (II) A CEMETERY;

2 (III) A RELIGIOUS SCHOOL, EDUCATIONAL FACILITY, OR
3 COMMUNITY CENTER; AND

4 (IV) THE GROUNDS ADJACENT TO THEM.

5 (B) (1) THIS SECTION DOES NOT APPLY TO:

6 (I) THE PERSON IN CHARGE OF THE RELIGIOUS FACILITY;

7 (II) A DESIGNEE OF THE PERSON IN CHARGE OF THE RELIGIOUS
8 FACILITY;

9 (III) AN AGENT OF THE RELIGIOUS FACILITY;

10 (IV) A LAW ENFORCEMENT OFFICER; OR

11 (V) A PERSON:

12 1. AUTHORIZED BY THE RELIGIOUS AUTHORITY TO
13 PROTECT THE RELIGIOUS FACILITY OR THE RELIGIOUS FACILITY'S ACTIVITIES; OR

14 2. OTHERWISE ACTING IN GOOD FAITH ON THE
15 RELIGIOUS FACILITY'S BEHALF TO PROTECT THE RELIGIOUS FACILITY OR THE
16 RELIGIOUS FACILITY'S ACTIVITIES.

17 (2) THIS SECTION DOES NOT PROHIBIT SPEECH.

18 (C) A RELIGIOUS FACILITY HAS SOLE DISCRETION IN DETERMINING WHO
19 MAY BE ON THE RELIGIOUS FACILITY'S PREMISES, AS DETERMINED BY THE
20 INTERNAL DICTATES OF THE RELIGIOUS ORGANIZATION.

21 (D) A PERSON MAY NOT INTENTIONALLY ACT, ALONE OR WITH OTHERS, TO
22 PREVENT ANOTHER FROM ENTERING OR EXITING A RELIGIOUS FACILITY BY
23 PHYSICALLY:

24 (1) DETAINING THE OTHER; OR

25 (2) OBSTRUCTING, IMPEDING, OR HINDERING THE OTHER'S PASSAGE.

(E) A PERSON WHO VIOLATES THIS SECTION IS GUILTY OF A MISDEMEANOR AND ON CONVICTION IS SUBJECT TO IMPRISONMENT NOT EXCEEDING 90 DAYS OR A FINE NOT EXCEEDING \$1,000 OR BOTH.

10-302.

A person may not deface, damage, or destroy, or attempt or threaten to deface, damage, or destroy, personal or real property that is owned, leased, or used by a religious entity or for any religious purpose including:

(1) a place of worship;

(2) a cemetery;

(3) a religious school, educational facility, or community center; and

(4) the grounds adjacent to them.

SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect October 1, 2026.
