## A BILL ENTITLED

1 AN ACT concerning

2 **Law Enforcement Officers' Pension System – Military Service Credit Eligibility**

3 FOR the purpose of authorizing certain members of the Law Enforcement Officers' Pension  
4 System to receive credit for certain military service if the member receives military  
5 service credit in another retirement system; prohibiting an individual from receiving  
6 credit more than a certain number of times; and generally relating to members of  
7 the Law Enforcement Officers' Pension System receiving military service credit.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – State Personnel and Pensions**

16 38–104.

17 (a) (1) This section applies to an individual who is:

18 (i) a member of a State system; or

19 (ii) a former member of a State system who is eligible to receive a  
20 benefit under § 29–302 or § 29–303 of this article.

21 (2) This section does not apply to a retiree of a State system.

(b) Except as provided in [subsection (c)] **SUBSECTIONS (C) AND (E)** of this section, an individual described in subsection (a) of this section, who has not met the conditions set forth in § 38–103(a)(2) through (4) of this subtitle, is entitled to receive service credit for military service only on the attainment of 10 years of service credit earned through employment as a member of a State system.

6 (c) (1) An individual described in subsection (a) of this section may not receive  
7 credit for that military service if the individual receives credit for military service from  
8 another retirement system for which retirement benefits have been or will be received by  
9 the individual.

10 (2) Paragraph (1) of this subsection does not apply to:

(i) credit for military service provided under:

## 1. the Social Security Act;

2. the National Railroad Retirement Act; or

3. Title 3 or Title 10, Chapter 1223, §§ 12731 through 12737  
e; [or]

(ii) disability payments from a pension or retirement system; OR

**(III) A MEMBER OR FORMER MEMBER OF THE LAW OFFICERS' PENSION SYSTEM.**

19 (3) (i) Military service credit under this section may not exceed 5 years.

(ii) Subject to subparagraph (i) of this paragraph, a member of the 1 Guard or of a reserve component of the armed forces of the United States, not been activated under Title 10 of the United States Code, shall receive the rate of 4 months for each full year of service with the Maryland National Guard or with a reserve component of the armed forces of the United States, not to exceed 36 months.

1 shall be applied to the individual's retirement allowance using the accrual rate in effect at  
2 the time the individual submits an application for military service credit to the State  
3 Retirement Agency.

4 **(E) AN INDIVIDUAL MAY NOT RECEIVE SERVICE CREDIT UNDER THIS**  
5 **SECTION MORE THAN ONCE.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
7 1, 2026.
