A BILL ENTITLED

1 AN ACT concerning

2 **Economic Development – Small, Minority, and Women–Owned Business**
3 **Accounts – Management Fees**
4 **(Small Business Increased Access to Capital Act)**

5 FOR the purpose of authorizing the Department of Commerce to authorize an eligible fund
6 manager to receive, use, and retain a certain management fee; authorizing the
7 Department to set an annual cap on the amount of certain management fees; and
8 generally relating to management fees for eligible fund managers of Small, Minority,
9 and Women–Owned Business Accounts.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Economic Development**

23 5–1501.

24 (a) In this section, “eligible fund manager” means:

1 (1) an entity that has significant financial or investment experience, under
2 criteria developed by the Department; and

3 (2) includes an entity that the Department designates to manage funds
4 received under subsection (c)(1) of this section.

5 (g) (1) Subject to paragraph (2) of this subsection, an eligible fund manager
6 may use money from grants received under this section to pay expenses for administrative,
7 actuarial, legal, and technical services.

8 (2) The Department shall set the maximum amount of grant money that
9 each eligible fund manager may use under paragraph (1) of this subsection.

10 **(3) (I) IN ADDITION TO OR IN LIEU OF THE AMOUNT AUTHORIZED**
11 **UNDER PARAGRAPH (2) OF THIS SUBSECTION, THE DEPARTMENT MAY AUTHORIZE**
12 **AN ELIGIBLE FUND MANAGER TO RECEIVE A MANAGEMENT FEE THAT IS**
13 **CALCULATED AS A PERCENTAGE OF EACH LOAN MADE UNDER SUBSECTION (D) OF**
14 **THIS SECTION.**

15 **(II) THE PERCENTAGE AUTHORIZED UNDER SUBPARAGRAPH (I)**
16 **OF THIS PARAGRAPH MAY NOT BE LESS THAN 1.5% AND MAY NOT EXCEED 3% OF THE**
17 **TOTAL LOAN PRINCIPAL.**

18 **(III) A MANAGEMENT FEE AUTHORIZED UNDER THIS**
19 **PARAGRAPH SHALL BE PAID FROM THE ACCOUNT AND MAY BE RETAINED BY AN**
20 **ELIGIBLE FUND MANAGER FOR ADMINISTRATIVE PURPOSES RELATED TO LENDING**
21 **ACTIVITIES UNDER SUBSECTION (D) OF THIS SECTION.**

22 **(4) THE DEPARTMENT MAY ESTABLISH AN ANNUAL CAP ON THE**
23 **CUMULATIVE AMOUNT OF MANAGEMENT FEES AN ELIGIBLE FUND MANAGER MAY**
24 **RECEIVE UNDER PARAGRAPHS (2) AND (3) OF THIS SUBSECTION.**

25 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
26 1, 2026.
