A BILL ENTITLED

1 AN ACT concerning

2 **State Board of Education – Membership – Educational Support Member**

3 FOR the purpose of altering the membership of the State Board of Education to include an
4 educational support member; providing for the qualifications, term, powers, and
5 election of the new member; and generally relating to the membership of the State
6 Board of Education.

7 BY repealing and reenacting, with amendments,

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 2–202.

16 (a) The State Board consists of 13 regular members, and 1 student member,
17 appointed by the Governor with the advice and consent of the Senate.

18 (b) (1) In making appointments to the State Board, the Governor shall
19 consider representation from:

20 (i) All parts of this State; and

21 (ii) Areas of this State with concentrations of population or unique
22 needs.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



(2) Except as provided in paragraphs (4) through [(6)] (7) of this subsection, the members of the Board shall be appointed from the general public.

3 (3) The following individuals may not be appointed to the Board:

4 (i) Except for the teacher member, **EDUCATIONAL SUPPORT**
5 **MEMBER**, and student member, any individual who is subject to the authority of the Board;

6 (ii) The Governor; and

7 (iii) The State Superintendent.

10 (ii) The Governor shall appoint the teacher member, with the advice
11 and consent of the Senate, who received the highest number of votes after an election by
12 teachers in the State.

19 (iv) 1. The election shall be conducted under regulations that the
20 Department adopts.

24 (v) The teacher member may attend and participate in an executive
25 session of the State Board.

26 (vi) The teacher member may not vote on any matter that relates to
27 appeals to the State Board under § 6–202 of this article.

5 (III) THE DEPARTMENT SHALL PROVIDE NOTICE OF AN
6 EDUCATIONAL SUPPORT MEMBER VACANCY ON THE STATE BOARD TO:

14 (IV) THE ELECTION SHALL BE CONDUCTED UNDER
15 REGULATIONS THAT THE DEPARTMENT ADOPTS.

16 (v) THE EDUCATIONAL SUPPORT MEMBER MAY ATTEND AND
17 PARTICIPATE IN AN EXECUTIVE SESSION OF THE STATE BOARD.

18 (VI) THE EDUCATIONAL SUPPORT MEMBER MAY NOT VOTE ON
19 ANY MATTER THAT RELATES TO APPEALS TO THE STATE BOARD UNDER § 6-202 OF
20 THIS ARTICLE.

21 [(5)] (6) (i) Of the 13 regular members of the State Board, one regular
22 member shall be the parent of a student enrolled in a public school in the State.

23 (ii) The Governor shall appoint the parent member, with the advice
24 and consent of the Senate, from a list of three qualified individuals submitted to the
25 Governor by the Maryland PTA.

26 (iii) The Department shall provide notice of the parent member
27 vacancy on the State Board to the Maryland PTA.

28 (iv) The parent member may attend and participate in an executive
29 session of the State Board.

30 [(6)] (7) The student member shall be selected by the Governor from a list
31 of 2 persons nominated by the Maryland Association of Student Councils.

32 (c) (1) The student member shall be:

- (i) A regularly enrolled student; and
- (ii) In good standing in a public high school in the State.

The student member may attend and participate in an executive d.

The student member may not vote on any matter that relates to:

- (i) The dismissal of or other disciplinary action involving personnel;
- (ii) Appeals to the State Board under § 2–205 of this subtitle or § f this article.

Each regular member serves for a term of 4 years and until a successor qualifies. These terms are staggered as required by the terms of the n the State Board as of July 1, 1989.

The Governor shall appoint a new member to fill any vacancy on the iinder of that term and until a successor is appointed and qualifies.

A member is eligible for reappointment but may not serve for more than ms.

The student member shall serve for a term of 1 year. A student member ointment but may not serve more than two full 1–year terms.
