## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Public Utilities – For–Hire Drivers and Transportation Network Operators –**  
3 **Human Trafficking Awareness and Prevention Training and Liability**

4 FOR the purpose of requiring an applicant for certain for–hire driver’s licenses ~~and~~  
5 ~~transportation network operator’s licenses~~ to submit to the Public Service  
6 Commission documentation verifying that the applicant completed a certain human  
7 trafficking awareness training program; prohibiting licensed taxicab drivers,  
8 for–hire drivers, or transportation network operators and applicants for a  
9 transportation network operator’s license from being held civilly or criminally liable  
10 for reporting or responding to in good faith a suspected incident of human trafficking;  
11 prohibiting a transportation network company from allowing certain applicants for  
12 and holders of a transportation network operator’s license to provide transportation  
13 network services using a digital network application if the applicant or license holder  
14 has not completed a certain human trafficking awareness training program; and  
15 generally relating to for–hire drivers and transportation network operators.

 19 county or municipal corporation:

 21 **FOR A LICENSE;**

22 (II) **CONDUCTS A** driving record check of each applicant for a license;  
 23 **AND**

24 (III) **REQUIRES THAT EACH APPLICANT FOR A LICENSE INCLUDE**  
 25 **IN THE APPLICATION DOCUMENTATION VERIFYING THAT THE APPLICANT**  
 26 **COMPLETED A HUMAN TRAFFICKING AWARENESS TRAINING IN ACCORDANCE WITH**

5 Commission access to the driver's photograph through the Motor Vehicle Administration;

1 (a) The term of a for-hire driver's license is not less than 1 year and not more  
2 than 3 years, as the Commission sets.

3 (b) (1) An applicant for a renewal of a for-hire driver's license shall:

4 (I) submit to the Commission an application on the form that the  
5 Commission provides; AND

6 (II) INCLUDE IN THE APPLICATION DOCUMENTATION  
7 VERIFYING THAT THE APPLICANT COMPLETED A HUMAN TRAFFICKING AWARENESS

**(G) (1) THIS SUBSECTION DOES NOT APPLY TO AN INDIVIDUAL WHO:**

**(I) SUBMITTED AN APPLICATION FOR A TRANSPORTATION NETWORK OPERATOR'S LICENSE ON OR BEFORE SEPTEMBER 30, 2026; AND**

**(II) COMPLETED, BETWEEN JULY 1, 2025, AND SEPTEMBER 30, 2026, A HUMAN TRAFFICKING AWARENESS TRAINING THAT MEETS THE REQUIREMENTS OF PARAGRAPHS (2) AND (3) OF THIS SUBSECTION.**

**(2) A TRANSPORTATION NETWORK COMPANY MAY NOT ALLOW AN APPLICANT FOR A TRANSPORTATION NETWORK OPERATOR'S LICENSE OR THE HOLDER OF A TEMPORARY OR PERMANENT TRANSPORTATION NETWORK OPERATOR'S LICENSE TO PROVIDE TRANSPORTATION NETWORK SERVICES USING A DIGITAL NETWORK APPLICATION UNLESS THE APPLICANT OR LICENSE HOLDER, WITHIN 30 DAYS AFTER THE APPLICANT OR LICENSE HOLDER FIRST PROVIDES A PREARRANGED RIDE, HAS COMPLETED:**

13                   **(II) RESPOND TO AN INDIVIDUAL WHO MAY BE OR IS A VICTIM OF**  
14 **HUMAN TRAFFICKING; AND**

15                   **(III) CONNECT AN INDIVIDUAL WHO MAY BE OR IS A VICTIM OF**  
16 **HUMAN TRAFFICKING WITH AVAILABLE RESOURCES.**

17                   **(4) AN APPLICANT FOR A TRANSPORTATION NETWORK OPERATOR’S**  
18 **LICENSE OR THE HOLDER OF A TEMPORARY OR PERMANENT TRANSPORTATION**  
19 **NETWORK OPERATOR’S LICENSE MAY NOT BE HELD CIVILLY OR CRIMINALLY LIABLE**  
20 **FOR REPORTING OR RESPONDING IN GOOD FAITH TO A SUSPECTED INCIDENT OF**  
21 **HUMAN TRAFFICKING.**

22                   SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
23                   October 1, 2026.
