## A BILL ENTITLED

1 AN ACT concerning

2 **Election Law – Absentee Ballots – Signature Requirements and Verification**

3 FOR the purpose of prohibiting a local board of elections from removing an absentee ballot  
4 from a return envelope or ballot/return envelope or counting the ballot unless the  
5 return envelope or ballot/return envelope is signed by the voter and, except under  
6 certain circumstances, a witness and the local board verify the voter's signature; and  
7 generally relating to absentee ballots.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Election Law**

21 9–303.

22 (a) The State Board shall establish guidelines for the administration of absentee  
23 voting by the local boards.

(b) The guidelines shall provide for:

(1) the application process;

(2) late application for absentee ballots;

(3) ballot security, including storage of returned ballots;

(4) determining timeliness of receipt of applications and ballots, including

applications and ballots for overseas voters;

(5) the canvass process;

(6) notice of the canvass to candidates, political parties, campaign  
as, news media, and the general public;

(7) observers of the process;

(8) review of voted ballots and envelopes for compliance with the law and tabulation acceptability;

(9) standards for disallowance of ballots during the canvass;

(10) storage and retention of ballots following canvass and certification;

(11) the permanent absentee ballot list; AND

**(12) VERIFICATION OF SIGNATURES ON ABSENTEE BALLOT  
S.**

(c) The State Board shall:

(1) in consultation with the local boards, assess the guidelines before each election; and

(2) revise the guidelines if indicated.

9-310.

(a) (5) When voted and returned to the local board, an absentee ballot shall be  
ed in a ballot envelope or ballot/return envelope, on which has been printed [an oath]  
S prescribed by the State Board.

(c) If an absentee ballot is sent by the Internet or facsimile transmission, the local shall provide the voter with an envelope template, the [oath] OATHS prescribed by

1 the State Board, and instructions for marking and returning the absentee ballot.

3       **(A) IN THIS SECTION, “UNIFORMED SERVICES” HAS THE MEANING STATED**  
4 **IN 10 U.S.C. § 101.**

5       **(B) A LOCAL BOARD MAY NOT REMOVE AN ABSENTEE BALLOT FROM THE**  
6 **RETURN ENVELOPE OR BALLOT/RETURN ENVELOPE OR COUNT THE BALLOT**  
7 **UNLESS:**

8           **(1) THE RETURN ENVELOPE OR BALLOT/RETURN ENVELOPE IS**  
9 **SIGNED BY:**

10           **(I) THE VOTER TO WHOM THE BALLOT WAS ISSUED; AND**

11           **(II) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION,**  
12 **A WITNESS OTHER THAN THE VOTER TO WHOM THE BALLOT WAS ISSUED; AND**

13           **(2) THE VOTER’S SIGNATURE IS VERIFIED AS PROVIDED IN**  
14 **SUBSECTION (D) OF THIS SECTION.**

15       **(C) THE WITNESS SIGNATURE REQUIREMENT UNDER SUBSECTION (B)(1)(II)**  
16 **OF THIS SECTION DOES NOT APPLY TO AN ABSENTEE BALLOT THAT IS VOTED AND**  
17 **RETURNED BY:**

18           **(1) AN ACTIVE DUTY MEMBER OF THE UNIFORMED SERVICES WHO IS**  
19 **SERVING OVERSEAS; OR**

20           **(2) THE SPOUSE OR DEPENDENT OF AN ACTIVE DUTY MEMBER OF THE**  
21 **UNIFORMED SERVICES WHO IS SERVING OVERSEAS IF THE SPOUSE OR DEPENDENT**  
22 **LIVES OVERSEAS.**

23       **(D) EACH LOCAL BOARD SHALL VERIFY THE SIGNATURE OF THE VOTER ON**  
24 **THE RETURN ENVELOPE OR BALLOT/RETURN ENVELOPE BY COMPARING THE**  
25 **SIGNATURE WITH THE VOTER’S REGISTRATION RECORD IN ACCORDANCE WITH**  
26 **REGULATIONS ADOPTED BY THE STATE BOARD.**

27       SECTION 2. AND BE IT FURTHER ENACTED, That, on or before the date that is  
28 1 year after the date on which this Act becomes effective, each local board of elections shall  
29 obtain technology capable of verifying the signature of a voter on the return envelope or  
30 ballot/return envelope under § 9–310.1 of the Election Law Article as enacted by Section 1  
31 of this Act.

**HOUSE BILL 830**

1 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency  
2 measure, is necessary for the immediate preservation of the public health or safety, has  
3 been passed by a yea and nay vote supported by three-fifths of all the members elected to  
4 each of the two Houses of the General Assembly, and shall take effect from the date it is  
5 enacted.
