## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Workgroup on Aging Out of Foster Care**

3 FOR the purpose of establishing the Workgroup on Aging Out of Foster Care; and generally  
4 relating to the Workgroup on Aging Out of Foster Care.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
6 That:

7 (a) There is a Workgroup on Aging Out of Foster Care.

8 (b) The Workgroup consists of the following members:

9 (1) the Secretary of Human Services, or the Secretary's designee;

10 (2) the State Superintendent of Schools, or the State Superintendent's  
11 designee;

12 (3) the Secretary of Health, or the Secretary's designee;

13 (4) the Secretary of Housing and Community Development, or the  
14 Secretary's designee; and

15 (5) the following members, appointed by the Governor:

- 1 (i) 15 individuals who are at least 18 years old and under the age of  
2 25 years, who:
- 3 1. have aged out of foster care;
  - 4 2. are currently aging out of foster care; or
  - 5 3. are members of the Department of Human Services' Youth  
6 Advisory Board; and
- 7 (ii) a representative of:
- 8 1. the Court–Appointed Special Advocate Program;
  - 9 2. the Legal Aid Bureau;
  - 10 3. the Maryland Association of Resources for Families and  
11 Youth;
  - 12 4. the Maryland Chapter of the American Academy of

  - 14 5. the Maryland Chapter of the National Association of  
15 Social Workers;

  - 24 13. the Office of the Public Defender;

5           (c)     The Workgroup shall select a member to serve as chair of the Workgroup.

6           (d)     The State ~~Council on Child Abuse and Neglect~~ Citizens Review Board for  
7 Children shall provide staff for the Workgroup.

8           (e)     (1)    A member of the Workgroup is entitled to reimbursement for expenses  
9 under the Standard State Travel Regulations, as provided in the State budget.

10           (2)    The Department of Human Services shall award a one-time stipend of  
11 \$2,000 to each member of the Workgroup appointed under subsection (b)(5)(i) of this  
12 section.

13           (f)     The Workgroup shall:

14           (1)    identify the types of resources currently available for youth who have  
15 aged out of foster care to achieve self-sufficiency, including stable housing, food security,  
16 reliable transportation, educational programs, employment, physical and behavioral health  
17 care services, disability accommodations, financial resources, and other services to address  
18 basic needs;

19           (2)    determine the effectiveness of currently available resources, and  
20 identify challenges with current services and programs that are offered before a youth ages  
21 out of the system and seek to assist youth to successfully transition into adulthood and  
22 self-sufficiency;

23           (3)    determine the types of resources that youth who have aged out of foster  
24 care are most likely to utilize when seeking continuing support, such as adults, peers,  
25 financial assistance organizations, and community groups;

26           (4)    identify the circumstances under which youth in foster care were  
27 removed from the youth's home county during any period of foster care; and

28           (5)    identify programs that have successfully improved outcomes for youth  
29 who have aged out of foster care, such as a hotline or an anonymous support line.

30           (g)     On or before June 1, 2027, the Workgroup shall submit a report of its findings  
31 and recommendations to the General Assembly, in accordance with § 2-1257 of the State  
32 Government Article.

33           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June  
34 1, 2026. It shall remain effective for a period of 1 year and 1 month and, at the end of June

1 30, 2027, this Act, with no further action required by the General Assembly, shall be  
2 abrogated and of no further force and effect.
