A BILL ENTITLED

1 AN ACT concerning

2 **Electric Vehicle Fuel Sold at Retail – Equipment Requirements, Units of**
3 **Measure, Sales Price, and Fees**

4 FOR the purpose of requiring the owner or possessor of a weight and measure used for the
5 retail sale of electricity as a vehicle fuel to display certain information in a certain
6 manner; requiring all electricity possessed, offered, or exposed for sale and sold at
7 retail as a vehicle fuel to be measured and sold in a certain manner; requiring the
8 Comptroller to determine the minimum price for the retail sale of electricity as a
9 vehicle fuel; authorizing the owner or possessor of a weight and measure used for the
10 retail sale of electricity as a vehicle fuel to charge certain fees for certain services;
11 and generally relating to the sale of electricity sold at retail as a vehicle fuel.

22 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
23 That the Laws of Maryland read as follows:

1 (a) In this title the following words have the meanings indicated.

2 (l) "Weight and measure" means any instrument or device used for weighing or
3 measuring, and any appliance or accessory associated with any instrument or device used
4 for weighing or measuring.

6 (A) (1) **THE OWNER OR POSSESSOR OF A WEIGHT AND MEASURE USED**
7 **FOR THE RETAIL SALE OF ELECTRICITY AS A VEHICLE FUEL SHALL CLEARLY AND**
8 **CONSPICUOUSLY DISPLAY INFORMATION DETAILING THE NAME, ADDRESS, AND**
9 **PHONE NUMBER OF A LOCAL PERSON RESPONSIBLE FOR THE WEIGHT AND**
10 **MEASURE.**

11 (2) **THE INFORMATION REQUIRED TO BE DISPLAYED UNDER THIS**
12 **SUBSECTION MAY BE DISPLAYED ON OR IMMEDIATELY ADJACENT TO THE WEIGHT**
13 **AND MEASURE.**

14 (B) **ALL ELECTRICITY POSSESSED, OFFERED, OR EXPOSED FOR SALE AND**
15 **SOLD AT RETAIL AS A VEHICLE FUEL SHALL BE MEASURED AND SOLD IN UNITS OF**
16 **KILOWATT-HOURS.**

17 (D) (1) **IN ADDITION TO THE PRICE CHARGED FOR THE RETAIL SALE OF**
18 **ELECTRICITY AS A VEHICLE FUEL, THE OWNER OR POSSESSOR OF A WEIGHT AND**
19 **MEASURE USED FOR THE RETAIL SALE OF ELECTRICITY AS A VEHICLE FUEL MAY**
20 **CHARGE A FEE FOR SERVICES RELATED TO THE RETAIL SALE OF ELECTRICITY AS A**
21 **VEHICLE FUEL.**

22 (2) **THE FEE AUTHORIZED UNDER THIS SUBSECTION MAY BE A FIXED**
23 **FEE OR ASSESSED BASED ON LENGTH OF TIME.**

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2026.
