A BILL ENTITLED

1 AN ACT concerning

2 **Harford County – Alcoholic Beverages – Class HC (Health Club) License – Hours**
3 **of Sale**

4 FOR the purpose of altering the hours during which a holder of a Class HC (health club)
5 beer and wine license in Harford County may sell alcoholic beverages; and generally
6 relating to alcoholic beverages licenses in Harford County.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Alcoholic Beverages and Cannabis**

20 22–102.

21 This title applies only in Harford County.

- 1 (1) a 6-day Class HC (health club) beer and wine license; and
- 2 (2) a 7-day Class HC (health club) beer and wine license.
- 3 (b) The Board may issue the 6-day or the 7-day license to a person who:
- 4 (1) sells health club services, as defined in § 14-12B-01 of the Commercial
5 Law Article;
- 6 (2) has a health club facility that offers:
- 7 (i) an indoor or outdoor swimming pool; or
- 8 (ii) pickleball courts;
- 9 (3) has at least 150 members who pay dues; and
- 10 (4) owns or leases real property in the county for use as a for-profit or
11 nonprofit health club facility.
- 12 (c) (1) The 6-day license authorizes the license holder to sell beer and wine
13 from Monday through Saturday in a bar area at a swimming pool or an indoor lounge or
14 both.
- 15 (2) The 7-day license authorizes the license holder to sell beer and wine
16 from Monday through Sunday in a bar area at a swimming pool or an indoor lounge or both.
- 17 (d) The 6-day license holder and the 7-day license holder may sell beer and wine
18 for on-premises consumption from 1 p.m. to [9 p.m.] **11 P.M.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2026.
