A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – Licensed Psychologists – Prescriptive Authority**

3 FOR the purpose of authorizing a licensed psychologist to use prescriptive authority under
4 certain circumstances if the psychologist is certified by the State Board of Examiners
5 of Psychologists; establishing the Prescriptive Authority Advisory Committee to
6 advise the Board on oversight and implementation of certain provisions of this Act;
7 establishing application and qualification requirements for certified prescribing
8 psychologists; establishing requirements for prescribing psychologists who use
9 prescriptive authority; and generally relating to licensed psychologists and
10 prescriptive authority.

1 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
2 That the Laws of Maryland read as follows:

3 **Article – Health Occupations**

4 12–101.

5 (a) In this title the following words have the meanings indicated.

6 (b) “Authorized prescriber” means any licensed dentist, licensed dental hygienist
7 with prescriptive authority under § 4–206.4 of this article, licensed physician, licensed
8 podiatrist, licensed veterinarian, advanced practice registered nurse with prescriptive
9 authority under Title 8 of this article, licensed nurse anesthetist, **LICENSED**
10 **PSYCHOLOGIST WITH PRESCRIPTIVE AUTHORITY UNDER TITLE 18, SUBTITLE 3B OF**
11 **THIS ARTICLE**, or other individual authorized by law to prescribe prescription or
12 nonprescription drugs or devices.

13 12–102.

14 (e) (1) This title does not prohibit:

15 (i) A dentist, physician, nurse or midwife, or podiatrist from
16 administering a prescription drug or device in the course of treating a patient;

17 (ii) A licensed dental hygienist from administering medication under
18 § 4–206.4 of this article; [or]

19 (iii) A nurse anesthetist from administering medication under §
20 8–513 of this article; **OR**

21 **(IV) A PRESCRIBING PSYCHOLOGIST FROM ADMINISTERING**
22 **MEDICATION UNDER TITLE 18, SUBTITLE 3B OF THIS ARTICLE.**

23 (2) For the purposes of paragraph (1)(i) of this subsection, “administering”
24 means the direct introduction of a single dosage of a drug or device at a given time, whether
25 by injection or other means, and whether in liquid, tablet, capsule, or other form.

26 18–101.

27 (a) In this title the following words have the meanings indicated.

28 (f) (1) “Practice psychology” means to provide to any person:

29 (i) Any service for compensation involving the application of
30 psychological principles, psychological methods, or psychological procedures for
31 understanding, predicting, or influencing behavior, including the principles that relate to

1 learning, perception, motivation, emotions, organizational relationships, and interpersonal
2 relationships;

3 (ii) Any service for compensation involving the application of
4 psychological methods or psychological procedures for interviewing, counseling,
5 psychotherapy, behavior modification, or hypnosis; or

6 (iii) Any service for compensation involving the application of
7 psychological methods or psychological procedures for constructing, administering, or
8 interpreting tests of mental abilities, neuropsychological functioning, aptitudes, interests,
9 attitudes, personality characteristics, emotions, or motivations.

10 (2) "Practice psychology" includes:

11 (i) The application of psychological principles and psychological
12 methods in the diagnosis, prevention, treatment, and amelioration of psychological
13 problems, emotional conditions, or mental conditions of individuals or groups;

14 (ii) The use of psychological methods to assist an individual in
15 acquiring greater human effectiveness or to modify feelings, conditions, attitudes, or
16 behavior that is emotionally, intellectually, or socially ineffectual or maladjusted; [and]

17 (iii) The use of biofeedback instruments that do not pierce or cut the
18 skin to measure physical and mental functioning; **AND**

19 **(IV) THE USE OF PRESCRIPTIVE AUTHORITY AS AUTHORIZED**
20 **UNDER SUBTITLE 3B OF THIS TITLE.**

21 (3) In this subsection, "psychological methods", "psychological principles",
22 and "psychological procedures" include the body of information that can be derived from a
23 graduate program in psychology, and other education or training recognized by the Board
24 as prerequisites for a license under this title, and that does not amount to the practice of
25 medicine.

26 18-302.

27 (a) To qualify for a license or registration, an applicant shall be an individual who
28 meets the requirements of this section.

29 (b) The applicant shall be of good moral character.

30 (c) The applicant shall be at least 18 years old.

31 (d) (1) Except as provided in this subsection, an applicant shall reside or
32 practice, or intend to reside or practice, in this State.

1 (2) The Board may issue a license or registration to an applicant who is
2 neither a resident of this State nor practicing in this State if the applicant shows that
3 issuing the license or registration would be in the interest of the citizens or government of
4 this State.

5 (e) The applicant shall submit to a criminal history records check in accordance
6 with § 18–302.1 of this subtitle.

7 (f) In addition to the other requirements of this section, to qualify to be a licensed
8 psychologist, an applicant must have:

9 (1) (i) A doctoral degree in psychology as defined in § 18–101(c)(1)(i) or
10 (iii) of this title; and

11 (ii) At least 2 years of professional, supervised experience in
12 psychology that is approved by the Board in accordance with regulations adopted by the
13 Board; or

14 (2) (i) A doctoral degree in psychology as defined in § 18–101(c)(1)(ii) of
15 this title;

16 (ii) Received a postdoctoral respecialization certificate from a
17 department of psychology that, at the time the certificate was issued, had a degree program
18 that was accredited by the American Psychological Association or the Canadian
19 Psychological Association and that included a minimum of 1,750 hours in a supervised
20 internship in accordance with regulations adopted by the Board; and

21 (iii) Completed a minimum of 1,500 hours of postcertification
22 advanced training hours or precertification hours of service as a registered psychology
23 associate in accordance with regulations adopted by the Board.

24 (h) (1) An applicant for a psychologist license shall successfully pass:

25 (i) A national examination in the practice of psychology; and

26 (ii) The State jurisprudence examination.

29 **(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS**
30 **INDICATED.**

31 **(B) “ADVISORY COMMITTEE” MEANS THE PRESCRIPTIVE AUTHORITY**
32 **ADVISORY COMMITTEE.**

1 (C) "CONTROLLED SUBSTANCE" HAS THE MEANING STATED IN § 5-101 OF
2 THE CRIMINAL LAW ARTICLE.

3 (D) "DRUG" HAS THE MEANING STATED IN § 5-101 OF THE CRIMINAL LAW
4 ARTICLE.

5 (E) "PRESCRIBING PSYCHOLOGIST" MEANS AN INDIVIDUAL WHO MEETS
6 THE REQUIREMENTS OF § 18-3B-04 OF THIS SUBTITLE AND IS CERTIFIED BY THE
7 BOARD TO USE PRESCRIPTIVE AUTHORITY.

8 (F) "PRESCRIPTION" MEANS AN ORDER FOR A DRUG, A LABORATORY TEST,
9 OR ANY MEDICINES, DEVICES, OR TREATMENTS, INCLUDING CONTROLLED
10 SUBSTANCES.

11 (G) (1) "PRESCRIPTIVE AUTHORITY" MEANS THE AUTHORITY TO
12 PRESCRIBE, ADMINISTER, MODIFY, DISCONTINUE, OR DISTRIBUTE WITHOUT
13 CHARGE STARTER DOSAGES, DRUGS, OR CONTROLLED SUBSTANCES RECOGNIZED IN
14 OR CUSTOMARILY USED IN THE DIAGNOSIS, TREATMENT, AND MANAGEMENT OF
15 INDIVIDUALS WITH PSYCHIATRIC, MENTAL, COGNITIVE, NERVOUS, EMOTIONAL,
16 DEVELOPMENTAL, OR BEHAVIORAL DISORDERS.

17 (2) "PRESCRIPTIVE AUTHORITY" INCLUDES:

18 (I) ISSUING ORAL, WRITTEN, OR ELECTRONIC PRESCRIPTIONS;

19 (II) IN CONJUNCTION WITH A PRESCRIPTION, THE ORDERING
20 OF LABORATORY TESTS, DIAGNOSTIC EXAMINATIONS, AND PROCEDURES
21 NECESSARY TO OBTAIN THE LABORATORY TESTS OR DIAGNOSTIC EXAMINATIONS;
22 AND

23 (III) OTHER PROCEDURES DIRECTLY RELATED TO THE SCOPE
24 OF PRACTICE OF PSYCHOLOGY AS DETERMINED IN REGULATIONS ADOPTED BY THE
25 BOARD.

27 (A) THERE IS A PRESCRIPTIVE AUTHORITY ADVISORY COMMITTEE.

28 (B) THE PURPOSE OF THE ADVISORY COMMITTEE IS TO ADVISE THE BOARD
29 ON OVERSIGHT AND IMPLEMENTATION OF THIS SUBTITLE.

30 (C) THE ADVISORY COMMITTEE CONSISTS OF:

1 **(1) THREE LICENSED PSYCHOLOGISTS WHO CURRENTLY SERVE ON**
2 **THE BOARD;**

3 **(2) ONE LICENSED PHYSICIAN WHO CURRENTLY SERVES ON THE**
4 **STATE BOARD OF PHYSICIANS OR IS APPOINTED BY THE STATE BOARD OF**
5 **PHYSICIANS; AND**

6 **(3) ONE LICENSED PHARMACIST WHO CURRENTLY SERVES ON THE**
7 **STATE BOARD OF PHARMACY.**

8 **(D) EACH MEMBER SHALL BE APPOINTED BY THE RESPECTIVE BOARD OF**
9 **EACH MEMBER.**

10 **(E) (1) THE TERM OF A MEMBER IS 3 YEARS.**

11 **(2) A MEMBER MAY BE REAPPOINTED.**

12 **(F) THE BOARD MAY REMOVE A MEMBER, AFTER A NOTICE AND A HEARING,**
13 **FOR INCAPACITY, INCOMPETENCE, NEGLIGENCE OF DUTY, OR MALFEASANCE IN**
14 **OFFICE.**

15 **18-3B-03.**

16 **(A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A**
17 **LICENSED PSYCHOLOGIST SHALL BE CERTIFIED BY THE BOARD AS A PRESCRIBING**
18 **PSYCHOLOGIST BEFORE THE LICENSED PSYCHOLOGIST MAY USE PRESCRIPTIVE**
19 **AUTHORITY IN THE STATE.**

20 **(B) THIS SECTION DOES NOT APPLY TO A LICENSED PSYCHOLOGIST WHO**
21 **HAS SUCCESSFULLY COMPLETED THE U.S. DEPARTMENT OF DEFENSE**
22 **PSYCHOPHARMACOLOGY DEMONSTRATION PROGRAM.**

24 **(A) TO QUALIFY TO BECOME CERTIFIED AS A PRESCRIBING PSYCHOLOGIST,**
25 **AN APPLICANT MUST:**

26 **(1) BE A LICENSED PSYCHOLOGIST IN GOOD STANDING WITH THE**
27 **BOARD;**

28 **(2) HAVE SUCCESSFULLY COMPLETED AN EDUCATIONAL PROGRAM**
29 **RECOGNIZED BY THE BOARD THAT INCLUDES:**

- 1 **(I) BASIC SCIENCE;**
- 2 **(II) FUNCTIONAL NEUROSCIENCES;**
- 3 **(III) PHYSICAL EXAMINATION;**
- 4 **(IV) INTERPRETATION OF LABORATORY TESTS;**
- 5 **(V) PATHOLOGICAL BASIS DISEASE;**
- 6 **(VI) CLINICAL MEDICINE;**
- 7 **(VII) CLINICAL NEUROTHERAPEUTICS;**
- 8 **(VIII) SYSTEMS OF CARE;**
- 9 **(IX) PHARMACOLOGY;**
- 10 **(X) CLINICAL PHARMACOLOGY;**
- 11 **(XI) PSYCHOPHARMACOLOGY;**
- 12 **(XII) PSYCHOPHARMACOLOGY RESEARCH;**
- 13 **(XIII) PROFESSIONAL, ETHICAL, AND LEGAL ISSUES; AND**
- 14 **(XIV) AT LEAST 30 HOURS OF DIDACTIC INSTRUCTION TO ENSURE**
15 **ACQUISITION OF THE NECESSARY KNOWLEDGE AND SKILLS TO PRESCRIBE IN A SAFE**
16 **AND EFFECTIVE MANNER;**
- 17 **(3) HAVE SUCCESSFULLY COMPLETED A POSTDOCTORAL**
18 **PRESCRIBING PSYCHOLOGY FELLOWSHIP THAT INCLUDES AT LEAST 400 HOURS OF**
19 **PSYCHOPHARMACOLOGICAL TREATMENT OF AT LEAST 100 PATIENTS OF A DIVERSE**
20 **PATIENT POPULATION UNDER THE DIRECTION OF QUALIFIED PRACTITIONERS; AND**
- 21 **(4) HAVE PASSED:**
- 22 **(I) THE PSYCHOPHARMACOLOGY EXAMINATION FOR**
23 **PSYCHOLOGISTS OFFERED BY THE ASSOCIATION OF STATE AND PROVINCIAL**
24 **PSYCHOLOGY BOARDS; OR**

1 **(II) AN EXAMINATION DEVELOPED BY A NATIONALLY**
2 **RECOGNIZED BODY APPROVED BY THE BOARD.**

3 **(B) THE BOARD, IN CONSULTATION WITH THE ADVISORY COMMITTEE,**
4 **SHALL ESTABLISH A JOINT POLICY FOR THE RENEWAL OF THE LICENSE AND**
5 **CERTIFICATION OF A PRESCRIBING PSYCHOLOGIST THAT REQUIRES THAT AT LEAST**
6 **20 HOURS OF THE CONTINUING EDUCATION INSTRUCTION REQUIRED FOR LICENSE**
7 **RENEWAL BE RELEVANT TO PRESCRIPTIVE AUTHORITY.**

8 **(C) THE BOARD, IN CONSULTATION WITH THE ADVISORY COMMITTEE,**
9 **SHALL DEVELOP AND IMPLEMENT PROCEDURES FOR REVIEWING EDUCATION AND**
10 **TRAINING CREDENTIALS FOR COMPLIANCE WITH CURRENT STANDARDS OF**
11 **PROFESSIONAL PRACTICE.**

12 **18-3B-05.**

13 **TO APPLY TO BECOME CERTIFIED TO USE PRESCRIPTIVE AUTHORITY, A**
14 **LICENSED PSYCHOLOGIST SHALL SUBMIT A FORM AND EVIDENCE OF COMPLIANCE**
15 **WITH THIS SUBTITLE AS REQUIRED BY THE BOARD.**

16 **18-3B-06.**

17 **THE BOARD SHALL CERTIFY AS A PRESCRIBING PSYCHOLOGIST ANY**
18 **APPLICANT WHO MEETS THE REQUIREMENTS OF THIS SUBTITLE.**

19 **18-3B-07.**

20 **(A) A PRESCRIBING PSYCHOLOGIST MAY USE PRESCRIPTIVE AUTHORITY IN**
21 **THE STATE FOR INDIVIDUALS WITH WHOM THE PRESCRIBING PSYCHOLOGIST HAS**
22 **AN ESTABLISHED CLIENT OR PATIENT RECORD AT THE TIME THE PRESCRIBING**
23 **PSYCHOLOGIST USES THE PRESCRIPTIVE AUTHORITY.**

24 **(B) A PRESCRIBING PSYCHOLOGIST WHO USES PRESCRIPTIVE AUTHORITY**
25 **SHALL:**

26 **(1) COORDINATE WITH THE PATIENT'S LICENSED MEDICAL**
27 **PROVIDER; AND**

28 **(2) MAKE AND DOCUMENT REASONABLE EFFORTS TO ENCOURAGE**
29 **THE PATIENT TO MAINTAIN OR ESTABLISH A RELATIONSHIP WITH A LICENSED**
30 **MEDICAL PROVIDER.**

1 (C) FOR EACH PRESCRIPTION ISSUED BY A PRESCRIBING PSYCHOLOGIST,
2 THE PRESCRIBING PSYCHOLOGIST SHALL:

3 (1) ENSURE THAT THE PRESCRIPTION:

4 (I) COMPLIES WITH STATE AND FEDERAL LAW; AND

5 (II) IS IDENTIFIABLE AS BEING ISSUED BY THE PRESCRIBING
6 PSYCHOLOGIST IN A MANNER DETERMINED BY THE BOARD;

7 (2) DOCUMENT THE PRESCRIPTION IN THE PATIENT'S RECORD; AND

8 (3) AS APPLICABLE, REPORT THE PRESCRIPTION TO THE
9 PRESCRIPTION DRUG MONITORING PROGRAM IN ACCORDANCE WITH TITLE 21,
10 SUBTITLE 2A OF THE HEALTH – GENERAL ARTICLE.

11 (D) BEFORE A PRESCRIBING PSYCHOLOGIST PRESCRIBES A CONTROLLED
12 SUBSTANCE, THE PRESCRIBING PSYCHOLOGIST SHALL FILE WITH THE BOARD:

13 (1) THE U.S. DRUG ENFORCEMENT AGENCY REGISTRATION NUMBER
14 OF THE PRESCRIBING PSYCHOLOGIST; AND

15 (2) THE MARYLAND STATE CONTROLLED DANGEROUS SUBSTANCE
16 REGISTRATION NUMBER OF THE PRESCRIBING PSYCHOLOGIST.

17 (E) A PRESCRIBING PSYCHOLOGIST MAY NOT DELEGATE PRESCRIPTIVE
18 AUTHORITY TO ANOTHER PERSON.

19 18-3B-08.

20 (A) A LICENSED PSYCHOLOGIST MAY NOT USE PRESCRIPTIVE AUTHORITY
21 UNLESS THE LICENSED PSYCHOLOGIST IS CERTIFIED UNDER THIS SUBTITLE.

22 (B) UNLESS CERTIFIED AS A PRESCRIBING PSYCHOLOGIST UNDER THIS
23 SUBTITLE, A PERSON MAY NOT USE THE WORDS OR TERM "PRESCRIBING
24 PSYCHOLOGIST" WITH THE INTENT TO REPRESENT THAT THE PERSON IS A
25 PRESCRIBING PSYCHOLOGIST.

26 18-3B-09.

27 (A) THE BOARD SHALL MAINTAIN RECORDS ON EACH PRESCRIBING
28 PSYCHOLOGIST THAT INCLUDE:

1 **(1) THE NAME OF THE PRESCRIBING PSYCHOLOGIST;**

2 **(2) THE IDENTIFICATION NUMBER OF THE PRESCRIBING**
3 **PSYCHOLOGIST ASSIGNED BY THE BOARD;**

4 **(3) THE U.S. DRUG ENFORCEMENT AGENCY REGISTRATION NUMBER**
5 **AND MARYLAND STATE CONTROLLED DANGEROUS SUBSTANCE REGISTRATION**
6 **NUMBER OF THE PRESCRIBING PSYCHOLOGIST, IF APPLICABLE; AND**

7 **(4) THE EFFECTIVE DATE OF THE CERTIFICATE ISSUED TO THE**
8 **PRESCRIBING PSYCHOLOGIST.**

9 **(B) (1) AT THE TIME THE BOARD CERTIFIES A PRESCRIBING**
10 **PSYCHOLOGIST UNDER THIS SUBTITLE, THE BOARD SHALL PROMPTLY TRANSMIT**
11 **THE INFORMATION LISTED IN SUBSECTION (A) OF THIS SECTION FOR THE**
12 **PRESCRIBING PSYCHOLOGIST TO THE STATE BOARD OF PHYSICIANS AND THE**
13 **STATE BOARD OF PHARMACY.**

14 **(2) THE BOARD SHALL PROMPTLY NOTIFY THE STATE BOARD OF**
15 **PHYSICIANS AND THE STATE BOARD OF PHARMACY IF THE BOARD REVOKES,**
16 **SUSPENDS, OR REINSTATES THE CERTIFICATION OR LICENSE OF A PRESCRIBING**
17 **PSYCHOLOGIST OR HAS A CERTIFICATION OR LICENSE REVOKED, SUSPENDED, OR**
18 **REINSTATED.**

19 **(C) (1) THE BOARD SHALL ADOPT RULES AND REGULATIONS FOR**
20 **DENYING, MODIFYING, SUSPENDING, OR REVOKING THE CERTIFICATION OR**
21 **LICENSE OF A PRESCRIBING PSYCHOLOGIST.**

22 **(2) THE BOARD MAY REQUIRE REMEDIATION OF ANY DEFICIENCIES**
23 **IN THE TRAINING OR PRACTICE PATTERN OF A PRESCRIBING PSYCHOLOGIST IF, IN**
24 **THE JUDGMENT OF THE BOARD, THE DEFICIENCIES COULD BE REASONABLY**
25 **EXPECTED TO JEOPARDIZE THE HEALTH, SAFETY, OR WELFARE OF THE PUBLIC.**

26 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
27 October 1, 2026.
