A BILL ENTITLED

1 AN ACT concerning

2 **Public High Schools – Sports Injury Recordkeeping and Reporting –**
3 **Requirements**

4 FOR the purpose of requiring each public high school in the State to maintain an injury log
5 for injuries that occur during school athletic activities, subject to certain
6 requirements; requiring each local school system to submit a report of high school
7 athletic injuries to the State Department of Education on or before a certain date
8 each year; and generally relating to the recordkeeping and reporting of sports
9 injuries at public high school athletic activities.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

17 **Article – Education**

18 **7–455.**

19 **(A) EACH PUBLIC HIGH SCHOOL IN THE STATE SHALL MAINTAIN A**
20 **STANDARDIZED INJURY LOG FOR ALL INJURIES THAT OCCUR DURING ATHLETIC**
21 **ACTIVITIES CONDUCTED BY THE SCHOOL.**

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



1 **(B) AN INJURY LOG REQUIRED UNDER SUBSECTION (A) OF THIS SECTION**
2 **SHALL INCLUDE, AT A MINIMUM:**

3 **(1) THE DATE AND TIME OF THE INJURY;**

4 **(2) THE SPORT OR ACTIVITY DURING WHICH THE INJURY OCCURRED;**

5 **(3) A GENERAL DESCRIPTION OF THE INJURY, INCLUDING THE BODY**
6 **PART AFFECTED;**

7 **(4) WHETHER THE INJURY OCCURRED DURING A PRACTICE,**
8 **COMPETITION, OR CONDITIONING ACTIVITY;**

9 **(5) WHETHER THE STUDENT WAS REMOVED FROM THE SPORT OR**
10 **ACTIVITY AND, IF KNOWN, THE DURATION OF REMOVAL;**

11 **(6) WHETHER MEDICAL EVALUATION OR TREATMENT WAS PROVIDED**
12 **OR RECOMMENDED;**

13 **(7) THE ROLE OF THE INDIVIDUAL DOCUMENTING THE INJURY; AND**

14 **(8) IF APPLICABLE, A DATE ON WHICH THE INJURED STUDENT IS**
15 **AUTHORIZED TO RETURN TO THE ACTIVITY.**

16 **(C) (1) THE INDIVIDUAL DOCUMENTING THE INJURY SHALL DOCUMENT**
17 **THE INJURY NOT LATER THAN 24 HOURS AFTER THE INJURY IS OBSERVED OR**
18 **REPORTED.**

19 **(2) A COACH, CERTIFIED ATHLETIC TRAINER, SCHOOL NURSE, OR**
20 **OTHER DESIGNATED SCHOOL PERSONNEL MAY COMPLETE THE DOCUMENTATION**
21 **REQUIRED UNDER THIS SECTION.**

22 **(D) EACH SCHOOL SHALL RETAIN INJURY LOGS FOR A MINIMUM OF 5 YEARS**
23 **AND MAKE THE LOGS AVAILABLE ON REQUEST BY THE LOCAL SCHOOL SYSTEM AND**
24 **THE DEPARTMENT FOR COMPLIANCE AND SAFETY REVIEW PURPOSES.**

25 **(E) (1) ON OR BEFORE JULY 1, 2027, AND EACH JULY 1 THEREAFTER,**
26 **EACH LOCAL SCHOOL SYSTEM SHALL SUBMIT AN AGGREGATED REPORT OF HIGH**
27 **SCHOOL ATHLETIC INJURIES FOR THE IMMEDIATELY PRECEDING SCHOOL YEAR TO**
28 **THE DEPARTMENT IN A MANNER PRESCRIBED BY THE DEPARTMENT.**

29 **(2) THE LOCAL SCHOOL SYSTEM MAY NOT INCLUDE INDIVIDUAL**
30 **STUDENT-IDENTIFYING INFORMATION IN THE REPORT.**

1 **(F) EACH PUBLIC HIGH SCHOOL SHALL MAINTAIN INJURY LOGS AND**
2 **REPORTS UNDER THIS SECTION IN COMPLIANCE WITH ALL APPLICABLE STATE AND**
3 **FEDERAL STUDENT PRIVACY LAWS, INCLUDING THE FEDERAL FAMILY**
4 **EDUCATIONAL RIGHTS AND PRIVACY ACT.**

5 **(G) THE DEPARTMENT, IN COLLABORATION WITH THE MARYLAND**
6 **DEPARTMENT OF HEALTH AND THE MARYLAND PUBLIC SECONDARY SCHOOLS**
7 **ATHLETIC ASSOCIATION, MAY ADOPT REGULATIONS AND STANDARDIZED**
8 **REPORTING FORMS NECESSARY TO IMPLEMENT THIS SECTION.**

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
10 1, 2026.
