1 AN ACT concerning

2 **Alcoholic Beverages – Class 3 Wineries and Class 4 Limited Wineries – Bulk**
3 **Wine**

4 FOR the purpose of authorizing the holder of a Class 3 winery license to acquire bulk wine
5 from the holder of a Class 4 limited winery license; authorizing the holder of a Class
6 4 limited winery license to sell and deliver bulk wine to the holder of a Class 3 winery
7 license; and generally relating to Class 3 wineries and Class 4 limited wineries.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That the Laws of Maryland read as follows:

20 **Article – Alcoholic Beverages and Cannabis**

2 (a) There is a Class 3 winery license.

3 (b) A license holder may:

4 (1) establish and operate a plant for fermenting and bottling wine at the
5 location described in the license;

6 (2) import bulk wine from the holder of a nonresident dealer's permit;

7 (3) **ACQUIRE BULK WINE FROM THE HOLDER OF A CLASS 4 LIMITED**
8 **WINERY LICENSE;**

9 (4) sell and deliver wine to:

10 (i) a holder of a wholesaler's license;

11 (ii) a holder of a permit that is authorized to acquire wine; and

12 (iii) a person outside the State that is authorized to acquire wine;

13 **[(4)] (5)** subject to subsection (c) of this section, sell at retail wine made
14 at the plant from products grown in the State to an individual participating in a guided
15 tour of the plant; and

16 **[(5)] (6)** serve, at no charge, not more than 6 ounces of wine made at the
17 plant to an individual who has attained the legal drinking age and is participating in a
18 guided tour of the plant.

19 (c) An individual may purchase wine under subsection **[(b)(4)] (B)(5)** of this
20 section if the individual has attained the legal drinking age.

21 (d) The license holder shall report to the Executive Director annually on a form
22 provided by the Executive Director on:

23 (1) the amount of alcoholic beverages produced under the license;

24 (2) the amount of alcoholic beverages sold for off-premises consumption;
25 and

26 (3) the amount of alcoholic beverages served for on-premises consumption.

27 (e) Except as otherwise provided by law, the license holder may not sell alcoholic
28 beverages for off-premises consumption to a person who intends to resell the alcoholic
29 beverages.

1 (f) The annual license fee:

2 (1) shall be determined by the Executive Director; and

3 (2) may not exceed \$750.

5 (b) There is a Class 4 limited winery license.

6 (c) (1) A license holder may:

7 (i) subject to paragraph (2) of this subsection, from available
8 Maryland agricultural products:

9 1. ferment and bottle wine; and

10 2. distill and bottle pomace brandy; [and]

11 (ii) sell and deliver the wine and pomace brandy to:

12 1. a holder of a wholesaler’s license;

13 2. a holder of a permit that is authorized to acquire wine or
14 pomace brandy; or

15 3. a person outside the State that is authorized to acquire
16 wine or pomace brandy; AND

17 (III) **SELL AND DELIVER BULK WINE TO THE HOLDER OF A CLASS**
18 **3 WINERY LICENSE.**

19 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
20 1, 2026.
