17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

- 7 (ii) Acquisition and disposition of real property and matters
- 8 pertaining to school construction under § 4-115 of this article;
- 9 (iii)] Employment of architects under § 4-117 of this article;
- 10 [(iv) Donations under § 4-118 of this article;
- 11 (v) Condemnation under § 4-119 of this article;
- 12 (vi) Consolidation of schools and transportation of students under §
- 13 4-120 of this article;
- 14 (vii)] **(II)** Appointment and salary of a county superintendent under
- 15 §§ 4-201 and 4-202 of this article;
- 16 [(viii)] **(III)** Employee discipline and other appeals under § 4-205(c) of
- 17 this article;
- 18 [(ix) Budgetary matters under Title 5 of this article;
- 19 (x)] **(IV)** Appointment and promotion of staff under § 6-201 of this
- 20 article;
- 21 [(xi)] **(V)** Discipline of certificated staff under § 6-202 of this article;
