5 Office of Supplier Diversity and Inclusion; ~~authorizing~~ requiring the Commission to
6 name the Office; altering the purpose and duties of the Office; altering the local small
7 business enterprise program to ~~include local or small businesses or certain other~~
8 ~~businesses~~ be the business participation program and limiting participation in the
9 program to certain businesses; requiring the Commission to adopt certain additional
10 eligibility criteria for participation in the program; authorizing the Commission to
11 accept as a registered vendor any ~~person~~ business that is registered as a vendor with
12 another jurisdiction or has self-certified as a vendor in a certain manner; authorizing
13 the Commission to adopt certain regulations to promote workforce engagement and
14 local economic benefits; and generally relating to procurement by the Washington
15 Suburban Sanitary Commission.

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
 6 That the Laws of Maryland read as follows:

15 (a) There is an Office [of Supplier Diversity and Inclusion in the Commission]

26 (B) “DISABLED VETERAN-OWNED BUSINESS” MEANS A BUSINESS THAT IS
 27 AT LEAST 51% OWNED AND CONTROLLED BY ONE OR MORE INDIVIDUALS CERTIFIED
 28 BY THE U.S. DEPARTMENT OF VETERANS AFFAIRS AS HAVING A
 29 SERVICE-CONNECTED DISABILITY REGARDLESS OF THE DISABILITY RATING.

30 (C) “LOCAL BUSINESS” MEANS A BUSINESS WITH:

31 (1) A PRINCIPAL PLACE OF BUSINESS IN MONTGOMERY COUNTY OR

18 BENEFITS WITHIN THE COMMISSION'S SERVICE DISTRICT, INCLUDING
19 ESTABLISHING DEFINITIONS AND STANDARDS FOR CONTRACTOR GOOD FAITH
20 EFFORTS REGARDING:

21 (1) LOCAL HIRING AND RECRUITMENT;

22 (2) SKILLS TRAINING, PRE-APPRENTICESHIP, AND APPRENTICESHIP
23 PARTICIPATION OR SUPPORT; AND

24 (3) DATA REPORTING ON WORKFORCE RESIDENCY OR LOCAL

28 Program of the Washington Suburban Sanitary Commission.

30 October 1, 2026.
