## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Child in Need of Assistance – Proceedings – Child’s Right to be Present**

3 FOR the purpose of authorizing a child who is the subject of a child in need of assistance  
4 proceeding to be present at the proceeding; authorizing the court to exclude the child  
5 from a proceeding under certain circumstances ~~and after considering certain~~  
6 ~~alternatives~~; and generally relating to children in need of assistance.

7 BY repealing and reenacting, without amendments,

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
18 That the Laws of Maryland read as follows:

2 (a) In this subtitle the following words have the meanings indicated.

3 (e) "Child" means an individual under the age of 18 years.

4 (f) "Child in need of assistance" means a child who requires court intervention  
5 because:

6 (1) The child has been abused, has been neglected, has a developmental  
7 disability, or has a mental disorder; and

8 (2) The child's parents, guardian, or custodian are unable or unwilling to  
9 give proper care and attention to the child and the child's needs.

10 (g) "CINA" means a child in need of assistance.

11 (i) "Court" means the circuit court for a county sitting as the juvenile court.

12 3-831.

13 (A) EXCEPT AS PROVIDED IN SUBSECTION (B) OF THIS SECTION, A CHILD  
14 WHO IS THE SUBJECT OF A CINA PROCEEDING UNDER THIS SUBTITLE HAS THE  
15 RIGHT TO BE PRESENT AT THE PROCEEDING.

16 (B) THE COURT MAY EXCLUDE A CHILD FROM A CINA PROCEEDING IF:

17 ~~(1) THE THE CHILD'S ATTORNEY:~~

7           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
8 October 1, 2026.
