1 AN ACT concerning

2 **Alcoholic Beverages – License Fee Refund Requirements – Alterations**

3 FOR the purpose of altering certain alcoholic beverages license fee refund requirements to
4 allow for certain members of the National Oceanic and Atmospheric Administration
5 and the Public Health Service to be eligible for a certain refund; and generally
6 relating to alcoholic beverages licenses.

7 BY repealing and reenacting, with amendments,
8 Article – Alcoholic Beverages and Cannabis
9 Section 3–108 and 4–113
10 Annotated Code of Maryland
11 (2024 Replacement Volume and 2025 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Alcoholic Beverages and Cannabis**

15 3–108.

16 (a) Except as provided in subsection (b) of this section, a license holder is not
17 entitled to a refund of the unearned portion of the license fee.

18 (b) A refund shall be issued to a license holder on surrender of the license if:

10 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July
11 1, 2026.
