1 AN ACT concerning

2 **Baltimore County – Property Tax Credit – Fraternal Order of Police Lodge 34**

3 FOR the purpose of authorizing the governing body of Baltimore County to grant, by law,
4 a property tax credit against the county property tax imposed on certain real
5 property owned by the Fraternal Order of Police Lodge 34; and generally relating to
6 a property tax credit for real property owned by the Fraternal Order of Police Lodge
7 34 in Baltimore County.

13 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

14 That the Laws of Maryland read as follows:

15 **Article – Tax – Property**

17 **(J) (1) THE GOVERNING BODY OF BALTIMORE COUNTY MAY GRANT, BY**
18 **LAW, A PROPERTY TAX CREDIT UNDER THIS SUBSECTION AGAINST THE COUNTY**
19 **PROPERTY TAX IMPOSED ON REAL PROPERTY THAT IS:**

5 (2) FOR EACH TAXABLE YEAR, THE AMOUNT OF THE PROPERTY TAX
6 CREDIT GRANTED UNDER THIS SUBSECTION SHALL EQUAL 100% OF THE PROPERTY
7 TAX IMPOSED ON THE PROPERTY.

8 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
9 1, 2026, and shall be applicable to all taxable years beginning after June 30, 2026.
