1 AN ACT concerning

2 **Oversight Committee on Quality of Care in Nursing Homes and Assisted Living**  
3 **Facilities – Membership**

4 FOR the purpose of altering the membership of the Oversight Committee on Quality of  
5 Care in Nursing Homes and Assisted Living Facilities; and generally relating to the  
6 Oversight Committee on Quality of Care in Nursing Homes and Assisted Living  
7 Facilities.

8 BY repealing and reenacting, without amendments,  
9 Article – Health – General  
10 Section 19–1409(a)  
11 Annotated Code of Maryland

13 BY repealing and reenacting, with amendments,

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
19 That the Laws of Maryland read as follows:

20 **Article – Health – General**

2 (a) There is an Oversight Committee on Quality of Care in Nursing Homes and  
3 Assisted Living Facilities.

4 (b) The Oversight Committee shall consist of the following members:

5 (1) One member of the Senate Finance Committee, appointed by the  
6 President of the Senate;

7 (2) [One member of the Senate Education, Health, and Environmental  
8 Affairs Committee, appointed by the President of the Senate;

9 (3) Two members] **ONE MEMBER** of the House Health ~~and Government~~  
10 ~~Operations~~ Committee, appointed by the Speaker of the House;

11 [(4)] **(3)** The Secretary of Aging, or the Secretary’s designee;

12 [(5)] **(4)** The Secretary of Health, or the Secretary’s designee;

13 [(6)] **(5)** The Director of the Office of Health Care Quality, or the  
14 Director’s designee;

15 [(7)] **(6)** The Deputy Secretary for Behavioral Health, or the Deputy  
16 Secretary’s designee;

17 [(8)] **(7)** The Secretary of Human Services, or the Secretary’s designee;

18 [(9)] **(8)** The Secretary of Disabilities, or the Secretary’s designee;

19 [(10)] **(9)** The State Long–Term Care Ombudsman;

20 [(11)] **(10)** Two representatives of area agencies on aging, one of which shall  
21 be a member of a local long–term care ombudsman program established under Title 10,  
22 Subtitle 9 of the Human Services Article, selected by the President of the Maryland  
23 Association of Area Agencies on Aging;

24 [(12)] **(11)** One representative of a local long–term care ombudsman entity,  
25 selected by the State Long–Term Care Ombudsman;

26 [(13)] **(12)** Three consumer members, selected by the State Long–Term  
27 Care Ombudsman, all of whom shall be consumers living in an assisted living facility or a  
28 nursing home or have a family member living in an assisted living facility or a nursing  
29 home;

1 [(14)] (13) The following representatives, selected by the organizations the  
 2 individual represents:

19 (X) **ONE REPRESENTATIVE OF LEADING AGE MARYLAND; AND**

20 [(15)] (14) Three representatives from the assisted living industry, of  
 21 which, **TO THE EXTENT PRACTICABLE**, one shall represent a program that cares for one  
 22 to four residents, one shall represent a program that cares for five to nine residents, and  
 23 one shall represent a program that cares for more than 10 residents.

24 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
 25 October 1, 2026.
