18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Health – General**

21 19–1409.

22 (a) There is an Oversight Committee on Quality of Care in Nursing Homes and
23 Assisted Living Facilities.

23 **[(13)] (12)** Three consumer members, selected by the State Long-Term
24 Care Ombudsman, all of whom shall be consumers living in an assisted living facility or a
25 nursing home or have a family member living in an assisted living facility or a nursing
26 home;

27 [(14)] (13) The following representatives, selected by the organizations the
