A BILL ENTITLED

1 AN ACT concerning

2 **Income and Property Tax Incentives – Members and Veterans of the Space**
3 **Force – Application**

4 FOR the purpose of applying certain provisions of law relating to the job creation tax credit
5 and certain property tax credits and exemptions for certain members, veterans, and
6 surviving spouses of certain members and veterans of the military, naval, or air
7 service to certain members, veterans, and surviving spouses of certain members and
8 veterans of the space force; and generally relating to income and property tax
9 incentives for members, veterans, and surviving spouses of members and veterans
10 of the space force.

15 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
16 That the Laws of Maryland read as follows:

19 (a) In this subtitle the following words have the meanings indicated.

20 (b) “Active duty” has the meaning stated in 37 U.S.C. § 101.

21 (c) **“ACTIVE MILITARY, NAVAL, AIR, OR SPACE SERVICE” HAS THE MEANING
22 STATED IN 38 U.S.C. § 101.**

23 (D) “Active service member” means an individual who is:

24 (1) an active duty member of the uniformed services; or

25 (2) serving in a reserve component of the uniformed services on active duty
26 orders.

27 [(d)] (E) “Armed forces” has the meaning stated in 10 U.S.C. § 101.

28 [(e)] (F) “Board” means the Board of Trustees of the Maryland Veterans Trust.

29 [(f)] (G) “Department” means the Department of Veterans and Military
30 Families.

1 [(g)] (H) "Military family" includes the spouse and dependent children of a
2 service member or veteran related by blood, marriage, or adoption.

3 [h] (I) "Reserve component" has the meaning stated in 37 U.S.C. § 101.

4 [i] (j) "Secretary" means the Secretary of Veterans and Military Families.

5 [(j)] (K) "Service member" means an individual who is a member of:

6 (1) the uniformed services; or

7 (2) a reserve component of the uniformed services.

8 [(k)] (L) “Trust” means the Maryland Veterans Trust.

9 [l] (M) "Uniformed services" has the meaning stated in 37 U.S.C. § 101.

10 **[(m)] (N)** Except as otherwise provided in this subtitle, “veteran” has the
11 meaning stated in 38 U.S.C. § 101.

12 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
13 as follows:

Article – Economic Development

15 6-301.

(a) In this subtitle the following words have the meanings indicated.

17 (e) "Qualified veteran employee" means an individual who:

18 (1) is honorably discharged or released under honorable circumstances
19 from active military, naval, [or] air, **OR SPACE** service as defined in [38 U.S.C. § 101] §
20 **9-901 OF THE STATE GOVERNMENT ARTICLE**; and

21 (2) is a qualified veteran as defined under § 51(d)(3)(A) of the Internal
22 Revenue Code for purposes of the federal Work Opportunity Tax Credit.

23 SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
24 as follows:

27 (a) In this article the following words have the meanings indicated.

1 **(A-2) "ACTIVE MILITARY, NAVAL, AIR, OR SPACE SERVICE" HAS THE MEANING**
2 **STATED IN § 9-901 OF THE STATE GOVERNMENT ARTICLE.**

3 **[(a-2)] (A-3)** “Active service member” has the meaning stated in § 9-901 of the
4 State Government Article.

6 (a) (1) In this section the following words have the meanings indicated.

10 (i) is reasonably certain to continue for the life of the service
11 member; and

12 (ii) was not caused or incurred by misconduct of the service member.

13 (3) (i) "Disabled veteran" means an individual who:

22 B. was not caused or incurred by misconduct of the veteran.

23 (ii) "Disabled veteran" includes an individual who qualifies
24 posthumously for a 100% service connected disability.

25 (4) “Dwelling house”:

26 (i) means real property that is:

(ii) includes the lot or curtilage and structures necessary to use the real property as a residence.

7 (6) "Surviving spouse" means an individual who has not remarried and
8 who:

9 (i) is the surviving spouse of a disabled veteran;

10 (ii) is the surviving spouse of an individual who died in the line of
11 duty; or

12 (iii) receives Dependency and Indemnity Compensation from the U.S.
13 Department of Veterans Affairs.

14 (d) (1) A disabled veteran or a surviving spouse of a disabled veteran shall
15 apply for an exemption under this section by providing to the supervisor:

16 (i) a copy of the disabled veteran's discharge certificate from active
17 military, naval, [or] air, OR SPACE service; and

18 (ii) 1. on the form provided by the Department, a certification of
19 the disabled veteran's disability from the U.S. Department of Veterans Affairs; or

31 SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall be
32 applicable to all taxable years beginning after December 31, 2025.

1 SECTION 5. AND BE IT FURTHER ENACTED, That Section 3 of this Act shall be
2 applicable to all taxable years beginning after June 30, 2026.

3 SECTION 6. AND BE IT FURTHER ENACTED, That this Act shall take effect July
4 1, 2026.
