## A BILL ENTITLED

1 AN ACT concerning

2 **Higher Education – Nonresident Tuition – Exemption for Dependents of State or**  
3 **Local Public Safety Employees**  
4 **(Maryland Fallen Heroes Tuition Benefits Act)**

5 FOR the purpose of exempting financially dependent children of certain State or local  
6 public safety employees from paying out-of-state or out-of-county tuition at a public  
7 institution of higher education in the State; and generally relating to nonresident  
8 tuition exemptions for financially dependent children of State or local public safety  
9 employees.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

1                   **(A) IN THIS SECTION, “STATE OR LOCAL PUBLIC SAFETY EMPLOYEE” HAS**  
2                   **THE MEANING STATED IN § 18–601 OF THIS ARTICLE.**

3                   **(B) NOTWITHSTANDING THE STATE OR COUNTY IN WHICH THE CHILD**  
4                   **RESIDES, A FINANCIALLY DEPENDENT CHILD OF A STATE OR LOCAL PUBLIC SAFETY**  
5                   **EMPLOYEE WHO DIES AS A RESULT OF OR IN THE COURSE OF PERFORMANCE OF**  
6                   **DUTIES IS EXEMPT FROM PAYING OUT–OF–STATE OR OUT–OF–COUNTY TUITION AT**  
7                   **A PUBLIC INSTITUTION OF HIGHER EDUCATION IN THE STATE.**

8                   **(C) THE COMMISSION SHALL ADOPT REGULATIONS TO IMPLEMENT THIS**  
9                   **SECTION.**

11                  (a)     (1)    In this section the following words have the meanings indicated.

12                  (5)    “State or local public safety employee” means a person who is employed  
13    in the State as:

14                  (i)     A career or volunteer member of a:

15                  1.     Fire department;

16                  2.     Ambulance company or squad; or

17                  3.     Rescue company or squad;

18                  (ii)    A law enforcement officer;

19                  (iii)   A correctional officer; or

20                  (iv)    A member of the Maryland National Guard who was a resident  
21    of this State at the time of death.

22                  SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
23    1, 2026.
