1 AN ACT concerning

2 **Election Law – Presidential Electors – Selection and Voting**

3 FOR the purpose of altering the procedures for the selection of presidential elector
4 nominees and alternate presidential elector nominees; requiring the State
5 Administrator of Elections to preside at a certain meeting of certain presidential
6 electors; altering the procedures for the meeting of presidential electors; establishing
7 procedures for the preparation, delivery, signing, and transmission of an amended
8 certificate of ascertainment after the vote of the State’s presidential electors under
9 certain circumstances; and generally relating to presidential electors.

9 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
10 That the Laws of Maryland read as follows:

11 **Article – Election Law**

12 1–101.

13 (a) In this article the following words have the meanings indicated unless a
14 different meaning is clearly intended from the context.

15 **(II–2) “PRESIDENTIAL ELECTOR” MEANS AN ELECTOR FOR PRESIDENT AND**
16 **VICE PRESIDENT OF THE UNITED STATES.**

17 **(TT–1) “UNAFFILIATED PRESIDENTIAL CANDIDATE” MEANS A**
18 **CANDIDATE FOR PRESIDENT OF THE UNITED STATES WHO QUALIFIES FOR THE**
19 **GENERAL ELECTION BALLOT BY MEANS OTHER THAN NOMINATION BY A POLITICAL**
20 **PARTY.**

21 **[(tt–1)] (TT–2)** “Uniformed services” has the meaning stated in § 9–901 of the
22 State Government Article.

23 8–503.

24 [(a) Each political party shall nominate or provide for the nomination of
25 candidates for presidential elector of the party in accordance with party rules.

26 (b) The number of candidates nominated by each political party shall be the
27 number that this State is entitled to elect.]

28 **(A) (1) FOR EACH PRESIDENTIAL ELECTOR, A POLITICAL PARTY**
29 **CONTESTING THE POSITION, OR AN UNAFFILIATED PRESIDENTIAL CANDIDATE,**
30 **SHALL SUBMIT TO THE STATE BOARD THE NAMES OF TWO QUALIFIED INDIVIDUALS.**

31 **(2) ONE OF THE INDIVIDUALS SHALL BE DESIGNATED**
32 **“PRESIDENTIAL ELECTOR NOMINEE” AND THE OTHER “ALTERNATE PRESIDENTIAL**
33 **ELECTOR NOMINEE”.**

1 **[(c)] (B)** (1) The names and residential addresses of [individuals nominated
2 as candidates for presidential elector] **THE PRESIDENTIAL ELECTOR NOMINEES AND**
3 **ALTERNATE PRESIDENTIAL ELECTOR NOMINEES SUBMITTED TO THE STATE BOARD**
4 **IN ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION** by a political party shall be
5 certified to the State Board by the presiding officers of the political party.

6 (2) The names and residential addresses of [individuals nominated as
7 candidates for presidential elector] **THE PRESIDENTIAL ELECTOR NOMINEES AND**
8 **ALTERNATE PRESIDENTIAL ELECTOR NOMINEES SUBMITTED TO THE STATE BOARD**
9 **IN ACCORDANCE WITH SUBSECTION (A) OF THIS SECTION** by a candidate for President
10 of the United States who is nominated by petition shall be certified to the State Board by
11 the candidate.

12 (3) The **NOMINEES FOR PRESIDENTIAL** electors **AND ALTERNATE**
13 **PRESIDENTIAL ELECTORS** shall be certified to the State Board at least 30 days before the
14 general election.

16 **(A) EACH PRESIDENTIAL ELECTOR NOMINEE AND ALTERNATE**
17 **PRESIDENTIAL ELECTOR NOMINEE OF A POLITICAL PARTY SHALL EXECUTE THE**
18 **FOLLOWING PLEDGE: “IF SELECTED FOR THE POSITION OF PRESIDENTIAL**
19 **ELECTOR, I AGREE TO SERVE AND TO MARK MY BALLOTS FOR PRESIDENT AND VICE**
20 **PRESIDENT FOR THE NOMINEES FOR THOSE OFFICES OF THE PARTY THAT**
21 **NOMINATED ME.”.**

22 **(B) EACH PRESIDENTIAL ELECTOR NOMINEE AND ALTERNATE**
23 **PRESIDENTIAL ELECTOR NOMINEE OF AN UNAFFILIATED PRESIDENTIAL**
24 **CANDIDATE SHALL EXECUTE THE FOLLOWING PLEDGE: “IF SELECTED FOR THE**
25 **POSITION OF PRESIDENTIAL ELECTOR AS A NOMINEE OF AN UNAFFILIATED**
26 **PRESIDENTIAL CANDIDATE, I AGREE TO SERVE AND TO MARK MY BALLOTS FOR THAT**
27 **CANDIDATE AND FOR THAT CANDIDATE’S VICE PRESIDENTIAL RUNNING MATE.”.**

28 **(C) THE EXECUTED PLEDGES SHALL ACCOMPANY THE SUBMISSION OF THE**
29 **CORRESPONDING PRESIDENTIAL ELECTOR NOMINEE NAMES TO THE STATE BOARD.**

30 **(D) IF, AFTER THE NOMINATION OF A CANDIDATE FOR PRESIDENT OR VICE**
31 **PRESIDENT BY A POLITICAL PARTY AND BEFORE THE MEETING OF PRESIDENTIAL**
32 **ELECTORS UNDER § 8-508 OF THIS SUBTITLE, THE CANDIDATE DIES OR WITHDRAWS**
33 **AS A CANDIDATE FOR THAT OFFICE IN ACCORDANCE WITH THE RULES OF THE**
34 **POLITICAL PARTY, THE PLEDGE EXECUTED UNDER SUBSECTION (A) OF THIS**
35 **SECTION OR § 8-507(D) OF THIS SUBTITLE APPLIES TO THE SUCCESSOR CANDIDATE**
36 **FOR THAT OFFICE NOMINATED BY THE POLITICAL PARTY IN ACCORDANCE WITH THE**

1 PARTY RULES.

2 8-506.

3 IN SUBMITTING THIS STATE'S CERTIFICATE OF ASCERTAINMENT AS
4 REQUIRED BY 3 U.S.C. § 6, THE GOVERNOR SHALL CERTIFY THE STATE'S
5 PRESIDENTIAL ELECTORS AND STATE IN THE CERTIFICATE THAT:

6 (1) THE PRESIDENTIAL ELECTORS WILL SERVE AS PRESIDENTIAL
7 ELECTORS UNLESS A VACANCY OCCURS IN THE OFFICE OF PRESIDENTIAL ELECTOR
8 BEFORE THE END OF THE MEETING AT WHICH PRESIDENTIAL ELECTOR VOTES ARE
9 CAST, IN WHICH CASE A SUBSTITUTE PRESIDENTIAL ELECTOR WILL FILL THE
10 VACANCY; AND

11 (2) IF A SUBSTITUTE PRESIDENTIAL ELECTOR IS APPOINTED TO FILL
12 A VACANCY, THE GOVERNOR WILL SUBMIT AN AMENDED CERTIFICATE OF
13 ASCERTAINMENT STATING THE NAMES ON THE FINAL LIST OF THE PRESIDENTIAL
14 ELECTORS.

15 8-507.

16 (A) THE STATE ADMINISTRATOR SHALL PRESIDE AT THE MEETING OF
17 PRESIDENTIAL ELECTORS DESCRIBED IN § 8-508 OF THIS SUBTITLE.

18 (B) THE POSITION OF A PRESIDENTIAL ELECTOR NOT PRESENT TO VOTE IS
19 VACANT.

20 (C) THE STATE ADMINISTRATOR SHALL APPOINT AN INDIVIDUAL AS A
21 SUBSTITUTE PRESIDENTIAL ELECTOR TO FILL A VACANCY AS FOLLOWS:

22 (1) IF THE ALTERNATE PRESIDENTIAL ELECTOR IS PRESENT TO
23 VOTE, BY APPOINTING THE ALTERNATE PRESIDENTIAL ELECTOR FOR THE VACANT
24 POSITION;

25 (2) IF THE ALTERNATE PRESIDENTIAL ELECTOR FOR THE VACANT
26 POSITION IS NOT PRESENT TO VOTE, BY APPOINTING A PRESIDENTIAL ELECTOR
27 CHOSEN BY LOT FROM AMONG THE ALTERNATE PRESIDENTIAL ELECTORS PRESENT
28 TO VOTE WHO WERE NOMINATED BY THE SAME POLITICAL PARTY OR THE
29 UNAFFILIATED PRESIDENTIAL CANDIDATE;

30 (3) IF THE NUMBER OF ALTERNATE PRESIDENTIAL ELECTORS
31 PRESENT TO VOTE IS INSUFFICIENT TO FILL ANY VACANT POSITION IN ACCORDANCE
32 WITH ITEM (1) OR (2) OF THIS SUBSECTION, BY APPOINTING ANY IMMEDIATELY

1 AVAILABLE INDIVIDUAL WHO IS QUALIFIED TO SERVE AS A PRESIDENTIAL ELECTOR
2 AND CHOSEN THROUGH NOMINATION BY AND PLURALITY VOTE OF THE REMAINING
3 PRESIDENTIAL ELECTORS, INCLUDING NOMINATION AND VOTE BY A SINGLE
4 PRESIDENTIAL ELECTOR IF ONLY ONE REMAINS;

5 (4) IF THERE IS A TIE BETWEEN AT LEAST TWO NOMINEES FOR
6 SUBSTITUTE PRESIDENTIAL ELECTOR IN A VOTE CONDUCTED UNDER ITEM (3) OF
7 THIS SUBSECTION, BY APPOINTING A PRESIDENTIAL ELECTOR CHOSEN BY LOT
8 FROM AMONG THOSE NOMINEES; OR

9 (5) IF ALL PRESIDENTIAL ELECTOR POSITIONS ARE VACANT AND
10 CANNOT BE FILLED IN ACCORDANCE WITH ITEM (1), (2), (3), OR (4) OF THIS
11 SUBSECTION, BY APPOINTING A SINGLE PRESIDENTIAL ELECTOR, WITH REMAINING
12 VACANT POSITIONS TO BE FILLED IN ACCORDANCE WITH ITEM (3) OR (4) OF THIS
13 SUBSECTION.

14 (D) TO QUALIFY AS A SUBSTITUTE PRESIDENTIAL ELECTOR UNDER
15 SUBSECTION (C) OF THIS SECTION, AN INDIVIDUAL WHO HAS NOT EXECUTED THE
16 PLEDGE REQUIRED UNDER § 8-504 OF THIS SUBTITLE SHALL EXECUTE THE
17 FOLLOWING PLEDGE: "I AGREE TO SERVE AND TO MARK MY BALLOTS FOR
18 PRESIDENT AND VICE PRESIDENT CONSISTENT WITH THE PLEDGE OF THE
19 INDIVIDUAL TO WHOSE PRESIDENTIAL ELECTOR POSITION I HAVE SUCCEEDED."

21 (A) AFTER THE VOTE OF THE STATE'S PRESIDENTIAL ELECTORS IS
22 COMPLETED, IF THE FINAL LIST OF PRESIDENTIAL ELECTORS DIFFERS FROM ANY
23 LIST THAT THE GOVERNOR PREVIOUSLY INCLUDED ON A CERTIFICATE OF
24 ASCERTAINMENT PREPARED AND TRANSMITTED UNDER 3 U.S.C. § 6, THE STATE
25 ADMINISTRATOR IMMEDIATELY SHALL PREPARE AN AMENDED CERTIFICATE OF
26 ASCERTAINMENT IN ACCORDANCE WITH 3 U.S.C. § 4 AND TRANSMIT IT TO THE
27 GOVERNOR FOR THE GOVERNOR'S SIGNATURE.

28 (B) THE GOVERNOR IMMEDIATELY SHALL DELIVER THE SIGNED AMENDED
29 CERTIFICATE OF ASCERTAINMENT TO THE STATE ADMINISTRATOR AND A SIGNED
30 DUPLICATE ORIGINAL OF THE AMENDED CERTIFICATE OF ASCERTAINMENT TO ALL
31 INDIVIDUALS ENTITLED TO RECEIVE THIS STATE'S CERTIFICATE OF
32 ASCERTAINMENT, INDICATING THAT THE AMENDED CERTIFICATE OF
33 ASCERTAINMENT IS TO BE SUBSTITUTED FOR THE CERTIFICATE OF
34 ASCERTAINMENT PREVIOUSLY SUBMITTED.

35 (C) (1) THE STATE ADMINISTRATOR SHALL PREPARE A CERTIFICATE OF
36 THE VOTE.

1 electors who are present shall fill any vacancy in the office of **PRESIDENTIAL** elector **IN**
2 **ACCORDANCE WITH § 8-507 OF THIS SUBTITLE**, whether the vacancy is caused by
3 absence or other reason.

4 (2) An individual appointed to fill a vacancy is entitled to all rights and
5 privileges of the duly elected electors.

6 (c) (1) After taking the oath prescribed by Article I, § 9 of the Maryland
7 Constitution before the Clerk of the Supreme Court of Maryland or, in the Clerk's absence,
8 before one of the Clerk's deputies, the presidential electors shall cast their votes for the
9 candidates for President and Vice President who received a plurality of the votes cast in
10 the State of Maryland.

11 (2) **THE STATE ADMINISTRATOR SHALL PROVIDE EACH**
12 **PRESIDENTIAL ELECTOR WITH A PRESIDENTIAL AND VICE PRESIDENTIAL BALLOT.**

13 (3) **EACH PRESIDENTIAL ELECTOR SHALL MARK THE PRESIDENTIAL**
14 **ELECTOR'S PRESIDENTIAL AND VICE PRESIDENTIAL BALLOTS WITH THE**
15 **PRESIDENTIAL ELECTOR'S SIGNATURE AND THE PRESIDENTIAL ELECTOR'S**
16 **LEGIBLY PRINTED NAME.**

17 (D) (1) **EACH PRESIDENTIAL ELECTOR SHALL PRESENT BOTH**
18 **COMPLETED BALLOTS TO THE STATE ADMINISTRATOR.**

19 (2) **THE STATE ADMINISTRATOR SHALL EXAMINE THE BALLOTS**
20 **PRESENTED UNDER PARAGRAPH (1) OF THIS SUBSECTION AND ACCEPT AS CAST ALL**
21 **BALLOTS OF PRESIDENTIAL ELECTORS WHOSE VOTES ARE CONSISTENT WITH THEIR**
22 **PLEDGES EXECUTED UNDER § 8-504 OR § 8-507(D) OF THIS SUBTITLE.**

23 (3) **THE STATE ADMINISTRATOR MAY NOT COUNT EITHER A**
24 **PRESIDENTIAL ELECTOR'S PRESIDENTIAL OR VICE PRESIDENTIAL BALLOT IF THE**
25 **PRESIDENTIAL ELECTOR HAS NOT MARKED BOTH BALLOTS OR HAS MARKED A**
26 **BALLOT IN VIOLATION OF THE PRESIDENTIAL ELECTOR'S PLEDGE.**

27 (E) **A PRESIDENTIAL ELECTOR WHO REFUSES TO PRESENT A BALLOT,**
28 **PRESENTS AN UNMARKED BALLOT, OR PRESENTS A BALLOT MARKED IN VIOLATION**
29 **OF THE PRESIDENTIAL ELECTOR'S PLEDGE EXECUTED UNDER § 8-504 OR § 8-507(D)**
30 **OF THIS SUBTITLE VACATES THE OFFICE OF ELECTOR, CREATING A VACANT**
31 **POSITION TO BE FILLED UNDER § 8-507 OF THIS SUBTITLE.**

32 (F) **THE STATE ADMINISTRATOR SHALL DISTRIBUTE BALLOTS AND**
33 **COLLECT BALLOTS FROM A SUBSTITUTE PRESIDENTIAL ELECTOR AND REPEAT THE**
34 **PROCESS UNDER THIS SECTION, DECLARING AND FILLING VACANT POSITIONS AS**
35 **REQUIRED, AND RECORDING APPROPRIATELY COMPLETED BALLOTS FROM THE**

1 **SUBSTITUTED PRESIDENTIAL ELECTORS, UNTIL ALL OF THE STATE'S ELECTORAL**
2 **VOTES HAVE BEEN CAST AND RECORDED.**

3 SECTION 3. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
4 as follows:

5 **Article – Election Law**

6 **[8-504.] 8-505.**

7 (a) (1) At the general election for President and Vice President of the United
8 States there shall be elected, in accordance with subsection (b) of this section, the number
9 of presidential electors to which this State is entitled.

10 (2) Presidential electors shall be elected under the procedure provided in §
11 8-5A-01 of this title.

12 (b) (1) The names of the candidates for the office of presidential elector may
13 not be printed on the ballot.

14 (2) A vote for the candidates for President and Vice President of a political
15 party shall be considered to be and counted as a vote for each of the **NOMINEES FOR**
16 presidential [electors] **ELECTOR** of the political party [nominated] **SUBMITTED** in
17 accordance with § 8-503 of this subtitle.

18 **(3) A VOTE FOR AN UNAFFILIATED CANDIDATE FOR PRESIDENT AND**
19 **VICE PRESIDENT SHALL BE CONSIDERED TO BE AND COUNTED AS A VOTE FOR EACH**
20 **OF THE NOMINEES FOR PRESIDENTIAL ELECTOR SUBMITTED BY THE UNAFFILIATED**
21 **PRESIDENTIAL CANDIDATE TO THE STATE BOARD IN ACCORDANCE WITH § 8-503 OF**
22 **THIS SUBTITLE.**

23 **[8-505.] 8-508.**

24 (a) (1) The individuals elected to the office of presidential elector shall meet in
25 the State House in the City of Annapolis on the day provided by the Constitution and laws
26 of the United States.

27 (2) The conduct of the meeting shall be consistent with the requirements
28 of federal law.

29 (b) (1) Before proceeding to perform the duties of their office, the presidential
30 electors who are present shall fill any vacancy in the office of **PRESIDENTIAL** elector **IN**
31 **ACCORDANCE WITH § 8-507 OF THIS SUBTITLE**, whether the vacancy is caused by
32 absence or other reason.

33 (2) An individual appointed to fill a vacancy is entitled to all rights and

1 privileges of the duly elected electors.

2 (c) (1) After taking the oath prescribed by Article I, § 9 of the Maryland
3 Constitution before the Clerk of the Supreme Court of Maryland or, in the Clerk's absence,
4 before one of the Clerk's deputies, the presidential electors shall cast their votes for the
5 candidates for President and Vice President who received a plurality of the votes cast in
6 the national popular vote total defined in § 8-5A-01 of this title.

7 (2) THE STATE ADMINISTRATOR SHALL PROVIDE EACH
8 PRESIDENTIAL ELECTOR WITH A PRESIDENTIAL AND VICE PRESIDENTIAL BALLOT.

9 (3) EACH PRESIDENTIAL ELECTOR SHALL MARK THE PRESIDENTIAL
10 ELECTOR'S PRESIDENTIAL AND VICE PRESIDENTIAL BALLOTS WITH THE
11 PRESIDENTIAL ELECTOR'S SIGNATURE AND THE PRESIDENTIAL ELECTOR'S
12 LEGIBLY PRINTED NAME.

13 (D) (1) EACH PRESIDENTIAL ELECTOR SHALL PRESENT BOTH
14 COMPLETED BALLOTS TO THE STATE ADMINISTRATOR, WHO SHALL EXAMINE THE
15 BALLOTS AND ACCEPT AS CAST ALL BALLOTS OF PRESIDENTIAL ELECTORS WHOSE
16 VOTES ARE CONSISTENT WITH THEIR PLEDGES EXECUTED FOR THE CANDIDATES
17 FOR PRESIDENT AND VICE PRESIDENT WHO ARE THE NATIONAL POPULAR VOTE
18 WINNERS AS DEFINED IN § 8-5A-01 OF THIS TITLE.

19 (2) THE STATE ADMINISTRATOR MAY NOT COUNT EITHER A
20 PRESIDENTIAL ELECTOR'S PRESIDENTIAL OR VICE PRESIDENTIAL BALLOT IF THE
21 PRESIDENTIAL ELECTOR HAS NOT MARKED BOTH BALLOTS OR HAS MARKED A
22 BALLOT IN VIOLATION OF THE PRESIDENTIAL ELECTOR'S PLEDGE.

23 (E) A PRESIDENTIAL ELECTOR WHO REFUSES TO PRESENT A BALLOT,
24 PRESENTS AN UNMARKED BALLOT, OR PRESENTS A BALLOT MARKED IN VIOLATION
25 OF THE PRESIDENTIAL ELECTOR'S PLEDGE EXECUTED UNDER § 8-504 OR § 8-507(D)
26 OF THIS SUBTITLE VACATES THE OFFICE OF ELECTOR, CREATING A VACANT
27 POSITION TO BE FILLED UNDER § 8-507 OF THIS SUBTITLE.

28 (F) THE STATE ADMINISTRATOR SHALL DISTRIBUTE BALLOTS AND
29 COLLECT BALLOTS FROM A SUBSTITUTE PRESIDENTIAL ELECTOR AND REPEAT THE
30 PROCESS UNDER THIS SECTION, DECLARING AND FILLING VACANT POSITIONS AS
31 REQUIRED, AND RECORDING APPROPRIATELY COMPLETED BALLOTS FROM THE
32 SUBSTITUTE PRESIDENTIAL ELECTORS, UNTIL ALL OF THIS STATE'S ELECTORAL
33 VOTES HAVE BEEN CAST AND RECORDED.

34 SECTION 4. AND BE IT FURTHER ENACTED, That Section 2 of this Act shall take
35 effect October 1, 2026. It shall remain effective until the taking effect of Section 1 of
36 Chapters 43 and 44 of the Acts of the General Assembly of 2007. If the contingency stated

1 in Section 3 of Chapters 43 and 44 of the Acts of the General Assembly of 2007 takes effect,
2 Section 2 of this Act shall be abrogated and of no further force and effect.

3 SECTION 5. AND BE IT FURTHER ENACTED, That Section 3 of this Act shall take
4 effect on the taking effect of Section 1 of Chapters 43 and 44 of the Acts of the General
5 Assembly of 2007.

6 SECTION 6. AND BE IT FURTHER ENACTED, That, subject to the provisions of
7 Sections 4 and 5 of this Act, this Act shall take effect October 1, 2026.
