A BILL ENTITLED

1 AN ACT concerning

2 **Office of Health Care Quality Stakeholder Advisory Council – Establishment**

3 FOR the purpose of establishing the Office of Health Care Quality Stakeholder Advisory
4 Council to provide feedback to the Office of Health Care Quality regarding
5 maintaining oversight of health care facilities and to notify the Secretary of Health
6 if the Office is negligent in providing oversight; and generally relating to the Office
7 of Health Care Quality Stakeholder Advisory Council.

10 Section 19–2701 and 19–2702 to be under the new subtitle “Subtitle 27. Office of
11 Health Care Quality Stakeholder Advisory Council”

14 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

15 That the Laws of Maryland read as follows:

16 **Article – Health – General**

17 **SUBTITLE 27. OFFICE OF HEALTH CARE QUALITY STAKEHOLDER ADVISORY
18 COUNCIL.**

20 (A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS

22 (B) “ADVISORY COUNCIL” MEANS THE OFFICE OF HEALTH CARE QUALITY
23 STAKEHOLDER ADVISORY COUNCIL.

4 **(A) THERE IS AN OFFICE OF HEALTH CARE QUALITY STAKEHOLDER**
5 **ADVISORY COUNCIL.**

6 **(B) THE ADVISORY COUNCIL SHALL:**

7 **(1) PROVIDE FEEDBACK TO THE OFFICE FROM STAKEHOLDERS**
8 **REGARDING MAINTAINING OVERSIGHT OF HEALTH CARE FACILITIES; AND**

9 **(2) NOTIFY THE SECRETARY IF THE OFFICE IS REPORTED**
10 **NEGLIGENT BY THE ADVISORY COUNCIL IN PROVIDING OVERSIGHT OF HEALTH**
11 **CARE FACILITIES.**

12 **(C) THE ADVISORY COUNCIL CONSISTS OF THE FOLLOWING MEMBERS:**

13 **(1) ONE MEMBER OF THE SENATE OF MARYLAND, APPOINTED BY THE**
14 **PRESIDENT OF THE SENATE;**

15 **(2) ONE MEMBER OF THE HOUSE OF DELEGATES, APPOINTED BY THE**
16 **SPEAKER OF THE HOUSE;**

17 **(3) THE SECRETARY, OR THE SECRETARY'S DESIGNEE;**

18 **(4) THE SECRETARY OF AGING, OR THE SECRETARY'S DESIGNEE;**

19 **(5) A REPRESENTATIVE FROM THE MARYLAND ATTORNEY**
20 **GENERAL'S HEALTH EDUCATION AND ADVOCACY UNIT, DESIGNATED BY THE**
21 **ATTORNEY GENERAL;**

22 **(6) THE FOLLOWING MEMBERS, APPOINTED BY THE SECRETARY:**

23 **(I) TWO FRONTLINE HOSPITAL WORKERS;**

24 **(II) TWO NURSING HOME WORKERS;**

25 **(III) TWO NURSING HOME RESIDENTS OR INDIVIDUALS WITH A**
26 **FAMILY MEMBER RESIDING IN A NURSING HOME;**

1 (IV) ONE REPRESENTATIVE FROM THE LONG-TERM CARE
2 INDUSTRY;

(v) ONE MEMBER OF AN ADVOCACY GROUP FOR THE
INTELLECTUALLY AND DEVELOPMENTALLY DISABLED; AND

5 (VI) ONE MEMBER OF AN ADVOCACY GROUP FOR BEHAVIORAL
6 HEALTH;

7 (7) ONE REPRESENTATIVE OF THE MARYLAND HOSPITAL
8 ASSOCIATION, DESIGNATED BY THE PRESIDENT OF THE ASSOCIATION; AND

11 (I) ONE REPRESENTATIVE OF MEDCHI, THE MARYLAND
12 STATE MEDICAL SOCIETY;

13 (II) ONE REPRESENTATIVE OF 1199 SEIU UNITED
14 HEALTHCARE WORKERS EAST;

15 (III) ONE REPRESENTATIVE OF THE MARYLAND CHAPTER OF
16 AARP;

17 (IV) ONE REPRESENTATIVE OF THE MARYLAND STATE
18 CONFERENCE NAACP;

19 (v) ONE REPRESENTATIVE OF MARYLAND CASA;

20 (VI) ONE REPRESENTATIVE OF DISABILITY RIGHTS MARYLAND;
21 AND

22 (VII) ONE MEMBER OF THE MARYLAND CONTINUING CARE
23 RESIDENTS' ASSOCIATION.

24 (D) (1) (I) THE TERM OF A MEMBER OF THE ADVISORY COUNCIL IS 2
25 YEARS.

26 (II) AT THE END OF A TERM, A MEMBER SHALL CONTINUE TO
27 SERVE UNTIL A SUCCESSOR IS APPOINTED.

(II) THE TERM OF THE CHAIR IS 2 YEARS.

2 (E) THE DEPARTMENT SHALL PROVIDE STAFF FOR THE ADVISORY
3 COUNCIL.

4 (F) A MEMBER OF THE ADVISORY COUNCIL MAY NOT RECEIVE
5 COMPENSATION AS A MEMBER OF THE ADVISORY COUNCIL.

6 (G) (1) BEGINNING JANUARY 1, 2027, THE ADVISORY COUNCIL SHALL
7 HOLD A VIRTUAL PUBLIC MEETING ONCE EVERY 6 MONTHS.

1. BE STREAMED LIVE THROUGH THE DEPARTMENT'S

10 WEBSITE; AND

2. INCLUDE A DESIGNATED OPPORTUNITY FOR PUBLIC

17 (H) (1) AT EACH PUBLIC MEETING OF THE ADVISORY COUNCIL, THE
18 OFFICE SHALL REPORT DATA FROM THE IMMEDIATELY PRECEDING 6-MONTH
19 PERIOD REGARDING:

(I) THE NUMBER OF:

1. HOSPITALS ACTIVELY MONITORED:

3. COMPLAINTS RECEIVED FROM HOSPITAL PATIENTS RESIDENTS: AND

26 (II) THE AVERAGE LENGTH OF TIME FOR THE OFFICE TO
27 RESPOND TO EACH COMPLAINT; AND

(III) THE NUMBER OF COMPLAINTS RESOLVED BY THE OFFICE.

(2) THE ADVISORY COMMITTEE SHALL:

(I) 1. REVIEW THE DATA REPORTS PROVIDED BY THE
PARAGRAPH (1) OF THIS SUBSECTION; AND

10 (I) ON OR BEFORE DECEMBER 1 EACH YEAR, BEGINNING IN 2027, THE
11 ADVISORY COUNCIL SHALL REPORT ITS FINDINGS AND RECOMMENDATIONS TO THE
12 GOVERNOR AND, IN ACCORDANCE WITH § 2-1257 OF THE STATE GOVERNMENT
13 ARTICLE, THE GENERAL ASSEMBLY.

14 SECTION 2. AND BE IT FURTHER ENACTED, That the terms of the initial
15 non-ex officio members of the Office of Health Care Quality Stakeholder Advisory Council
16 shall expire as follows:

17 (1) ten members in 2027; and

18 (2) ten members in 2028.

19 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect
20 October 1, 2026.
