A BILL ENTITLED

1 AN ACT concerning

2 **Education – Board of Community College Trustees for Baltimore County –**
3 **Membership**

4 FOR the purpose of altering the membership of the Board of Community College Trustees
5 for Baltimore County; and generally relating to the Board of Community College
6 Trustees for Baltimore County.

7 BY repealing and reenacting, with amendments,
8 Article – Education
9 Section 16–402
10 Annotated Code of Maryland
11 (2022 Replacement Volume and 2025 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 16–402.

16 (a) The Board of Community College Trustees for Baltimore County consists of
17 [15] 11 members appointed by the Governor, with the advice and consent of the Senate.

18 (b) Of the members:

19 (1) [1 serves] 2 SERVE at large; and

20 (2) [14] 9 serve from the [7] 9 councilmanic districts in Baltimore County,
21 [2] 1 from each district.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

1 (c) (1) The term of a member is 5 years and begins on July 1.

2 (2) A member may not serve for more than 2 consecutive terms.

3 (d) (1) The Governor shall appoint a chairperson from among the members of
4 the Board as of July 1, 1997.

5 (2) The chairperson appointed by the Governor shall serve until June 30,
6 2000.

7 (3) For the year beginning July 1, 2000, and each year thereafter, the
8 Board shall elect a chairperson from among the members of the Board.

9 SECTION 2. AND BE IT FURTHER ENACTED, That:

10 (a) The terms of the following members of the Board of Community College
11 Trustees for Baltimore County shall terminate on June 30, 2026:

12 (1) the members representing Baltimore County councilmanic districts 2,
13 6, and 7, as they existed before June 23, 2026, whose terms are scheduled to expire on June
14 30, 2026;

15 (2) the members representing Baltimore County councilmanic district 1, as
16 it existed before June 23, 2026, whose seats are vacant;

17 (3) the member representing Baltimore County councilmanic district 3, as
18 it existed before June 23, 2026, whose term expired on June 30, 2024, and whose seat is
19 vacant; and

20 (4) the member representing Baltimore County councilmanic district 4, as
21 it existed before June 23, 2026, whose term expired on June 30, 2025.

22 (b) Beginning July 1, 2026, the following members of the Board of Community
23 College Trustees for Baltimore County shall represent the following Baltimore County
24 councilmanic districts:

25 (1) the member representing councilmanic district 4, as it existed before
26 June 23, 2026, whose term is set to expire on June 30, 2030, shall represent councilmanic
27 district 2, as it exists on or after June 23, 2026;

28 (2) the member representing councilmanic district 3, as it existed before
29 June 23, 2026, whose term is set to expire on June 30, 2029, shall represent councilmanic
30 district 3, as it exists on or after June 23, 2026;

31 (3) the member representing councilmanic district 2, as it existed before
32 June 23, 2026, whose term is set to expire on June 30, 2028, shall represent councilmanic
33 district 4, as it exists on or after June 23, 2026;

(4) the member representing councilmanic district 6, as it existed before June 23, 2026, whose term is set to expire on June 30, 2027, shall represent councilmanic district 6, as it exists on or after June 23, 2026;

(5) the member representing councilmanic district 5, as it existed before June 23, 2026, whose term is set to expire on June 30, 2030, shall represent councilmanic district 7, as it exists on or after June 23, 2026;

(6) the member representing councilmanic district 7, as it existed before June 23, 2026, whose term is set to expire on June 30, 2027, shall represent councilmanic district 8, as it exists on or after June 23, 2026;

10 (7) the at-large member of the Board, whose term is set to expire June 30,
11 2029, shall become one of the at-large members of the Board; and

15 (c) Beginning July 1, 2026, the initial members representing Baltimore County
16 councilmanic districts 1, 5, and 9 on the Board of Community College Trustees for
17 Baltimore County, as the districts exist on or after June 23, 2026, shall be appointed using
18 the method provided under § 16-402 of the Education Article, as enacted by Section 1 of
19 this Act, and shall expire as follows:

20 (1) the term of the member appointed to represent councilmanic district 1
21 shall expire June 30, 2028;

22 (2) the term of the member appointed to represent councilmanic district 5
23 shall expire June 30, 2029; and

24 (3) the term of the member appointed to represent councilmanic district 9
25 shall expire June 30, 2030.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect June
27 1, 2026.
