## A BILL ENTITLED

1 AN ACT concerning

2 **General Provisions – Commemorative Months – Muslim American Heritage and**  
3 **Jewish American Heritage Months**

4 FOR the purpose of requiring the Governor annually to proclaim certain months as Muslim  
5 American Heritage and Jewish American Heritage months; requiring the  
6 proclamations to urge certain organizations to observe the months with certain  
7 programs and activities; and generally relating to Muslim American Heritage and  
8 Jewish American Heritage months.

## Preamble

21 WHEREAS, There are over 350,000 Muslim Marylanders who currently reside in

1        WHEREAS, There are over 250,000 Jewish Marylanders who currently reside in the  
2 State and, for generations, have contributed to enriching the artistic, business, academic,  
3 and public service communities thereby significantly increasing the vibrancy of Maryland;  
4 now, therefore,

5 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
6 That Section(s) 7-501 through 7-503 and 7-504 through 7-507 of Article – General  
7 Provisions of the Annotated Code of Maryland be renumbered to be Section(s) 7-502  
8 through 7-504 and 7-506 through 7-509, respectively.

9 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read  
10 as follows:

## Article – General Provisions

12 7-501.

13 (A) THE GOVERNOR ANNUALLY SHALL PROCLAIM THE MONTH OF JANUARY  
14 AS MUSLIM AMERICAN HERITAGE MONTH IN RECOGNITION OF THE  
15 CONTRIBUTIONS THAT MUSLIM AMERICANS HAVE MADE TO THE STATE.

16 (B) THE PROCLAMATION SHALL URGE EDUCATIONAL AND CULTURAL  
17 ORGANIZATIONS TO OBSERVE MUSLIM AMERICAN HERITAGE MONTH PROPERLY  
18 WITH APPROPRIATE PROGRAMS, CEREMONIES, AND ACTIVITIES.

19 7-505.

20 (A) THE GOVERNOR ANNUALLY SHALL PROCLAIM THE MONTH OF MAY AS  
21 JEWISH AMERICAN HERITAGE MONTH IN RECOGNITION OF THE CONTRIBUTIONS  
22 THAT JEWISH AMERICANS HAVE MADE TO THE STATE.

23 (B) THE PROCLAMATION SHALL URGE EDUCATIONAL AND CULTURAL  
24 ORGANIZATIONS TO OBSERVE JEWISH AMERICAN HERITAGE MONTH PROPERLY  
25 WITH APPROPRIATE PROGRAMS, CEREMONIES, AND ACTIVITIES.

26 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
27 October 1, 2026.
