## A BILL ENTITLED

1 AN ACT concerning

2 **Public Safety – Police Accountability – Investigation Records Relating to Not**  
3 **Administratively Charged, Unfounded, and Exonerated Complaints**

4 FOR the purpose of requiring that certain investigation records relating to a complaint of  
5 misconduct by a police officer be removed from the police officer’s personnel record a  
6 certain amount of time after an administrative charging committee issues a  
7 determination not to administratively charge the police officer in connection with the  
8 complaint or a trial board issues a finding of unfounded or exonerated in connection  
9 with the complaint; and generally relating to police accountability.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
21 That the Laws of Maryland read as follows:

22 **Article – Public Safety**

23 3–101.

24 (a) In this title the following words have the meanings indicated.

1 (b) “Administratively charged” means that a police officer has been formally  
2 accused of misconduct in an administrative proceeding.

3 (d) “Exonerated” means that a police officer acted in accordance with the law and  
4 agency policy.

5 (f) “Not administratively charged” means that a determination has been made  
6 not to administratively charge a police officer in connection with alleged misconduct.

7 (k) “Unfounded” means that the allegations against a police officer are not  
8 supported by fact.

10 (A) [A] IN THIS SECTION, “INVESTIGATION RECORD” MEANS A record relating  
11 to an administrative or criminal investigation of misconduct by a police officer, including  
12 an internal affairs investigatory record, a hearing record, and records relating to a  
13 disciplinary decision[.].

14 (B) EXCEPT AS PROVIDED IN SUBSECTION (C) OF THIS SECTION, AN  
15 INVESTIGATION RECORD may not be:

16 (1) expunged; or

17 (2) destroyed by a law enforcement agency.

18 (C) ALL INVESTIGATION RECORDS RELATING TO A COMPLAINT OF  
19 MISCONDUCT BY A POLICE OFFICER SHALL BE REMOVED FROM THE POLICE  
20 OFFICER’S PERSONNEL RECORD 3 YEARS AFTER:

21 (1) AN ADMINISTRATIVE CHARGING COMMITTEE ISSUES A  
22 DETERMINATION NOT TO ADMINISTRATIVELY CHARGE THE POLICE OFFICER IN  
23 CONNECTION WITH THE COMPLAINT UNDER § 3–104 OF THIS SUBTITLE; OR

24 (2) A TRIAL BOARD ISSUES A FINDING OF UNFOUNDED OR  
25 EXONERATED IN CONNECTION WITH THE COMPLAINT UNDER § 3–106 OF THIS  
26 SUBTITLE.

27 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
28 October 1, 2026.
