1 AN ACT concerning

2 **Property Tax – Agricultural Use Assessment – Community Solar Energy**
3 **Generating Systems**

4 FOR the purpose of altering the date by which certain community solar energy generating
5 systems must be approved by the Public Service Commission in order for land that
6 is used by the community solar energy generating systems to qualify for the
7 agricultural use assessment; requiring the State Department of Assessments and
8 Taxation to issue a certain preconstruction determination under certain
9 circumstances; authorizing the Department to rescind a preconstruction
10 determination under certain circumstances; authorizing the Department to charge a
11 certain application fee; and generally relating to the agricultural use assessment.

17 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
18 That the Laws of Maryland read as follows:

19 **Article – Tax – Property**

20 8–209.

1 (e) (1) (i) In this subsection the following words have the meanings
2 indicated.

3 (ii) “Agrivoltaics” has the meaning stated in § 7–237 of this article.

4 (iii) “Community solar energy generating system” has the meaning
5 stated in § 7–306.2 of the Public Utilities Article.

6 (2) Except as provided in paragraph (4) of this subsection, the Department
7 shall establish in regulations criteria to determine if land that appears to be actively used
8 for farm or agricultural purposes:

9 (i) is actually used for farm or agricultural purposes; and

10 (ii) qualifies for assessment under this section.

11 (3) The criteria shall include:

12 (i) the zoning of the land;

13 (ii) the present and past use of the land including land under the Soil
14 Bank Program of the United States;

15 (iii) the productivity of the land, including timberlands and
16 reforested lands; and

17 (iv) the gross income that is derived from the agricultural activity.

18 (4) (i) This paragraph applies through the life cycle of a community
19 solar energy generating system that:

20 1. is placed in service after June 30, 2022; and

21 2. has been approved on or before December 31, ~~[2025]~~ **2030**,
22 as a community solar energy generating system by the Public Service Commission under §
23 7–306.2 of the Public Utilities Article.

24 (ii) **1.** The Department shall assess and qualify land that is used
25 by a community solar energy generating system for agrivoltaics as land that is actively
26 used for farm or agricultural purposes.

27 **2. A. ON APPLICATION, THE DEPARTMENT SHALL**
28 **ISSUE A PRECONSTRUCTION DETERMINATION IN ACCORDANCE WITH PARAGRAPH**
29 **(5) OF THIS SUBSECTION.**

1 **B. A FAVORABLE PRECONSTRUCTION DETERMINATION**
2 **QUALIFIES THE LAND AS ACTIVELY USED FOR FARM OR AGRICULTURAL PURPOSES**
3 **UNDER SUBSUBPARAGRAPH 1 OF THIS SUBPARAGRAPH.**

4 **(5) (I) ON APPLICATION, THE DEPARTMENT SHALL ISSUE A**
5 **PRECONSTRUCTION DETERMINATION INDICATING WHETHER THE LAND SUBJECT TO**
6 **THE REQUEST WILL BE ASSESSED AS FARM OR AGRICULTURAL USE LAND UNDER**
7 **THIS SECTION.**

8 **(II) AN APPLICATION FOR A PRECONSTRUCTION**
9 **DETERMINATION UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH SHALL INCLUDE:**

10 **1. IDENTIFICATION OF THE PARCEL OR PARCELS;**

11 **2. THE ANTICIPATED EFFECTIVE TAX YEAR FOR WHEN**
12 **CONSTRUCTION WILL BE COMPLETE AND THE ANTICIPATED AGRICULTURAL**
13 **ACTIVITY;**

14 **3. A SITE PLAN SHOWING THE PROPOSED SOLAR LAYOUT**
15 **AND THE ACREAGE TO REMAIN IN AGRICULTURAL ACTIVITY;**

16 **4. AN AGRIVOLTAICS PLAN THAT INCLUDES:**

17 **A. THE ANTICIPATED AGRICULTURAL ACTIVITY TO BE**
18 **CONDUCTED DURING OPERATION OF THE COMMUNITY SOLAR ENERGY GENERATING**
19 **SYSTEM;**

20 **B. ACCESS AND FEATURES NECESSARY TO CONDUCT THE**
21 **ANTICIPATED AGRICULTURAL ACTIVITY; AND**

22 **C. HOW THE DESIGN OF THE COMMUNITY SOLAR ENERGY**
23 **GENERATING SYSTEM WILL ALLOW FOR THE ANTICIPATED AGRICULTURAL**
24 **ACTIVITY;**

25 **5. AN ESTIMATED CONSTRUCTION SCHEDULE AND THE**
26 **PROPOSED IN-SERVICE DATE;**

27 **6. EVIDENCE OF SITE CONTROL, INCLUDING:**

28 **A. AN EXECUTED LAND LEASE OR PURCHASE**
29 **AGREEMENT BETWEEN THE LAND OWNER AND SOLAR OPERATOR;**

30 **B. AN EXECUTED OPTION TO LEASE OR PURCHASE**
31 **BETWEEN THE LAND OWNER AND SOLAR OPERATOR; OR**

1 **C. A DEED INDICATING THE SOLAR OPERATOR OWNS THE**
 2 **LAND; AND**

3 **7. ANY OTHER INFORMATION REQUIRED BY THE**
 4 **DEPARTMENT THAT IS REASONABLY NECESSARY TO DETERMINE WHETHER THE**
 5 **LAND QUALIFIES FOR A FARM OR AGRICULTURAL USE ASSESSMENT UNDER**
 6 **PARAGRAPH (4) OF THIS SUBSECTION.**

7 **(III) 1. WITHIN 90 DAYS AFTER RECEIVING A COMPLETED**
 8 **APPLICATION FOR A PRECONSTRUCTION DETERMINATION, THE DEPARTMENT**
 9 **SHALL REVIEW THE APPLICATION AND:**

10 **A. ISSUE A FAVORABLE PRECONSTRUCTION**
 11 **DETERMINATION;**

12 **B. ISSUE AN UNFAVORABLE PRECONSTRUCTION**
 13 **DETERMINATION; OR**

14 **C. NOTIFY THE APPLICANT THAT ADDITIONAL**
 15 **INFORMATION IS REQUIRED TO COMPLETE REVIEW.**

16 **2. THE DEPARTMENT MAY RESCIND A**
 17 **PRECONSTRUCTION DETERMINATION IF:**

18 **A. THE COMMUNITY SOLAR ENERGY GENERATING**
 19 **SYSTEM, AS CONSTRUCTED OR OPERATED, MATERIALLY DIFFERS FROM THE**
 20 **DESCRIPTION PROVIDED IN THE APPLICATION;**

21 **B. THE SOLAR OPERATOR HAS FAILED TO NOTIFY THE**
 22 **DEPARTMENT OF THE COMPLETED CONSTRUCTION AND SUBMIT AN AGRICULTURAL**
 23 **USE APPLICATION;**

24 **C. AGRICULTURAL ACTIVITY IS NOT BEING MAINTAINED**
 25 **IN ACCORDANCE WITH THIS SECTION; OR**

26 **D. THE APPLICANT PROVIDED INACCURATE**
 27 **INFORMATION IN THE APPLICATION.**

28 **(IV) A FAVORABLE PRECONSTRUCTION DETERMINATION**
 29 **ISSUED BY THE DEPARTMENT QUALIFIES THE LAND FOR A FARM OR AGRICULTURAL**
 30 **USE ASSESSMENT UNDER PARAGRAPH (4) OF THIS SUBSECTION FOR THE**
 31 **IMMEDIATELY SUCCEEDING TAXABLE YEAR IF:**

1 **1. THE SOLAR OPERATOR PROVIDES WRITTEN NOTICE**
2 **TO THE DEPARTMENT THAT THE PROJECT’S CONSTRUCTION IS COMPLETED AND**
3 **AGRICULTURAL USE ACTIVITY IS BEING CONDUCTED;**

4 **2. AN APPLICATION FOR A FARM OR AGRICULTURAL USE**
5 **ASSESSMENT IS SUBMITTED TO THE DEPARTMENT THAT INCLUDES THE REQUIRED**
6 **INFORMATION; AND**

7 **3. THE SOLAR OPERATOR PROVIDES ACCESS TO THE**
8 **SOLAR FACILITY FOR THE DEPARTMENT TO VERIFY THE AGRICULTURAL USE**
9 **ACTIVITY IS BEING CONDUCTED IN ACCORDANCE WITH THIS SECTION.**

10 **(V) THE DEPARTMENT MAY CHARGE AN APPLICATION FEE IN**
11 **AN AMOUNT NECESSARY TO RECOVER THE DEPARTMENT’S COSTS TO ADMINISTER**
12 **AND IMPLEMENT THE REQUIREMENTS OF THIS PARAGRAPH.**

13 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect June
14 1, 2026, and shall be applicable to all taxable years beginning after June 30, 2026.
