18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
19 That Section(s) 18–1503 through 18–1506 of Article – Education of the Annotated Code of
20 Maryland be renumbered to be Section(s) 18–1506 through 18–1509, respectively.

21 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
22 as follows:

23 **Article – Education**

(a) There is a program of loan assistance repayment known as the Janet L. Hoffman Loan Assistance Repayment Program in the State.

(B) THE FOLLOWING INDIVIDUALS ARE ELIGIBLE FOR FINANCIAL ASSISTANCE UNDER THE PROGRAM:

(1) AN INDIVIDUAL WHO RECEIVES A GRADUATE, PROFESSIONAL, OR UNDERGRADUATE DEGREE FROM:

(I) A COLLEGE OR UNIVERSITY IN THE STATE OF MARYLAND;

(II) A SCHOOL OF LAW IN THE STATE OF MARYLAND; OR

(III) FOR A VETERINARY PRACTITIONER OR VETERINARY TECHNICIAN, AN ACCREDITED VETERINARY COLLEGE OR UNIVERSITY;

(2) A LICENSED CLINICAL ALCOHOL AND DRUG COUNSELOR, A LICENSED CLINICAL MARRIAGE AND FAMILY THERAPY COUNSELOR, OR A LICENSED CLINICAL PROFESSIONAL COUNSELOR WHO IS ELIGIBLE UNDER § 18-1503 OF THIS SUBTITLE; OR

(3) AN EDUCATION-RELATED PROFESSIONAL WHO QUALIFIES UNDER § 18-1504 OF THIS SUBTITLE WHO:

(I) RECEIVES A RESIDENT TEACHER LICENSE FROM THE DEPARTMENT AFTER COMPLETING AN ALTERNATIVE TEACHING PREPARATION PROGRAM APPROVED BY THE STATE SUPERINTENDENT;

(II) FOR A MENTAL HEALTH PROFESSIONAL, RECEIVES A GRADUATE, PROFESSIONAL, OR UNDERGRADUATE DEGREE FROM ANY ACCREDITED COLLEGE OR UNIVERSITY; OR

(III) IS A PUBLIC SCHOOL TEACHER.

18–1503.

[(b)] (A) The Office **[of Student Financial Assistance]** shall assist in the repayment of the amount of any higher education loan owed by an **ELIGIBLE** individual **UNDER § 18–1502(B) OF THIS SUBTITLE** who:

(1) **[(i)]** Receives a graduate, professional, or undergraduate degree from:

1. A college or university in the State of Maryland;

2. A school of law;

3. For a mental health professional, any accredited college or university; or

4. For a veterinary practitioner or veterinary technician, any accredited veterinary college or university; or

(ii) Receives a Resident Teacher Certificate (RTC) from the Department after completing an alternative teaching preparation program approved by the State Superintendent;

[(2)] Obtains eligible employment;

[(3)] (2) Receives an income that is less than the maximum eligible total income levels established by the Office, including any additional sources of income; and

[(4)] (3) Satisfies any other criteria established by the Office.

[(c)] (B) Subject to the provisions of **[subsection (b)] § 18–1502** of this **[section] SUBTITLE**, the Office shall assist in the repayment of the amount of any higher education loan owed by a **VETERINARY PRACTITIONER WHO HAS PROVIDED VETERINARY SERVICES OR A VETERINARY TECHNICIAN WHO HAS PROVIDED VETERINARY TECHNICIAN SERVICES AS:**

(1) **AN EMPLOYEE IN THE STATE FOR A PERIOD NOT LESS THAN 5 YEARS; OR**

(2) **A VOLUNTEER FOR A MINIMUM OF 100 HOURS PER YEAR FOR A PERIOD NOT LESS THAN 3 YEARS AT AN ANIMAL SHELTER THAT IS OWNED BY:**

(I) **A LOCAL GOVERNMENT;**

(II) AN ORGANIZATION CONTRACTED TO PERFORM ANIMAL CONTROL SERVICES FOR A LOCAL GOVERNMENT; OR

(III) AN ORGANIZATION THAT SHELTERS ANIMALS AND WAS A RECIPIENT OF THE MARYLAND SPAY AND NEUTER GRANTS PROGRAM DURING THE PRIOR YEAR.

(C) SUBJECT TO THE PROVISIONS OF § 18-1502 OF THIS SUBTITLE, THE OFFICE SHALL ASSIST IN THE REPAYMENT OF THE AMOUNT OF ANY HIGHER EDUCATION LOAN OWED BY A LICENSED CLINICAL ALCOHOL AND DRUG COUNSELOR, A LICENSED CLINICAL MARRIAGE AND FAMILY THERAPY COUNSELOR, OR A LICENSED CLINICAL PROFESSIONAL COUNSELOR WHOSE PRACTICE IS LOCATED IN A HIGH-NEED GEOGRAPHIC AREA OF THE STATE AS DETERMINED BY THE MARYLAND DEPARTMENT OF HEALTH.

18-1504.

(A) SUBJECT TO THE PROVISIONS OF § 18-1502 OF THIS SUBTITLE, THE OFFICE SHALL ASSIST IN THE REPAYMENT OF THE AMOUNT OF ANY HIGHER EDUCATION LOAN OWED BY AN EDUCATION-RELATED PROFESSIONAL DESCRIBED IN THIS SECTION.

(B) (1) A GRANT AWARDED UNDER THIS SECTION SHALL BE KNOWN AS THE NANCY GRASMICK PUBLIC SCHOOL PROFESSIONAL AWARD.

(2) A RECIPIENT OF A NANCY GRASMICK PUBLIC SCHOOL PROFESSIONAL AWARD SHALL BE KNOWN AS A NANCY GRASMICK PUBLIC SCHOOL PROFESSIONAL SCHOLAR.

(C) [(1) Public] A PUBLIC school teacher in the State [who] QUALIFIES FOR REPAYMENT UNDER THE PROGRAM IF THE INDIVIDUAL:

1 [(i)] (1) Has taught in Maryland for at least 2 years:

2 [1.] (I) In science, technology, engineering, fine arts, or
3 math subjects;

4 [2.] (II) In a school in which at least [the following
5 percentages of the] **55% OF** students are enrolled in the free and reduced price lunch
6 program in the State[:

7 A. 75% through June 30, 2025; and

8 B. 55% beginning July 1, 2025]; or

9 [3.] (III) In a school that:

10 [A.] 1. Had Title I status during the 2018–2019 school
11 year;

12 [B.] 2. Lost Title I status after the 2018–2019 school year;
13 and

14 [C.] 3. Participates in the United States Department of
15 Agriculture Community Eligibility Provision; and

16 [(ii)] (2) Has received a performance evaluation rating for the most
17 recent year available in the county in which the teacher taught[;].

18 [(2)] (D) [Mental] **A MENTAL** health professional [who] **QUALIFIES FOR**
19 **REPAYMENT UNDER THE PROGRAM IF THE INDIVIDUAL** has provided mental health
20 services in a public school for at least 2 years as an employee of:

21 [(i)] (1) A county school system; or

22 [(ii)] (2) A local health department through an agreement with a
23 county board[; or].

24 [(3)] (E) [Nurse who] **A NURSE QUALIFIES FOR REPAYMENT UNDER**
25 **THE PROGRAM IF THE INDIVIDUAL** has been a school nurse for at least 2 years.

26 [(d) Subject to the provisions of subsection (b) of this section, the Office shall assist
27 in the repayment of the amount of any higher education loan owed by:

28 (1) A veterinarian practitioner who has provided veterinary services as:

29 (i) An employee in the State for a period not less than 5 years; or

(ii) A volunteer for a minimum of 100 hours per year for a period not less than 3 years at an animal shelter that is owned by:

1. A local government;

2. An organization contracted to perform animal control services for a local government; or

3. An organization that shelters animals and was a recipient of the Maryland Spay and Neuter Grants Program during the prior year; or

(2) A veterinary technician who has provided veterinary technician services as:

(i) An employee in the State for a period not less than 5 years; or

(ii) A volunteer for a minimum of 100 hours per year for a period not less than 3 years at an animal shelter that is owned by:

1. A local government;

2. An organization contracted to perform animal control services for a local government; or

3. An organization that shelters animals and was a recipient of the Maryland Spay and Neuter Grants Program during the prior year.

(e) (1) A grant awarded under subsection (c) of this section shall be known as the Nancy Grasmick Public School Professional Award.

(2) A recipient of a Nancy Grasmick Public School Professional Award shall be known as a Nancy Grasmick Public School Professional Scholar.]

[(f)] (A) An applicant for assistance in the repayment of a commercial loan shall demonstrate to the Office that the commercial loan was used for tuition, educational expenses, or living expenses for graduate or undergraduate study.

[(g)] (B) Assistance in the repayment of a loan from an entity set forth in § 18–1501(c)(2) of this subtitle shall require the approval of the Office.

[(h)] Subject to the provisions of subsection (b) of this section, the Office shall assist in the repayment of the amount of any higher education loan owed by a licensed clinical alcohol and drug counselor, a licensed clinical marriage and family therapy counselor, or a licensed clinical professional counselor whose practice is located in a high–need geographic area of the State as determined by the Maryland Department of Health.]

SECTION 3. AND BE IT FURTHER ENACTED, That it is the intent of the General Assembly that, except as expressly provided in this Act, this Act shall be construed as a nonsubstantive revision, and may not otherwise be construed to render any substantive change in the law of the State.

SECTION 4. AND BE IT FURTHER ENACTED, That the Revisor’s Notes contained in this Act are not law and may not be considered to have been enacted as part of this Act.

SECTION 5. AND BE IT FURTHER ENACTED, That the publisher of the Annotated Code of Maryland, in consultation with and subject to the approval of the Department of Legislative Services, shall correct, with no further action required by the General Assembly, cross–references and terminology rendered incorrect by this Act or by any other Act of the General Assembly of 2026 that affects provisions enacted by this Act. The publisher shall adequately describe any correction that is made in an editor’s note following the section affected.

SECTION 6. AND BE IT FURTHER ENACTED, That this Act shall take effect July 1, 2026.
