## CHAPTER \_\_\_\_\_

1 AN ACT concerning

2 **Economic Development – Delivering Economic Competitiveness and Advancing**  
3 **Development Efforts (DECADE) Act**

4 FOR the purpose of altering the designation, administration, and purposes of and eligibility  
5 for certain economic development programs; redesignating the Economic  
6 Development Opportunities Program Account to be the Strategic Closing Fund  
7 within the Department of Commerce; altering the purposes for and methods by  
8 which the Strategic Closing Fund may be utilized; ~~altering the distribution of certain~~  
9 ~~video lottery terminal proceeds;~~ providing for certain requirements relating to the  
10 administration of the Small, Minority, and Women-Owned Businesses Account;  
11 providing that the sales and use tax does not apply to the sale of certain information  
12 technology services and certain digital codes and digital products under certain  
13 circumstances; altering the termination date of the Build Our Future Grant Pilot  
14 Program, Job Creation Tax Credit, Research and Development Tax Credit, and  
15 Employer Security Clearance Costs Tax Credit; altering eligibility for and the  
16 calculation of certain tax credits; ~~allowing a qualified investor that is a pass-through~~  
17 ~~entity that pays a certain income tax on behalf of its members to receive and allocate~~  
18 ~~in any manner a credit or refund of a credit under the Biotechnology Investment~~  
19 ~~Incentive Tax Credit;~~ authorizing a qualified film production entity to amend its

4 in areas of high unemployment]; or

5                   (iii) establishment or attraction of a public institution, a private  
6 institution, or a federal research and development institute new to the State that:

7                   1.     is consistent with the strategic plan of the State for  
8 economic development; and

9                   2.     creates or retains substantial employment[, particularly  
10 in areas of high unemployment].

11                   **(3) "FUND" MEANS THE STRATEGIC CLOSING FUND.**

12                   **[(5)] (4)** (i) "Performance requirement" means a contractual  
13 agreement between an executive agency and [an Account] **A FUND** recipient that requires  
14 the [Account] **FUND** recipient to meet minimum economic development outcomes in  
15 exchange for a grant or a loan under this section.

16                   (ii) "Performance requirement" includes claw-back, penalty,  
17 rescission, and recalibration clauses that utilize job creation, capital investment, and other  
18 measures of economic development.

19                   **[(6)] (5)** "Private sector enterprise" means any commercial, industrial,  
20 educational, or research organization which is not a part of or controlled by a federal, State,  
21 or local government agency.

22                   (b) Subject to the provisions of this section, the [Economic Development  
23 Opportunities Program Account] **STRATEGIC CLOSING FUND** is established **WITHIN THE**  
24 **DEPARTMENT** to maximize extraordinary economic development opportunities.

25                   (c) [Subject to subsection (r) of this section, the] **THE** Governor may provide an  
26 appropriation in the budget bill to the [Account] **FUND** for a specific or general purpose or  
27 purposes.

28                   (d) After notice to and approval by the Legislative Policy Committee, the  
29 Governor may transfer funds by budget amendment [from the Economic Development  
30 Opportunities Program Account to the expenditure account of the appropriate executive  
31 agency] **TO THE FUND**.

1 (e) (1) The [Account] **FUND** is a continuing, nonlapsing fund which is not  
2 subject to § 7–302 of [this subtitle] **THE STATE FINANCE AND PROCUREMENT ARTICLE**.

3 (2) The Treasurer shall separately hold, and the Comptroller shall account  
4 for, the [Account] **FUND**.

5 (3) The [Account] **FUND** shall be invested and reinvested in the same  
6 manner as other State funds.

7 (4) [Except as provided in paragraph (5) of this subsection, any] **ANY**  
8 investment earnings shall be [subject to § 7–311(d) of this subtitle] **CREDITED TO THE**  
9 **GENERAL FUND OF THE STATE**.

12 (f) (1) Money appropriated or credited to the [Account] **FUND** does not revert  
13 to the [Revenue Stabilization Account] **GENERAL FUND OF THE STATE**.

14 (2) [Except as provided in paragraph (3) of this subsection, repayments]  
15 **REPAYMENTS** of principal or interest on any loan from the [Account] **FUND** shall be  
16 retained to the credit of the [Account] **FUND**.

17 [(3) Repayments of principal or interest on any loan made from money  
18 transferred from the Account to a second continuing, nonlapsing fund may be retained to  
19 the credit of the second fund.]

20 (g) (1) The Department [of Commerce] shall include the following information  
21 in the report that is required under § 2.5–109 of [the Economic Development Article] **THIS**  
22 **ARTICLE**:

23 (i) the financial status of the program and a summary of its  
24 operations for the preceding fiscal year;

25 (ii) for the previous 3 fiscal years, the status of [Account] **FUND**  
26 disbursements for economic development projects reviewed by the Legislative Policy  
27 Committee under this section;

28 (iii) for the previous 3 fiscal years, the status of job creation, capital  
29 investment, and other measures of economic development for each economic development  
30 project reviewed by the Legislative Policy Committee under this section; **AND**

31 (iv) [a list of guidelines for the kinds of performance requirements  
32 that may be negotiated with the loan or grant applicant; and

1                   (v)] an explanation if the job creation, capital investment, and other  
2 measures of economic development described in items (i) through (iii) of this paragraph are  
3 lower than negotiated according to subsection (h)(1) of this section.

4                   (2) [Upon] ON receipt of the information that is required to be reported  
5 under this subsection, the Legislative Policy Committee shall have ~~60~~ 21 days to review  
6 and comment on the information provided by the Department [of Commerce] under  
7 paragraph (1) of this subsection, during which time the Department [of Commerce] shall  
8 provide any additional information regarding the [Account] FUND as requested by the  
9 Legislative Policy Committee.

10                  (h) (1) Except as provided in paragraph (2) of this subsection and in subsection  
11 (i) of this section, any funds transferred from the [Economic Development Opportunities  
12 Program Account] FUND shall be used only for extraordinary economic development  
13 opportunities that:

14                   (i) meet the criteria provided in this section;

15                   (ii) include performance requirements; and

16                   (iii) in addition to the performance requirements under item (ii) of  
17 this paragraph, include a performance requirement that utilizes a claw-back provision.

18                   (2) The [Account] DEPARTMENT may UTILIZE THE FUND TO pay [an  
19 executive agency] for administrative, legal, or actuarial expenses incurred by the [agency  
20 in connection with transactions funded by transfers of money to the agency from the  
21 Account] DEPARTMENT.

22                  (i) (1) The Legislative Policy Committee may approve an economic  
23 development opportunity that is not an extraordinary economic development opportunity  
24 if the executive agency requesting the transfer of funds offers a detailed justification for the  
25 exception.

26                   (2) The Legislative Policy Committee shall give particular consideration to  
27 an exception that would provide a significant economic development opportunity for an area  
28 of the State that has a relatively high unemployment rate or relatively low per capita  
29 income.

30                  (j) (1) The Department [of Commerce] may modify the guidelines for the  
31 kinds of performance requirements that may be negotiated with the loan or grant as  
32 needed, upon approval of the Legislative Policy Committee.

33                   (2) [An executive agency] THE DEPARTMENT may depart from these  
34 guidelines as needed, upon approval of the Legislative Policy Committee.

1 (k) [Subject to the provisions of this subtitle, funds transferred] **MONEY** from the  
 2 [Economic Development Opportunities Program Account, to an executive agency,] **FUND**  
 3 may be loaned, granted, or invested for:

4 (1) assisting in the retention or expansion of existing private sector  
 5 enterprises, public or private institutions, or federal research and development institutes;

6 (2) assisting in the establishment or attraction of private sector  
 7 enterprises, public or private institutions, or federal research and development institutes  
 8 new to this State; or

9 (3) providing assistance where existing State or local programs lack  
 10 sufficient resources or are constrained by timing or program design from being utilized.

11 (l) **(1)** [Upon submission to the Legislative Policy Committee of a proposed  
 12 budget amendment to transfer money from the Account, the Governor] **BEFORE FUNDS**  
 13 **FROM THE FUND MAY BE LOANED, GRANTED, OR INVESTED IN ACCORDANCE WITH**  
 14 **SUBSECTION (K) OF THIS SECTION, THE DEPARTMENT** shall provide, subject to §  
 15 2–1257 of the State Government Article, to the Legislative Policy Committee:

22 ~~(iv)~~ **4.** the degree to which available sources of federal, State,  
 23 local, and private financial support have been sought and will be utilized;

24 ~~(2)~~ **(II)** the terms, conditions, and performance requirements of any  
 25 grant or loan for which the funds are to be used;

26 ~~(3)~~ **(III)** a comprehensive economic analysis of the proposed use of the  
 27 funds which estimates:

28 ~~(i)~~ **1.** the economic impact to the State and the local  
 29 jurisdictions affected;

30 ~~(ii)~~ **2.** a minimum level of net economic benefits to the public  
 31 sector;

1                   ~~(iii)~~ **3.**     the number of jobs expected to be created as a result of the  
2 proposed economic development project and the percentage of those jobs that are expected  
3 to be held by Maryland residents;

4                   ~~(iv)~~ **4.**     the wage rates and benefit packages for the jobs expected  
5 to be created as a result of the proposed economic development project; and

6                   ~~(v)~~ **5.**     any other appropriate financial or economic benefits;

7                   ~~(4)~~ **(IV)** any other analysis or information that is requested by the  
8 Legislative Policy Committee; and

9                   ~~(5)~~ **(V)** the date on which the executive agency expects to disburse the  
10 funds to the proposed recipient.

11                   **(2)    THE LEGISLATIVE POLICY COMMITTEE SHALL HAVE 60 DAYS TO**  
12 **REVIEW THE INFORMATION PROVIDED UNDER PARAGRAPH (1) OF THIS SUBSECTION**  
13 **AND APPROVE THE PROPOSED USE OF FUNDS BEFORE FUNDS FROM THE FUND MAY**

17 1 year after the expected disbursement date presented to the Legislative Policy Committee

21 Account to the Legislative Policy Committee; and

25 Account] **FUND** may not be loaned, granted, or invested for:

1            [(o) (1) This subsection does not apply to an economic development opportunity  
2 located in an area designated as a qualified opportunity zone under § 1400Z–1 of the  
3 Internal Revenue Code in Allegany County, Garrett County, Somerset County, or Wicomico  
4 County.

5            (2) In the case of an economic development opportunity located outside a  
6 priority funding area as established under Title 5, Subtitle 7B of this article, the  
7 Department shall first comply with the provisions of that subtitle before making a request

27 may apply for only a prorated credit for research and development expenses paid or  
28 incurred in the taxable year for that part of the taxable year that falls in calendar year  
29 2025].

30 SECTION 4. AND BE IT FURTHER ENACTED, That this Act shall take effect July  
31 1, 2000. [It shall remain effective for a period of 27 years and, at the end of June 30, 2027,  
32 with no further action required by the General Assembly, this Act shall be abrogated and  
33 of no further force and effect.]

1 SECTION 7. AND BE IT FURTHER ENACTED, That the publisher of the  
2 Annotated Code of Maryland, in consultation with and subject to the approval of the  
3 Department of Legislative Services, shall correct, with no further action required by the  
4 General Assembly, cross-references and terminology rendered incorrect by this Act. The  
5 publisher shall adequately describe any correction that is made in an editor's note following  
6 the section affected.

7 SECTION 8. AND BE IT FURTHER ENACTED, That Section 4 of this Act shall be  
8 applicable to all taxable years beginning after December 31, 2025.

9 SECTION 9. AND BE IT FURTHER ENACTED, That Section 5 of this Act shall be  
10 applicable to all taxable years beginning after June 30, 2026.

11 SECTION 10. AND BE IT FURTHER ENACTED, That Sections 1, 2, 3, 4, and 6 of  
12 this Act shall take effect July 1, 2026.

13 SECTION 11. AND BE IT FURTHER ENACTED, That, except as provided in  
14 Section 10 of this Act, this Act shall take effect June 1, 2026.
