2 **Maryland Department of Health – Forensic Review Boards and Community**
3 **Forensic Aftercare Program ~~– Established~~**

4 FOR the purpose of repealing the requirement that a forensic review board provide notice
5 to certain individuals within a certain time period after issuing a recommendation
6 to the court; authorizing an authorized agent to attend a forensic review board
7 meeting virtually; establishing the Community Forensic Aftercare Program in the
8 Maryland Department of Health to monitor committed persons on conditional
9 release and individuals with mental illness or intellectual disability who are
10 required to be monitored under certain circumstances; requiring the Program to
11 establish a community monitoring board to make certain decisions and
12 recommendations related to conditional release and out-of-state travel; and
13 generally relating to forensic review boards and the Community Forensic Aftercare
14 Program.

SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

Article – Criminal Procedure

3–101.

(a) In this title the following words have the meanings indicated.

(b) “Committed person” means a person committed to the Health Department as not criminally responsible under the test for criminal responsibility.

(d) “Health Department” means the Maryland Department of Health.

3–120.1.

(a) In this section, “authorized agent” means an individual who is not counsel for the committed person and who is selected by the committed person to represent the interests of the committed person in all forensic review board matters.

(b) (1) The Health Department shall establish a forensic review board at each facility that has charge of a committed person under this subtitle.

(2) A forensic review board may make recommendations relating to the release or rehabilitation of a committed person under this subtitle.

(c) Each member of a forensic review board shall be a health care provider licensed under the Health Occupations Article.

(d) (1) At least once each year, each forensic review board shall review each committed person’s eligibility for release under § 3–114 of this subtitle.

(2) The forensic review board shall, by a majority vote of the members, determine whether to recommend to the court that a committed person is eligible for discharge or conditional release, with or without proposed conditions.

(3) (i) Each forensic review board shall maintain a written record containing its findings and recommendations.

1 (ii) The written record shall be included in the medical record of the
2 committed person.

3 (iii) The findings shall include the reasons for the forensic review
4 board's recommendation and a plan for overcoming any barriers to release.

5 (4) When making a recommendation under this section, a forensic review
6 board shall consider a written statement offered by the committed person to the forensic
7 review board.

8 (5) The forensic review board shall provide notice to a committed person
9 and the counsel of record for the committed person[:

10 (i)] at least 10 days before the forensic review board holds a meeting
11 concerning the committed person[; and

12 (ii) within 10 days after the forensic review board issues a
13 recommendation to the court].

14 (e) (1) Each forensic review board shall have an odd number of members.

15 (2) Each member of the forensic review board shall have one vote.

16 (3) (i) A forensic review board may not conduct a review under
17 subsection (d) of this section unless a quorum is present.

18 (ii) A majority of the members of the forensic review board is a
19 quorum.

20 (f) (1) A committed person may appoint an authorized agent to attend the
21 [portion] ENTIRETY of a forensic review board meeting concerning the committed person,
22 EXCEPT FOR THE FINAL VOTING PORTION OF A MEETING.

23 (2) An authorized agent may be a social worker or a nonlegal
24 representative employed by the office of the attorney representing the committed person.

25 (3) An authorized agent may only give and hear arguments.

26 (4) AN AUTHORIZED AGENT MAY ATTEND A FORENSIC REVIEW BOARD
27 MEETING VIRTUALLY.

28 [(4)] (5) Counsel for any party may not attend forensic review board
29 meetings.

1 (g) (1) If the committed person's treatment team determines that the
2 committed person is eligible for discharge or conditional release before the annual review
3 scheduled under subsection (d) of this section, the treatment team shall notify the forensic
4 review board in writing of the need for a release eligibility review.

5 (2) Within 30 days after receiving notice under paragraph (1) of this
6 subsection, the forensic review board shall conduct a review in accordance with subsection
7 (d) of this section.

8 (3) The treatment team shall provide a written statement that includes the
9 clinical reasons underlying the determination that the committed person is eligible for
10 discharge or conditional release.

11 (4) A copy of the notification made under paragraph (1) of this subsection
12 and the written statement required under paragraph (3) of this subsection shall be included
13 in the medical record of the committed person.

14 (h) A copy of a document or record produced by a forensic review board under this
15 section shall, on request, be provided to:

16 (1) the committed person;

17 (2) counsel for the committed person;

18 (3) the court;

19 (4) the State's Attorney; or

20 (5) the Health Department.

21 (i) The committed person's treatment team shall implement recommendations, if
22 any, from the forensic review board and make arrangements for necessary treatment to
23 rehabilitate the committed person in accordance with § 10-706 of the Health – General
24 Article.

25 (j) (1) A forensic review board may appoint a representative to testify as to
26 the Health Department's position at a release hearing.

27 (2) If a forensic review board takes a position contrary to the position of the
28 committed person's treatment team, the representative appointed under this subsection
29 may not be a member of the committed person's treatment team.

30 (k) The Health Department shall adopt regulations to carry out this section.

(A) IN THIS SUBTITLE THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(B) “AUTHORIZED AGENT” MEANS AN INDIVIDUAL WHO IS NOT COUNSEL FOR THE COMMITTED PERSON AND WHO IS SELECTED BY THE COMMITTED PERSON TO REPRESENT THE INTERESTS OF THE COMMITTED PERSON IN ALL COMMUNITY MONITORING BOARD MATTERS.

(C) “COMMITTED PERSON” HAS THE MEANING STATED IN § 3-101 OF THE CRIMINAL PROCEDURE ARTICLE.

(D) “MENTAL HEALTH TEAM” MEANS THE COMMITTED PERSON’S INPATIENT BEHAVIORAL HEALTH PROVIDERS AND OUTPATIENT COMMUNITY BEHAVIORAL HEALTH PROVIDERS.

(E) “PROGRAM” MEANS THE COMMUNITY FORENSIC AFTERCARE PROGRAM.

(F) “PROGRAM MONITOR” MEANS A LICENSED ~~CERTIFIED~~ SOCIAL ~~WORKER-CLINICAL~~ WORKER EMPLOYED BY THE PROGRAM TO:

(1) COLLECT AND REVIEW INFORMATION PERTAINING TO A COMMITTED PERSON’S COMPLIANCE WITH A CONDITIONAL RELEASE ORDER; AND

(2) MAKE BEHAVIORAL HEALTH RECOMMENDATIONS TO THE COMMITTED PERSON’S BEHAVIORAL HEALTH PROVIDERS AND THE COURT.
