A BILL ENTITLED

1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Consumption–Only Nonprofit**
3 **Swim Club License**

4 FOR the purpose of establishing a consumption–only nonprofit swim club license in Anne
5 Arundel County; authorizing the Board of License Commissioners for Anne Arundel
6 County to issue the license to a nonprofit swim club in Anne Arundel County;
7 authorizing the license holder to allow the consumption of beer, wine, and liquor
8 during certain designated events; and generally relating to alcoholic beverages
9 licenses in Anne Arundel County.

20 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
21 That the Laws of Maryland read as follows:

22 **Article – Alcoholic Beverages and Cannabis**

23 11–102.

24 This title applies only in Anne Arundel County.

2 **(A) THERE IS A CONSUMPTION-ONLY NONPROFIT SWIM CLUB LICENSE.**

3 **(B) THE BOARD MAY ISSUE THE LICENSE TO A NONPROFIT SWIM CLUB.**

4 **(C) (1) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO ALLOW**
5 **MEMBERS OF THE SWIM CLUB AND THEIR GUESTS TO BRING BEER, WINE, AND**
6 **LIQUOR ONTO THE LICENSED PREMISES FOR ON-PREMISES CONSUMPTION.**

7 **(2) THE LICENSE HOLDER MAY ALLOW THE CONSUMPTION OF BEER,**
8 **WINE, AND LIQUOR:**

9 **(I) IN A DESIGNATED AREA OF THE SWIM CLUB;**

10 **(II) DURING A DESIGNATED EVENT; AND**

11 **(III) UP TO 5 DAYS PER YEAR, UNLESS ADDITIONAL DAYS ARE**
12 **AUTHORIZED BY THE BOARD.**

13 **(D) THE LICENSE HOLDER SHALL PROVIDE NOTICE TO THE BOARD AT**
14 **LEAST 10 DAYS PRIOR TO A DESIGNATED EVENT WHERE ALCOHOL WILL BE**
15 **CONSUMED.**

16 **(E) DURING A DESIGNATED EVENT, THE LICENSE HOLDER MAY ALLOW THE**
17 **CONSUMPTION OF BEER, WINE, AND LIQUOR IN THE DESIGNATED AREA FROM 2 P.M.**
18 **TO 10 P.M.**

19 **(F) (1) THE ANNUAL LICENSE FEE IS \$100.**

20 **(2) THE FEE FOR ADDITIONAL DAYS IS \$50 PER DAY, UP TO A**
21 **MAXIMUM OF 3 ADDITIONAL DAYS.**

22 **SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect July**
23 **1, 2026.**
