1 AN ACT concerning

2 **Anne Arundel County – Alcoholic Beverages – Golf Course License and Sports**
3 **Activity Venue Licenses**

4 FOR the purpose of establishing in Anne Arundel County a Class ~~€~~ GC (golf course) license
5 that authorizes the holder to sell beer, wine, and liquor for on–premises consumption
6 at a certain golf course; establishing in Anne Arundel County sports activity venue
7 licenses that authorize the holder to sell beer and wine or beer, wine, and liquor for
8 on–premises consumption at a certain sports activity venue; and generally relating
9 to alcoholic beverages licenses in Anne Arundel County.

4 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
5 That Section(s) 11–1006.2 of Article – Alcoholic Beverages and Cannabis of the Annotated
6 Code of Maryland be renumbered to be Section(s) 11–1006.3.

7 SECTION 2. AND BE IT FURTHER ENACTED, That the Laws of Maryland read
8 as follows:

9 **Article – Alcoholic Beverages and Cannabis**

10 11–102.

11 This title applies only in Anne Arundel County.

12 **11–1006.2.**

13 **(A) THERE IS A CLASS ~~€~~ GC (GOLF COURSE) LICENSE.**

14 **(B) THE BOARD MAY ISSUE THE LICENSE FOR USE AT A GOLF COURSE WITH**
15 **AT LEAST NINE HOLES.**

16 **(C) THE LICENSE AUTHORIZES THE LICENSE HOLDER TO SELL BEER, WINE,**
17 **AND LIQUOR AT RETAIL AT THE PLACE DESCRIBED IN THE LICENSE FOR**
18 **ON–PREMISES CONSUMPTION.**

19 **(D) THE BOARD MAY PLACE CONDITIONS ON THE LOCATION OF SALES AND**
20 **CONSUMPTION, INCLUDING PROHIBITING THE SALE AND CONSUMPTION OF BEER,**
21 **WINE, AND LIQUOR IN SPECIFIC AREAS OF THE PREMISES.**

22 **(E) (1) (I) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS**
23 **SUBSECTION, THE HOLDER OF THE LICENSE MAY SELL BEER, WINE, AND LIQUOR ON**
24 **MONDAY THROUGH SUNDAY FROM 6 A.M. TO 2 A.M. THE FOLLOWING DAY.**

25 **(II) THE HOLDER OF THE LICENSE NEED NOT OBTAIN A SUNDAY**
26 **PERMIT UNDER § 11–2004 OF THIS TITLE TO SELL ALCOHOLIC BEVERAGES ON**
27 **SUNDAY.**

28 **(2) THE BOARD MAY REDUCE THE HOURS AND DAYS OF SALE FOR ALL**
29 **OR PART OF THE LICENSED PREMISES.**

30 **(F) THE ANNUAL LICENSE FEE IS \$1,200.**

2 **(A) THERE IS:**

3 **(1) A SPORTS ACTIVITY VENUE BEER AND WINE LICENSE; AND**

4 **(2) A SPORTS ACTIVITY VENUE BEER, WINE, AND LIQUOR LICENSE.**

5 **(B) THE BOARD MAY ISSUE A LICENSE TO THE OWNER OR OPERATOR OF A**
6 **COMMERCIAL RECREATIONAL FACILITY THAT OFFERS:**

7 **(1) BOWLING;**

8 **(2) GOLF SIMULATORS;**

9 **(3) MULTISPORT SIMULATORS;**

10 **(4) INDOOR OR OUTDOOR PICKLEBALL COURTS;**

11 **(5) INDOOR GYMNASIUMS OR TRAINING CENTERS; OR**

12 **(6) ANY SIMILAR SPORT ACTIVITY OR VENUE.**

13 **(C) (1) THE SPORTS ACTIVITY VENUE BEER AND WINE LICENSE**
14 **AUTHORIZES THE HOLDER TO SELL BEER AND WINE AT RETAIL AT THE PLACE**
15 **DESCRIBED IN THE LICENSE FOR ON-PREMISES CONSUMPTION.**

16 **(2) THE SPORTS ACTIVITY VENUE BEER, WINE, AND LIQUOR LICENSE**
17 **AUTHORIZES THE HOLDER TO SELL BEER, WINE, AND LIQUOR AT RETAIL AT THE**
18 **PLACE DESCRIBED IN THE LICENSE FOR ON-PREMISES CONSUMPTION.**

19 **(D) (1) THE LICENSE HOLDER MAY SELL OR SERVE ALCOHOL ONLY IN**
20 **AREAS WITHIN THE PREMISES DESIGNATED FOR ACTIVITY, SEATING, BAR SERVICE,**
21 **AND DINING, INCLUDING PRIVATE PARTY ROOMS, AS DELINEATED IN THE LICENSE**
22 **APPLICATION AND SITE PLAN APPROVED BY THE BOARD.**

23 **(2) THE LICENSE AUTHORIZES SALES TO A CUSTOMER, AT LEAST 21**
24 **YEARS OLD, WHO IS:**

25 **(I) ACTIVELY UTILIZING OR PARTICIPATING IN THE VENUE'S**
26 **RECREATIONAL SERVICES OR DINING; OR**

1 **(II) ON THE LICENSED PREMISES AS A GUEST OF A PARTICIPANT**
2 **IN AN ACTIVITY OFFERED BY THE VENUE.**

3 **(E) THE LICENSE HOLDER SHALL MAINTAIN AND OFFER FOR SALE TO**
4 **CUSTOMERS A VARIETY OF PREPARED, CONSUMABLE FOOD ITEMS AVAILABLE**
5 **DURING ALL HOURS THAT ALCOHOLIC BEVERAGES ARE FOR SALE, AS APPROVED BY**
6 **THE BOARD BASED ON THE NATURE OF THE FACILITY.**

7 **(F) THE LICENSE HOLDER SHALL:**

8 **(1) REQUIRE ALL EMPLOYEES SERVING ALCOHOL TO BE CERTIFIED**
9 **BY AN APPROVED ALCOHOL AWARENESS TRAINING PROGRAM;**

10 **(2) IMPLEMENT A WRITTEN POLICY FOR EMPLOYEES TO MONITOR**
11 **AND LIMIT SERVICE TO CUSTOMERS WHO ARE ACTIVELY PARTICIPATING IN**
12 **PHYSICAL ACTIVITIES TO ENSURE SAFETY AND PREVENT INTOXICATION; AND**

13 **(3) OBTAIN A CROWD CONTROL TRAINING CERTIFICATE WHERE THE**
14 **OCCUPANT LOAD EXCEEDS 50 PERSONS.**

15 **(G) (1) THE LICENSE HOLDER MAY SELL ALCOHOLIC BEVERAGES**
16 **MONDAY THROUGH SUNDAY FROM 6 A.M. TO 2 A.M. THE FOLLOWING DAY.**

17 **(2) THE LICENSE HOLDER NEED NOT OBTAIN A SUNDAY LICENSE**
18 **UNDER § 11-2004 OF THIS TITLE TO SELL ALCOHOLIC BEVERAGES ON SUNDAY.**

19 **(H) THE ANNUAL LICENSE FEES ARE:**

20 **(1) \$740 FOR A SPORTS ACTIVITY VENUE BEER AND WINE LICENSE;**
21 **AND**

22 **(2) \$1,200 FOR A SPORTS ACTIVITY VENUE BEER, WINE, AND LIQUOR**
23 **LICENSE.**

24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
25 1, 2026.
