## A BILL ENTITLED

1 AN ACT concerning

2 **Vehicle Laws – Crosswalk Monitoring Systems – Authorization**

3 FOR the purpose of authorizing the use of crosswalk monitoring systems in school zones if  
4 authorized by local law; providing that the owner or driver of a motor vehicle  
5 recorded failing to yield to a pedestrian crossing a roadway in a crosswalk is subject  
6 to a citation and a certain civil penalty under certain circumstances; establishing  
7 certain defenses to a charge of an alleged violation recorded by a crosswalk  
8 monitoring system; prohibiting a contractor administering a crosswalk monitoring  
9 system from being compensated in a certain manner; and generally relating to the  
10 use of crosswalk monitoring systems.

26 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
27 That the Laws of Maryland read as follows:

**Article – Courts and Judicial Proceedings**

4–401.

Except as provided in § 4–402 of this subtitle, and subject to the venue provisions of Title 6 of this article, the District Court has exclusive original civil jurisdiction in:

(13) A proceeding for a civil infraction under § 21–202.1, **§ 21–502.2**, § 21–704.1, § 21–706.1, § 21–707.1, § 21–809, § 21–810, § 21–1134, § 22–612, or § 24–111.3 of the Transportation Article or § 10–112 of the Criminal Law Article;

7–302.

(e) (1) (i) A citation issued under § 21–202.1, **§ 21–502.2**, § 21–706.1, § 21–707.1, § 21–809, § 21–810, § 21–1134, § 22–612, or § 24–111.3 of the Transportation Article shall provide that the person receiving the citation may elect to stand trial by notifying the issuing agency of the person’s intention to stand trial at least 5 days before the date of payment as set forth in the citation.

(ii) On receipt of the notice to stand trial, the agency shall forward to the District Court having venue a copy of the citation and a copy of the notice from the person who received the citation indicating the person’s intention to stand trial.

(iii) On receipt thereof, the District Court shall schedule the case for trial and notify the defendant of the trial date under procedures adopted by the Chief Judge of the District Court.

(2) (i) A citation issued as the result of any of the following systems or cameras controlled by a political subdivision shall provide that, in an uncontested case, the penalty shall be paid directly to that political subdivision:

1. A vehicle height monitoring system;
2. A traffic control signal monitoring system;
3. A speed monitoring system;
4. A work zone speed control system;
5. A stop sign monitoring system;
6. **A CROSSWALK MONITORING SYSTEM;**
7. A school bus monitoring camera;
- [7.] 8. A bus lane monitoring system; or**

1 [8.] 9. A noise abatement monitoring system.

2 (ii) A citation issued as the result of any of the following systems or  
3 cameras controlled by a political subdivision shall provide that, in a contested case, the  
4 penalty shall be paid directly to the District Court:

- 5 1. A vehicle height monitoring system;
- 6 2. A traffic control signal monitoring system;
- 7 3. A speed monitoring system;
- 8 4. A work zone speed control system;
- 9 5. A stop sign monitoring system;
- 10 6. **A CROSSWALK MONITORING SYSTEM;**
- 11 7. A school bus monitoring camera;

12 [7.] 8. A bus lane monitoring system; or

13 [8.] 9. A noise abatement monitoring system.

14 (iii) A citation issued as the result of any of the following systems or  
15 cameras controlled by a State agency shall provide that, in an uncontested or contested  
16 case, the penalty shall be paid directly to the District Court:

- 17 1. A traffic control signal monitoring system;
- 18 2. A work zone speed control system;
- 19 3. A speed monitoring system; or
- 20 4. A bus lane monitoring system.

21 (3) (i) Except as provided in subparagraphs (ii) and (iii) of this  
22 paragraph and paragraph (6) of this subsection, civil penalties resulting from citations  
23 issued using a vehicle height monitoring system, traffic control signal monitoring system,  
24 speed monitoring system, work zone speed control system, stop sign monitoring system,  
25 **CROSSWALK MONITORING SYSTEM**, school bus monitoring camera, bus lane monitoring  
26 system, or a noise abatement monitoring system that are collected by the District Court  
27 shall be collected in accordance with subsection (a) of this section and distributed in  
28 accordance with § 12–118 of the Transportation Article.

(ii) 1. The fines collected by the District Court as a result of violations enforced by speed monitoring systems on Interstate 695 in Baltimore County and Interstate 83 in Baltimore County shall be remitted to the Comptroller for distribution to the State Highway Administration to be used solely to:

A. Recover the cost of implementing and administering the speed monitoring systems on Interstate 695 in Baltimore County and Interstate 83 in Baltimore County; and

B. Assist in covering the cost of roadway and safety improvements on Interstate 695 in Baltimore County and Interstate 83 in Baltimore County.

2. Fines distributed to the State Highway Administration under subparagraph 1 of this subparagraph are supplemental to and are not intended to take the place of funding that would otherwise be appropriated for uses described under subparagraph 1 of this subparagraph.

(iii) Civil penalties resulting from citations issued using a speed monitoring system controlled by the Maryland Transportation Authority that are collected by the District Court shall be collected in accordance with subsection (a) of this section and remitted to the Maryland Transportation Authority.

(4) (i) Except as provided in paragraphs (5) and (6) of this subsection, from the fines collected by a political subdivision as a result of violations enforced by speed monitoring systems, work zone speed control systems, stop sign monitoring systems, **CROSSWALK MONITORING SYSTEMS**, school bus monitoring cameras, bus lane monitoring systems, or noise abatement monitoring systems, a political subdivision:

1. May recover the costs of implementing and administering the speed monitoring systems, work zone speed control systems, stop sign monitoring systems, **CROSSWALK MONITORING SYSTEMS**, school bus monitoring cameras, bus lane monitoring systems, or noise abatement monitoring systems; and

2. Subject to subparagraphs (ii), (iii), and (iv) of this paragraph, may spend any remaining balance solely for public safety purposes, including pedestrian or highway safety programs.

(a) A recorded image of a motor vehicle produced by a traffic control signal monitoring system in accordance with § 21–202.1 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of § 21–202(h) of the Transportation Article without authentication.

(b) A recorded image of a motor vehicle produced by a speed monitoring system in accordance with § 21–809 or § 21–810 of the Transportation Article is admissible in a

proceeding concerning a civil citation issued under that section for a violation of Title 21, Subtitle 8 of the Transportation Article without authentication.

(c) A recorded image of a motor vehicle produced by a school bus monitoring camera in accordance with § 21–706.1 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of § 21–706 of the Transportation Article without authentication.

(d) A recorded image of a motor vehicle produced by a vehicle height monitoring system in accordance with § 24–111.3 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of a State or local law restricting the presence of certain vehicles during certain times without authentication.

(e) A recorded image of a motor vehicle produced by a bus lane monitoring system in accordance with § 21–113.4 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of § 21–113.3 of the Transportation Article without authentication.

(f) A recorded image of a motor vehicle and any relevant recorded audio produced by a noise abatement monitoring system in conjunction with a noise measuring device in accordance with § 22–612 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of § 22–602 of the Transportation Article without authentication.

(g) A recorded image of a motor vehicle produced by a stop sign monitoring system in accordance with § 21–707.1 of the Transportation Article is admissible in a proceeding concerning a civil citation issued under that section for a violation of § 21–707 of the Transportation Article without authentication.

**(h) A RECORDED IMAGE OF A MOTOR VEHICLE PRODUCED BY A CROSSWALK MONITORING SYSTEM IN ACCORDANCE WITH § 21–502.2 OF THE TRANSPORTATION ARTICLE IS ADMISSIBLE IN A PROCEEDING CONCERNING A CIVIL CITATION ISSUED UNDER THAT SECTION FOR A VIOLATION OF § 21–502(A)(2) OF THE TRANSPORTATION ARTICLE WITHOUT AUTHENTICATION.**

**(I)** In any other judicial proceeding, a recorded image produced by a vehicle height monitoring system, traffic control signal monitoring system, speed monitoring system, work zone speed control system, stop sign monitoring system, **CROSSWALK MONITORING SYSTEM**, school bus monitoring camera, or bus lane monitoring system or a recorded image and any relevant recorded audio produced by a noise abatement monitoring system in conjunction with a noise measuring device is admissible as otherwise provided by law.

21-502.

(a) (1) This subsection does not apply where:

(i) A pedestrian tunnel or overhead pedestrian crossing is provided, as described in § 21-503(b) of this subtitle; or

(ii) A traffic control signal is in operation.

(2) The driver of a vehicle shall come to a stop when a pedestrian crossing the roadway in a crosswalk is:

(i) On the half of the roadway on which the vehicle is traveling; or

(ii) Approaching from an adjacent lane on the other half of the roadway.

(b) A pedestrian may not suddenly leave a curb or other place of safety and walk or run into the path of a vehicle which is so close that it is impossible for the driver to yield.

(c) If, at a marked crosswalk or at an unmarked crosswalk at an intersection, a vehicle is stopped to let a pedestrian cross the roadway, the driver of any other vehicle approaching from the rear may not overtake and pass the stopped vehicle.

(d) A person may not commit a violation of subsection (a) or (c) of this section that contributes to an accident.

(e) A person convicted of a violation of subsection (d) of this section is subject to imprisonment not exceeding 2 months or a fine not exceeding \$1,000 or both.

**(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.**

**(2) "AGENCY" MEANS A LAW ENFORCEMENT AGENCY THAT IS AUTHORIZED TO ISSUE A CITATION FOR A VIOLATION OF THE MARYLAND VEHICLE LAW OR OF LOCAL TRAFFIC LAWS OR REGULATIONS.**

**(3) "CROSSWALK MONITORING SYSTEM" MEANS A DEVICE DESIGNED TO CAPTURE A RECORDED IMAGE OF A VIOLATION.**

**(4) (I) "OWNER" MEANS THE REGISTERED OWNER OF A MOTOR VEHICLE OR LESSEE OF A MOTOR VEHICLE UNDER A LEASE OF 6 MONTHS OR MORE.**

**(II) "OWNER" DOES NOT INCLUDE:**

1                               1.     A MOTOR VEHICLE LEASING COMPANY; OR

2                               2.     A HOLDER OF A SPECIAL REGISTRATION PLATE  
3 ISSUED UNDER TITLE 13, SUBTITLE 9, PART III OF THIS ARTICLE.

4                               (5)    “RECORDED IMAGE” MEANS IMAGES RECORDED BY A CROSSWALK  
5 MONITORING SYSTEM:

6                               (I)    ON:

7                               1.     TWO OR MORE PHOTOGRAPHS;

8                               2.     TWO OR MORE MICROPHOTOGRAPHS;

9                               3.     TWO OR MORE ELECTRONIC IMAGES;

10                              4.     VIDEOTAPE; OR

11                              5.     ANY OTHER MEDIUM; AND

12                              (II)   SHOWING A MOTOR VEHICLE AND, ON AT LEAST ONE IMAGE  
13 OR PORTION OF TAPE, CLEARLY IDENTIFYING THE REGISTRATION PLATE NUMBER  
14 OF THE MOTOR VEHICLE.

15                              (6)    (I)    “VIOLATION” MEANS A FAILURE TO COME TO A STOP AT A  
16 CROSSWALK IN VIOLATION OF § 21-502(A)(2) OF THIS SUBTITLE.

17                              (II)   “VIOLATION” DOES NOT INCLUDE ANY ACTION A DRIVER IS  
18 INSTRUCTED TO TAKE BY A POLICE OFFICER.

19                              (B)    (1)   SUBJECT TO PARAGRAPHS (2) THROUGH (5) OF THIS  
20 SUBSECTION, AN AGENCY MAY USE CROSSWALK MONITORING SYSTEMS:

21                              (I)    ON HIGHWAYS LOCATED IN A SCHOOL ZONE MAINTAINED BY  
22 A LOCAL JURISDICTION, IF AUTHORIZED BY THE GOVERNING BODY OF THE LOCAL  
23 JURISDICTION; OR

24                              (II)   ON STATE HIGHWAYS LOCATED IN A SCHOOL ZONE, IF  
25 AUTHORIZED BY THE STATE HIGHWAY ADMINISTRATION.

26                              (2)    A CROSSWALK MONITORING SYSTEM MAY NOT BE USED IN A  
27 LOCAL JURISDICTION UNDER THIS SECTION UNLESS ITS USE IS AUTHORIZED BY THE

GOVERNING BODY OF THE LOCAL JURISDICTION BY LOCAL LAW ENACTED AFTER  
REASONABLE NOTICE AND A PUBLIC HEARING.

(3) A COUNTY SHALL PRIORITIZE THE PLACEMENT OF CROSSWALK  
MONITORING SYSTEMS WITHIN MUNICIPALITIES THAT HAVE HIGH VIOLATION  
RATES.

(4) BEFORE BEGINNING USE OF CROSSWALK MONITORING SYSTEMS,  
AN AGENCY SHALL PUBLISH NOTICE THAT THE AGENCY HAS ADOPTED THE USE OF  
CROSSWALK MONITORING SYSTEMS ON ITS WEBSITE AND IN A NEWSPAPER OF  
GENERAL CIRCULATION IN THE JURISDICTION IN WHICH THE CROSSWALK  
MONITORING SYSTEM WILL BE USED.

(5) (I) A COUNTY SHALL PROMINENTLY PLACE SIGNS ON  
HIGHWAYS WITHIN THE COUNTY PROVIDING NOTICE THAT CROSSWALK  
MONITORING SYSTEMS ARE USED IN THE COUNTY.

(II) THE STATE HIGHWAY ADMINISTRATION SHALL PLACE  
SIGNS PROMINENTLY PROVIDING NOTICE THAT CROSSWALK MONITORING SYSTEMS  
ARE IN USE ON STATE HIGHWAYS.

(C) A RECORDED IMAGE UNDER THIS SECTION INDICATING THAT THE  
DRIVER OF A MOTOR VEHICLE HAS COMMITTED A VIOLATION SHALL INCLUDE:

(1) THE TIME AND DATE OF THE VIOLATION; AND

(2) TO THE EXTENT POSSIBLE, THE LOCATION OF THE VIOLATION.

(D) (1) UNLESS THE DRIVER OF THE MOTOR VEHICLE RECEIVED A  
CITATION FROM A POLICE OFFICER AT THE TIME OF THE VIOLATION, THE OWNER  
OR, IN ACCORDANCE WITH SUBSECTION (E)(3) OR (G)(4) OR (5) OF THIS SECTION,  
THE DRIVER OF A MOTOR VEHICLE IS SUBJECT TO A CIVIL PENALTY IF THE MOTOR  
VEHICLE IS RECORDED BY A CROSSWALK MONITORING SYSTEM DURING THE  
COMMISSION OF A VIOLATION.

(2) A CIVIL PENALTY UNDER THIS SUBSECTION MAY NOT EXCEED \$40.

(3) FOR PURPOSES OF THIS SECTION, THE DISTRICT COURT SHALL  
PRESCRIBE:

(I) A UNIFORM CITATION FORM CONSISTENT WITH  
SUBSECTION (E)(1) OF THIS SECTION AND § 7-302 OF THE COURTS ARTICLE; AND

6           **CITATION WILL BE MAILED TO THE MOTOR VEHICLE RENTAL COMPANY UNLESS,**  
7           **WITHIN 45 DAYS AFTER RECEIVING THE NOTICE, THE MOTOR VEHICLE RENTAL**  
8           **COMPANY PROVIDES THE AGENCY WITH:**

10           **NAME AND LAST KNOWN MAILING ADDRESS OF THE INDIVIDUAL DRIVING OR**

15           **THE MOTOR VEHICLE WAS STOLEN AT THE TIME OF THE VIOLATION; AND**

16                      **B. A COPY OF THE POLICE REPORT ASSOCIATED WITH**  
17           **THE MOTOR VEHICLE THEFT CLAIMED UNDER ITEM A OF THIS ITEM; OR**

22           **THE MOTOR VEHICLE RENTAL COMPANY COMPLIES WITH SUBPARAGRAPH (I) OF**

14 **OR POSSESSION OF THE OWNER AT THE TIME OF THE VIOLATION;**

15                   **(II) SUBJECT TO PARAGRAPH (3) OF THIS SUBSECTION,**  
16 **EVIDENCE THAT THE PERSON NAMED IN THE CITATION WAS NOT OPERATING THE**  
17 **VEHICLE AT THE TIME OF THE VIOLATION; AND**

18                   **(III) ANY OTHER ISSUES AND EVIDENCE THAT THE DISTRICT**  
19 **COURT CONSIDERS PERTINENT.**

20           **(2) TO DEMONSTRATE THAT THE MOTOR VEHICLE OR THE**  
21 **REGISTRATION PLATES WERE STOLEN BEFORE THE VIOLATION OCCURRED AND**  
22 **WERE NOT UNDER THE CONTROL OR POSSESSION OF THE OWNER AT THE TIME OF**  
23 **THE VIOLATION, THE OWNER MUST SUBMIT PROOF THAT A POLICE REPORT ABOUT**  
24 **THE STOLEN MOTOR VEHICLE OR REGISTRATION PLATES WAS FILED IN A TIMELY**  
25 **MANNER.**

26           **(3) TO SATISFY THE EVIDENTIARY BURDEN UNDER PARAGRAPH**  
27 **(1)(II) OF THIS SUBSECTION, THE PERSON NAMED IN THE CITATION SHALL PROVIDE**  
28 **TO THE DISTRICT COURT EVIDENCE TO THE SATISFACTION OF THE DISTRICT**  
29 **COURT OF WHO WAS OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION,**  
30 **INCLUDING, AT A MINIMUM, THE OPERATOR'S NAME AND CURRENT ADDRESS.**

31           **(4) (I) THE PROVISIONS OF THIS PARAGRAPH APPLY ONLY TO A**  
32 **CITATION THAT INVOLVES A CLASS E (TRUCK) VEHICLE WITH A REGISTERED GROSS**  
33 **WEIGHT OF 26,001 POUNDS OR MORE, CLASS F (TRACTOR) VEHICLE, CLASS G**  
34 **(TRAILER) VEHICLE OPERATED IN COMBINATION WITH A CLASS F (TRACTOR)**  
35 **VEHICLE, OR CLASS P (PASSENGER BUS) VEHICLE.**

(II) TO SATISFY THE EVIDENTIARY BURDEN UNDER PARAGRAPH (1)(II) OF THIS SUBSECTION, THE PERSON NAMED IN A CITATION DESCRIBED UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH MAY PROVIDE TO THE DISTRICT COURT A LETTER, SWORN TO OR AFFIRMED BY THE PERSON AND MAILED BY CERTIFIED MAIL, RETURN RECEIPT REQUESTED, THAT:

1. STATES THAT THE PERSON NAMED IN THE CITATION WAS NOT OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION; AND

2. PROVIDES THE NAME, ADDRESS, AND DRIVER'S LICENSE IDENTIFICATION NUMBER OF THE PERSON WHO WAS OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION.

(5) (I) IF THE DISTRICT COURT FINDS THAT THE PERSON NAMED IN THE CITATION WAS NOT OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION OR RECEIVES EVIDENCE UNDER PARAGRAPH (4)(II)2 OF THIS SUBSECTION IDENTIFYING THE PERSON DRIVING THE VEHICLE AT THE TIME OF THE VIOLATION, THE CLERK OF COURT SHALL PROVIDE TO THE AGENCY ISSUING THE CITATION A COPY OF ANY EVIDENCE SUBSTANTIATING WHO WAS OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION.

(II) ON RECEIPT OF SUBSTANTIATING EVIDENCE FROM THE DISTRICT COURT UNDER SUBPARAGRAPH (I) OF THIS PARAGRAPH, THE AGENCY MAY ISSUE A CITATION AS PROVIDED IN SUBSECTION (E) OF THIS SECTION TO THE PERSON WHO THE EVIDENCE INDICATES WAS OPERATING THE VEHICLE AT THE TIME OF THE VIOLATION.

(III) A CITATION ISSUED UNDER SUBPARAGRAPH (II) OF THIS PARAGRAPH SHALL BE MAILED NOT LATER THAN 2 WEEKS AFTER RECEIPT OF THE EVIDENCE FROM THE DISTRICT COURT.

(H) IF THE CIVIL PENALTY IS NOT PAID AND THE VIOLATION IS NOT CONTESTED, THE ADMINISTRATION MAY REFUSE TO REGISTER OR REREGISTER OR MAY SUSPEND THE REGISTRATION OF THE MOTOR VEHICLE.

(I) A VIOLATION FOR WHICH A CIVIL PENALTY IS IMPOSED UNDER THIS SECTION:

(1) IS NOT A MOVING VIOLATION FOR THE PURPOSE OF ASSESSING POINTS UNDER § 16-402 OF THIS ARTICLE AND MAY NOT BE RECORDED BY THE ADMINISTRATION ON THE DRIVING RECORD OF THE OWNER OR DRIVER OF THE VEHICLE; AND

1           **(2) MAY NOT BE CONSIDERED IN THE PROVISION OF MOTOR VEHICLE**  
2 **INSURANCE COVERAGE.**

3           **(J) IN CONSULTATION WITH LAW ENFORCEMENT AGENCIES, THE CHIEF**  
4 **JUDGE OF THE DISTRICT COURT SHALL ADOPT PROCEDURES FOR THE ISSUANCE**  
5 **OF CITATIONS, TRIALS FOR VIOLATIONS, AND THE COLLECTION OF CIVIL PENALTIES**  
6 **IMPOSED UNDER THIS SECTION.**

7           **(K) (1) AN AGENCY OR AN AGENT OR A CONTRACTOR DESIGNATED BY THE**  
8 **AGENCY SHALL ADMINISTER AND PROCESS CIVIL CITATIONS ISSUED UNDER THIS**  
9 **SECTION IN COORDINATION WITH THE DISTRICT COURT.**

10           **(2) IF A CONTRACTOR IN ANY MANNER OPERATES A CROSSWALK**  
11 **MONITORING SYSTEM OR ADMINISTERS OR PROCESSES CITATIONS GENERATED BY**  
12 **A CROSSWALK MONITORING SYSTEM ON BEHALF OF A LOCAL JURISDICTION, THE**  
13 **CONTRACTOR'S FEE MAY NOT BE CONTINGENT ON A PER-TICKET BASIS ON THE**  
14 **NUMBER OF CITATIONS ISSUED OR PAID.**

15           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
16 October 1, 2026.
