1 AN ACT concerning

2 **Motor Vehicles – Speed Monitoring Systems – Safety Corridors**
3 **(Vulnerable Road User Protection Act of 2026)**

4 FOR the purpose of authorizing the State Highway Administration to implement a program
5 of safety corridor speed monitoring systems for use in areas determined to be of high
6 risk to vulnerable road users; authorizing a local jurisdiction to use speed monitoring
7 systems in safety corridors under certain circumstances; and generally relating to
8 the use of speed monitoring systems in safety corridors.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 That the Laws of Maryland read as follows:

25 **Article – Courts and Judicial Proceedings**

27 Except as provided in § 4–402 of this subtitle, and subject to the venue provisions of
28 Title 6 of this article, the District Court has exclusive original civil jurisdiction in:

29 (13) A proceeding for a civil infraction under § 21–202.1, § 21–704.1, §
30 21–706.1, § 21–707.1, § 21–809, § 21–810, **§ 21–810.1**, § 21–1134, § 22–612, or § 24–111.3
31 of the Transportation Article or § 10–112 of the Criminal Law Article;

33 (a) (1) Except as provided in paragraphs (2) and (3) of this subsection, the
34 court costs in a traffic case, including parking and impounding cases, cases under §
35 21–202.1, § 21–809, § 21–810, **§ 21–810.1**, § 21–1414, or § 24–111.3 of the Transportation

1 Article in which costs are imposed, and cases under § 10–112 of the Criminal Law Article
2 in which costs are imposed:

3 (i) Are \$22.50; and

4 (ii) Shall also be applicable to those cases in which the defendant

13 (e) (1) (i) A citation issued under § 21–202.1, § 21–706.1, § 21–707.1, §
14 21–809, § 21–810, **§ 21–810.1**, § 21–1134, § 22–612, or § 24–111.3 of the Transportation
15 Article shall provide that the person receiving the citation may elect to stand trial by
16 notifying the issuing agency of the person's intention to stand trial at least 5 days before
17 the date of payment as set forth in the citation.

18 (ii) On receipt of the notice to stand trial, the agency shall forward
19 to the District Court having venue a copy of the citation and a copy of the notice from the
20 person who received the citation indicating the person's intention to stand trial.

21 (iii) On receipt thereof, the District Court shall schedule the case for
22 trial and notify the defendant of the trial date under procedures adopted by the Chief Judge
23 of the District Court.

24 (2) (i) A citation issued as the result of any of the following systems or
25 cameras controlled by a political subdivision shall provide that, in an uncontested case, the
26 penalty shall be paid directly to that political subdivision:

- 27 1. A vehicle height monitoring system;
- 28 2. A traffic control signal monitoring system;
- 29 3. A speed monitoring system;
- 30 4. A work zone speed control system;
- 31 5. A stop sign monitoring system;
- 32 6. A school bus monitoring camera;

1 (4) (i) Except as provided in paragraphs (5) and (6) of this subsection,
2 from the fines collected by a political subdivision as a result of violations enforced by speed
3 monitoring systems, work zone speed control systems, stop sign monitoring systems, school
4 bus monitoring cameras, bus lane monitoring systems, or noise abatement monitoring
5 systems, a political subdivision:

6 1. May recover the costs of implementing and administering
7 the speed monitoring systems, work zone speed control systems, stop sign monitoring

10 2. Subject to subparagraphs (ii), (iii), and (iv) of this
11 paragraph, may spend any remaining balance solely for public safety purposes, including
12 pedestrian or highway safety programs.

15 in accordance with § 21–809 [or], § 21–810, **OR § 21–810.1** of the Transportation Article is
16 admissible in a proceeding concerning a civil citation issued under that section for a

19 height monitoring system, traffic control signal monitoring system, speed monitoring

22 monitoring system or a recorded image and any relevant recorded audio produced by a noise

5 subpoena, or court order unless the access or use is for an appropriate traffic enforcement
6 purpose.

16 jurisdiction under this section unless its use is authorized by the governing body of the local
17 jurisdiction by local law enacted after reasonable notice and a public hearing.

18 (v) An ordinance or resolution adopted by the governing body of a
19 local jurisdiction under this paragraph shall provide that, if the local jurisdiction moves or
20 places a mobile or stationary speed monitoring system to or at a location where a speed
21 monitoring system had not previously been moved or placed, the local jurisdiction may not
22 issue a citation for a violation recorded by that speed monitoring system:

23 1. Until signage is installed in accordance with
24 subparagraph (viii) of this paragraph; and

25 2. For at least the first 15 calendar days after the signage is
26 installed.

27 (vi) This section applies to a violation of this subtitle recorded by a
28 speed monitoring system that meets the requirements of this subsection and has been
29 placed:

30 1. In Anne Arundel County, Montgomery County, or Prince
31 George’s County, on a highway in a residential district, as defined in § 21–101 of this title,
32 with a maximum posted speed limit of 35 miles per hour, which speed limit was established
33 using generally accepted traffic engineering practices;

20 (II) SHOWING:

21 1. THE REAR OF A MOTOR VEHICLE;

22 2. AT LEAST TWO TIME-STAMPED IMAGES OF THE
23 MOTOR VEHICLE THAT INCLUDE THE SAME STATIONARY OBJECT NEAR THE MOTOR
24 VEHICLE; AND

25 3. ON AT LEAST ONE IMAGE OR PORTION OF TAPE, A
26 CLEAR AND LEGIBLE IDENTIFICATION OF THE ENTIRE REGISTRATION PLATE
27 NUMBER OF THE MOTOR VEHICLE.

1 (4) “SAFETY CORRIDOR SPEED MONITORING SYSTEM” MEANS A
2 SPEED MONITORING SYSTEM AS DEFINED UNDER § 21-809 OF THIS SUBTITLE THAT
3 IS PLACED AND USED IN A SAFETY CORRIDOR.

4 (5) “SAFETY CORRIDOR SPEED MONITORING SYSTEM OPERATOR”
5 MEANS A REPRESENTATIVE OF THE STATE HIGHWAY ADMINISTRATION OR ITS
6 CONTRACTOR THAT OPERATES A SAFETY CORRIDOR SPEED MONITORING SYSTEM.

7 (6) (I) “VULNERABLE ROAD USER” MEANS AN INDIVIDUAL ON A
8 HIGHWAY WHO IS NOT TRAVELING IN A MOTOR VEHICLE.

9 (II) “VULNERABLE ROAD USER” INCLUDES PEDESTRIANS,
10 BICYCLISTS, OTHER CYCLISTS, PERSONS USING A PERSONAL CONVEYANCE OR A
11 MOBILITY DEVICE SUCH AS A WHEELCHAIR, AND PERSONS ON FOOT IN A HIGHWAY
12 WORK ZONE.

13 (B) (1) (I) A SAFETY CORRIDOR SPEED MONITORING SYSTEM THAT
14 MEETS THE REQUIREMENTS OF THIS SUBSECTION MAY BE AUTHORIZED BY THE
15 STATE HIGHWAY ADMINISTRATION AND USED BY THE STATE HIGHWAY
16 ADMINISTRATION OR ITS CONTRACTOR TO RECORD THE IMAGES OF MOTOR
17 VEHICLES TRAVELING ON A STATE HIGHWAY WITHIN A SAFETY CORRIDOR.

18 (II) THE STATE HIGHWAY ADMINISTRATION MAY ISSUE A
19 PERMIT AUTHORIZING A LOCAL JURISDICTION THAT OPERATES ITS OWN PROGRAM
20 OF SPEED MONITORING SYSTEMS OR WORK ZONE SPEED CONTROL SYSTEMS TO
21 PLACE, IN ACCORDANCE WITH § 21-809 OF THIS SUBTITLE, SAFETY CORRIDOR
22 SPEED MONITORING SYSTEMS ON STATE HIGHWAYS IN SAFETY CORRIDORS WITHIN
23 ITS JURISDICTION.

24 (2) (I) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE
25 USED ONLY IF, IN ACCORDANCE WITH THE MARYLAND MANUAL ON UNIFORM
26 TRAFFIC CONTROL DEVICES, A CONSPICUOUS ROAD SIGN IS PLACED AT A
27 REASONABLE DISTANCE CONSISTENT WITH NATIONAL GUIDELINES BEFORE THE
28 SAFETY CORRIDOR ALERTING DRIVERS THAT A SPEED MONITORING SYSTEM MAY BE
29 IN OPERATION IN THE SAFETY CORRIDOR.

30 (II) A SAFETY CORRIDOR SPEED MONITORING SYSTEM
31 OPERATOR DOES NOT NEED TO BE PRESENT IN PERSON OR REMOTELY AT THE
32 SAFETY CORRIDOR WHEN A SAFETY CORRIDOR SPEED MONITORING SYSTEM IS IN
33 USE.

1 (III) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE
2 A MOBILE UNIT OR A STATIONARY UNIT.

3 (3) A SAFETY CORRIDOR SPEED MONITORING SYSTEM MAY BE USED
4 ONLY TO RECORD THE IMAGES OF VEHICLES THAT ARE TRAVELING AT SPEEDS AT

7 UNDERGO AN ANNUAL CALIBRATION CHECK PERFORMED BY AN INDEPENDENT
8 CALIBRATION LABORATORY.

9 (II) THE INDEPENDENT CALIBRATION LABORATORY SHALL
10 ISSUE A SIGNED CERTIFICATE OF CALIBRATION AFTER THE ANNUAL CALIBRATION
11 CHECK THAT:

12 1. SHALL BE KEPT ON FILE; AND

13 2. SHALL BE ADMITTED AS EVIDENCE IN ANY COURT
14 PROCEEDING FOR A VIOLATION OF THIS SECTION.

15 (5) IF THE STATE HIGHWAY ADMINISTRATION OR ITS CONTRACTOR

15 **(VI) AT LEAST ONE RECORDED IMAGE OF THE VEHICLE WITH A**
16 **DATA BAR IMPRINTED ON THE IMAGE THAT INCLUDES THE SPEED OF THE VEHICLE**
17 **AND THE DATE AND TIME THE IMAGE WAS RECORDED;**

18 **(VII) THE AMOUNT OF THE CIVIL PENALTY IMPOSED AND THE**
19 **DATE BY WHICH THE CIVIL PENALTY MUST BE PAID;**

20 **(VIII) A SIGNED STATEMENT UNDER OATH BY AN AUTHORIZED**
21 **STATE HIGHWAY ADMINISTRATION REPRESENTATIVE OR CONTRACTOR THAT,**
22 **BASED ON INSPECTION OF RECORDED IMAGES, THE MOTOR VEHICLE WAS BEING**

24 **(IX) A STATEMENT THAT RECORDED IMAGES ARE EVIDENCE OF**
25 **A VIOLATION OF THIS SUBTITLE;**

26 **(X) INFORMATION ADVISING THE PERSON ALLEGED TO BE**
27 **LIABLE UNDER THIS SECTION OF THE MANNER AND TIME IN WHICH LIABILITY AS**
28 **ALLEGED IN THE CITATION MAY BE CONTESTED IN THE DISTRICT COURT; AND**

1 **(XI) INFORMATION ADVISING THE PERSON ALLEGED TO BE**
2 **LIABLE UNDER THIS SECTION THAT FAILURE TO PAY THE CIVIL PENALTY OR TO**
3 **CONTEST LIABILITY IN A TIMELY MANNER:**

4 **1. IS AN ADMISSION OF LIABILITY;**

5 **2. MAY RESULT IN THE REFUSAL TO REGISTER THE**
6 **MOTOR VEHICLE; AND**

7 **3. MAY RESULT IN THE SUSPENSION OF THE MOTOR**
8 **VEHICLE REGISTRATION.**

9 **(2) THE STATE HIGHWAY ADMINISTRATION OR ITS CONTRACTOR**
