A BILL ENTITLED

1 AN ACT concerning

2 **Health Occupations – Massage Therapy – Advertising**

3 FOR the purpose of prohibiting licensed massage therapists, registered massage
4 practitioners, and third parties directed by licensed massage therapists or registered
5 massage practitioners from placing, publishing, or distributing certain
6 advertisements; requiring certain advertisements for massage therapy to include
7 certain information; and generally relating to massage therapy advertising.

18 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

19 That the Laws of Maryland read as follows:

20 **Article – Health Occupations**

21 6–308.

22 (a) Subject to the hearing provisions of § 6–309 of this subtitle, the Board may
23 deny a license or registration to an applicant, reprimand a licensee or registration holder,
24 place any licensee or registration holder on probation, or suspend or revoke the license of a

1 licensee or the registration of a registration holder if the applicant, licensee, or registration
2 holder:

3 (11) Has violated any provision of this title;

4 6–401.

5 (a) The Board shall adopt regulations to [establish]:

6 (1) **ESTABLISH** standards for advertising or soliciting by licensed massage
7 therapists or registered massage practitioners;

8 (2) **DEFINE SPECIFIC LANGUAGE AND CONTENT PROHIBITED UNDER**
9 **THIS SECTION; AND**

10 (3) **ESTABLISH PROCEDURES FOR REPORTING VIOLATIONS OF THIS**
11 **SECTION BY A LICENSED MASSAGE THERAPIST, REGISTERED MASSAGE**
12 **PRACTITIONER, OR MEMBER OF THE PUBLIC.**

13 (b) For purposes of this section, the mailing of notices to patients to inform them
14 of times for periodic appointments is not advertising or soliciting.

15 (c) (1) **EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION,**
16 **AN ADVERTISEMENT FOR MASSAGE THERAPY SERVICES SHALL INCLUDE THE FULL**
17 **NAME, AS STATED ON THE LICENSE OR REGISTRATION APPLICATION SUBMITTED TO**
18 **THE BOARD, AND LICENSE NUMBER OR REGISTRATION NUMBER OF THE LICENSED**
19 **MASSAGE THERAPIST OR REGISTERED MASSAGE PRACTITIONER PROVIDING THE**
20 **MASSAGE THERAPY SERVICES ADVERTISED.**

21 (2) **AN ADVERTISEMENT FOR MASSAGE THERAPY SERVICES PLACED,**
22 **PUBLISHED, OR DISTRIBUTED BY A BUSINESS THAT EMPLOYS OR CONTRACTS WITH**
23 **MULTIPLE LICENSED MASSAGE THERAPISTS OR REGISTERED MASSAGE**
24 **PRACTITIONERS IS NOT REQUIRED TO INCLUDE THE NAMES AND LICENSE OR**
25 **REGISTRATION NUMBERS OF EACH LICENSED MASSAGE THERAPIST OR REGISTERED**
26 **MASSAGE PRACTITIONER EMPLOYED OR CONTRACTED WITH.**

27 [(c)] (d) [A] **SUBJECT TO SUBSECTION (C) OF THIS SECTION, A licensed**
28 **massage therapist or registered massage practitioner may use a trade name in connection**
29 **with the practice of massage therapy provided that:**

30 (1) The use of the trade name is not deceptive or misleading;

31 (2) The advertisement in which the trade name appears includes the name
32 of the licensed massage therapist or registered massage practitioner or the name of the
33 business entity providing the massage therapy services being advertised, as long as the

1 advertisement includes the name of a licensed massage therapist or registered massage
2 practitioner;

3 (3) The name of the licensed massage therapist or registered massage
4 practitioner providing massage therapy services appears on the billing invoices, stationery,
5 and any receipt given to a patient; and

6 (4) Treatment records are maintained that clearly identify the licensed
7 massage therapist or registered massage practitioner who has performed the massage
8 therapy service for the patient.

9 (E) (1) A LICENSED MASSAGE THERAPIST, REGISTERED MASSAGE
10 PRACTITIONER, OR A THIRD PARTY ACTING ON BEHALF OF A LICENSED MASSAGE
11 THERAPIST OR REGISTERED MASSAGE PRACTITIONER MAY NOT PLACE, PUBLISH, OR
12 DISTRIBUTE, OR CAUSE TO BE PLACED, PUBLISHED, OR DISTRIBUTED, AN
13 ADVERTISEMENT FOR MASSAGE THERAPY SERVICES:

14 (I) THAT STATES PROSTITUTION SERVICES, ESCORT SERVICES,
15 OR SEXUAL SERVICES ARE AVAILABLE;

16 (II) ON A WEBSITE KNOWN FOR ADVERTISING PROSTITUTION
17 SERVICES, ESCORT SERVICES, OR SEXUAL SERVICES; OR

18 (III) THAT INDICATES OR IMPLIES, THROUGH LANGUAGE OR
19 OTHER CONTENT, THAT SEXUAL ACTIVITY IS PART OF THE MASSAGE THERAPY
20 SERVICE.

21 (2) FOR AN ONLINE ADVERTISEMENT, EACH DAY ON WHICH AN
22 ADVERTISEMENT THAT VIOLATES PARAGRAPH (1) OF THIS SUBSECTION IS VISIBLE
23 TO THE PUBLIC CONSTITUTES A SEPARATE VIOLATION OF THIS SECTION.

24 (3) FAILURE TO REMOVE A PHYSICAL SIGN OR BILLBOARD PLACED IN
25 PUBLIC VIEW THAT VIOLATES PARAGRAPH (1) OF THIS SUBSECTION CONSTITUTES A
26 VIOLATION OF THIS SECTION.

27 (F) ALL ADVERTISEMENTS FOR LICENSED MASSAGE THERAPISTS OR
28 REGISTERED MASSAGE PRACTITIONERS SHALL INCLUDE THE FULL NAME AS
29 LICENSED AND LICENSE NUMBER OF THE LICENSED MASSAGE THERAPIST OR
30 REGISTERED MASSAGE PRACTITIONER PROVIDING THE ADVERTISED MASSAGE
31 THERAPY SERVICES.

32 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
33 October 1, 2026.
