A BILL ENTITLED

1 AN ACT concerning

2 **Somerset County Board of Education – Alterations**

3 FOR the purpose of altering certain provisions of law with respect to the Somerset County
4 Board of Education regarding student members, appointments to fill certain
5 vacancies, annual compensation, and actions authorized during executive sessions;
6 and generally relating to the Somerset County Board of Education.

7 BY repealing and reenacting, with amendments,

8 Article – Education

9 Section 3–1201, 3–1203, and 3–1204

10 Annotated Code of Maryland

11 (2025 Replacement Volume and 2025 Supplement)

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

13 That the Laws of Maryland read as follows:

14 **Article – Education**

15 3–1201.

16 (a) The Somerset County Board [shall be elected and] consists of [one]:

17 (1) ONE member elected from each commissioner district in the county;

18 AND

19 (2) ONE NONVOTING STUDENT MEMBER FROM EACH PUBLIC HIGH
20 SCHOOL IN THE COUNTY SELECTED IN ACCORDANCE WITH SUBSECTION (F) OF THIS
21 SECTION.

EXPLANATION: CAPITALS INDICATE MATTER ADDED TO EXISTING LAW.

[Brackets] indicate matter deleted from existing law.



(3) A member from a commissioner district who no longer resides in that district may not continue as a member of the county board.

10 (d) (1) [Subject] EXCEPT AS PROVIDED IN SUBSECTION (F) OF THIS
11 SECTION, AND SUBJECT to the provisions of paragraph (2) of this subsection, each member
12 serves for a term of 4 years beginning on January 1 after the member's election and until a
13 successor is elected and qualifies.

14 (2) (i) The terms of members are staggered as provided in this
15 paragraph.

16 (ii) 1. The members elected at the 2004 election from
17 commissioner districts 1, 3, and 5 shall serve an initial term of 2 years.

(iii) 1. The members elected at the 2004 election from commissioner districts 2 and 4 shall serve an initial term of 4 years.

27 (e) (1) The State Board may remove a member of the county board for:

28 (i) Immorality;

29 (ii) Misconduct in office;

30 (iii) Incompetency; or

31 (iv) Willful neglect of duty.

4 (3) If the member requests a hearing within the 10-day period:

(ii) The member shall have an opportunity to be heard publicly before the State Board in his own defense, in person or by counsel.

(4) A member removed under this subsection has the right to a de novo review of the removal by the Circuit Court for Somerset County.

(F) (1) A STUDENT MEMBER SHALL:

17 (II) SERVE FOR 1 YEAR BEGINNING ON JULY 1 AFTER THE
18 ELECTION OF THE MEMBER;

19 (III) BE A NONVOTING MEMBER; AND

20 (IV) ADVISE THE COUNTY BOARD ON THE INTERESTS OF
21 STUDENTS

26 (a) Annual compensation for the board is as follows:

27 (1) Chairman – [\$3,000] **\$6,000**; and

28 (2) Member - [\$2,700] **\$5,000.**

29 (b) The chairman and other **NONSTUDENT** members are entitled to:

(2) \$500 per member per year for expenses incurred in official duties performed within Somerset County.

5 (C) A STUDENT MEMBER WHO COMPLETES A FULL TERM ON THE COUNTY
6 BOARD SHALL BE GRANTED A SCHOLARSHIP OF \$5,000 TO BE APPLIED TOWARD THE
7 STUDENT'S HIGHER EDUCATION COSTS.

9 (a) [All] EXCEPT FOR THOSE ACTIONS AUTHORIZED BY SUBSECTION (C) OF
10 THIS SECTION, ALL final actions of the county board shall be taken at a public meeting.

11 (B) The board shall keep a formal record of each public meeting.

12 [b] This section does not prohibit the board from meeting and deliberating in
13 executive session provided that all action is taken at a public meeting.]

14 (C) THE COUNTY BOARD MAY TAKE ACTIONS IN EXECUTIVE SESSION IN
15 ACCORDANCE WITH § 3-305 OF THE GENERAL PROVISIONS ARTICLE.

16 SECTION 2. AND BE IT FURTHER ENACTED, That, in accordance with Article
17 III, § 35 of the Maryland Constitution, this Act may not be construed to extend or apply to
18 the salary or compensation of a member of the Somerset County Board of Education while
19 serving in a term of office beginning before the effective date of this Act, but the provisions
20 of this Act concerning the salary or compensation of the members of the Somerset County
21 Board of Education shall take effect at the beginning of the next following term of office.
22 This limitation does not apply to an individual appointed or elected after the effective date
23 of this Act to fill out an unexpired term.

24 SECTION 3. AND BE IT FURTHER ENACTED, That this Act is an emergency
25 measure, is necessary for the immediate preservation of the public health or safety, has
26 been passed by a yea and nay vote supported by three-fifths of all the members elected to
27 each of the two Houses of the General Assembly, and shall take effect from the date it is
28 enacted.
