8 manner; requiring the Department, ~~when issuing a certain permit, to protect certain~~  
9 ~~vernal pools that are located within the geographic area covered by the permit of~~  
10 Natural Resources to create and maintain a certain list of vernal pools in the State  
11 in a certain manner; requiring the Department of the Environment to designate staff  
12 to receive training in vernal pool identification and to notify the Department of

~~WHEREAS, Vernal pools are unique, small-scale ecosystems that contribute significantly to the biodiversity of Maryland by providing habitat for species that cannot reproduce in alternative habitats, including the wood frog, mole salamanders, and fairy shrimp; and~~

~~WHEREAS, Vernal pools provide a significant amount of ecosystem services as they occur frequently throughout Maryland and have the capacity to replenish groundwater and filter stormwater flows; and~~

~~WHEREAS, Nontidal wetlands that meet the three federal wetland delineation criteria of hydrology, hydric soils, and hydrophytic vegetation, including vernal pools that satisfy those criteria, are regulated and protected by the State; and~~

~~WHEREAS, Vernal pools that do not meet all three federal wetland delineation criteria are not afforded the regulatory protections applicable to nontidal wetlands in the State and may suffer impairments or losses without regulatory review or approval; now, therefore,~~

## Article – Natural Resources

### 1-1002.

**(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.**

**(2) "FACULTATIVE SPECIES" MEANS AN ANIMAL SPECIES THAT USES VERNAL POOLS IRREGULARLY.**

**(3) "OBLIGATE SPECIES" MEANS AN ANIMAL SPECIES THAT DEPENDS ON VERNAL POOLS AS A NECESSARY PART OF ITS LIFE CYCLE.**

**(4) "TYPICAL YEAR" MEANS A YEAR IN WHICH RAINFALL TOTALS MEET OR EXCEED THE AVERAGE YEARLY RAINFALL FROM THE PREVIOUS 30 YEARS FOR THE LOCATION WITHIN WHICH THE VERNAL POOL IS LOCATED.**

**(5) "VERNAL POOL" MEANS A CONFINED DEPRESSION THAT:**

**(i) HAS SURFACE WATER FOR AT LEAST 2 CONSECUTIVE MONTHS BETWEEN NOVEMBER AND MAY IN A TYPICAL YEAR;**

**(ii) EXPERIENCES A DECREASE IN WATER LEVEL TO 6 INCHES OR LESS BETWEEN JUNE AND SEPTEMBER IN A TYPICAL YEAR;**

**(iii) PROVIDES A PERSISTENT OR BREEDING HABITAT FOR VARIOUS ANIMAL SPECIES, INCLUDING NATIVE AMPHIBIANS AND INVERTEBRATES THAT ARE FACULTATIVE SPECIES OR OBLIGATE SPECIES;**

**(iv) CONTAINS LESS THAN 30% AERIAL COVER OF EMERGENT VEGETATION WHEN FULL;**

**(v) IS PREDOMINANTLY OR PARTIALLY SHADED BY WOODY VEGETATION;**

1           **(VI) IS LESS THAN 5 ACRES IN SIZE; AND**

2           **(VII) MAY HAVE INTERMITTENT, TEMPORARY CONNECTIONS TO**  
3 **OTHER BODIES OF WATER.**

4           **(B) THE DEPARTMENT SHALL:**

5           **(1) IN COORDINATION WITH THE DEPARTMENT OF THE**  
6 **ENVIRONMENT, CREATE AND MAINTAIN A LIST OF VERNAL POOLS IN THE STATE;**

7           **(2) ESTABLISH CRITERIA AND PROCEDURES FOR IDENTIFYING AND**  
8 **INCLUDING VERNAL POOLS ON THE LIST, INCLUDING:**

9           **(I) VERNAL POOLS IDENTIFIED BY THE DEPARTMENT IN**  
10 **CARRYING OUT ITS DUTIES SET FORTH IN THIS ARTICLE;**

11           **(II) LOCATIONS THE DEPARTMENT DETERMINES MEET THE**  
12 **DEFINITION OF A VERNAL POOL UNDER SUBSECTION (A) OF THIS SECTION; AND**

13           **(III) VERNAL POOLS IDENTIFIED BY THE DEPARTMENT OF THE**  
14 **ENVIRONMENT IN ACCORDANCE WITH SUBSECTION (C) OF THIS SECTION;**

20 **UNIVERSITY OF MARYLAND, TO IDENTIFY VERNAL POOLS FOR INCLUSION ON THE**  
21 **LIST; AND**

22           **(4) PROVIDE FOR PUBLICATION OF THE LIST OF VERNAL POOLS ON**  
23 **THE DEPARTMENT'S WEBSITE.**

24           **(C) (1) THE DEPARTMENT OF THE ENVIRONMENT SHALL DESIGNATE**  
25 **STAFF TO RECEIVE TRAINING IN VERNAL POOL IDENTIFICATION.**

26           **(2) THE DEPARTMENT SHALL PROVIDE VERNAL POOL**  
27 **IDENTIFICATION TRAINING TO THE STAFF DESIGNATED UNDER PARAGRAPH (1) OF**  
28 **THIS SUBSECTION.**

29           **(3) IF, IN CARRYING OUT RESPONSIBILITIES UNDER TITLE 5,**  
30 **SUBTITLE 9 OF THE ENVIRONMENT ARTICLE, STAFF TRAINED UNDER THIS**

1 SUBSECTION IDENTIFY A LOCATION THAT MAY QUALIFY AS A VERNAL POOL, THE  
2 DEPARTMENT OF THE ENVIRONMENT SHALL NOTIFY THE DEPARTMENT OF THE  
3 LOCATION FOR POSSIBLE INCLUSION ON THE LIST ESTABLISHED UNDER  
4 SUBSECTION (B) OF THIS SECTION.

5 (4) NOTHING IN THIS SECTION SHALL BE CONSTRUED TO LIMIT THE  
6 AUTHORITY OF THE DEPARTMENT OF THE ENVIRONMENT TO REGULATE VERNAL  
7 POOLS THAT MEET THE DEFINITION OF NONTIDAL WETLANDS UNDER TITLE 5,  
8 SUBTITLE 9 OF THE ENVIRONMENT ARTICLE.

9 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
10 October 1, 2026.
