4 FOR the purpose of requiring certain research facilities to pay contributions for the  
5 Human–Relevant Research Fund to the Department of Agriculture, rather than the  
6 Maryland Department of Health; and generally relating to the Human–Relevant  
7 Research Fund.

8 IN THIS SUBTITLE, “ANIMAL AND PLANT HEALTH INSPECTION SERVICE  
9 FORM 7023” MEANS THE FORM REQUIRED TO BE SUBMITTED TO THE FEDERAL  
10 DEPARTMENT OF AGRICULTURE UNDER 7 U.S.C. § 2143 AND 9 C.F.R. § 2.36.

11 **2–2502.**

12 (A) ON OR BEFORE JANUARY 15 EACH YEAR, BEGINNING IN 2024, EACH  
13 RESEARCH FACILITY THAT IS LOCATED IN THE STATE AND IS REQUIRED TO SUBMIT  
14 AN ANIMAL AND PLANT HEALTH INSPECTION SERVICE FORM 7023 SHALL PAY TO  
15 THE DEPARTMENT A CONTRIBUTION IN THE AMOUNT OF:

16 (1) \$5,000 FOR UP TO 100 ANIMALS;

17 (2) \$10,000 FOR MORE THAN 100 BUT NOT MORE THAN 500 ANIMALS;

18 (3) \$55,000 FOR MORE THAN 500 BUT NOT MORE THAN 5,000  
19 ANIMALS; AND

20 (4) \$75,000 FOR MORE THAN 5,000 ANIMALS.

21 (B) THE AMOUNT OF THE CONTRIBUTION TO BE PAID UNDER SUBSECTION  
22 (A) OF THIS SECTION SHALL BE BASED ON THE TOTAL NUMBER OF ANIMALS  
23 REPORTED IN COLUMN F ON THE MOST RECENTLY SUBMITTED ANIMAL AND PLANT  
24 HEALTH INSPECTION SERVICE FORM 7023.

25 (C) THE SECRETARY SHALL DISTRIBUTE THE FUNDS PAID UNDER  
26 SUBSECTION (A) OF THIS SECTION TO THE HUMAN–RELEVANT RESEARCH FUND  
27 ESTABLISHED UNDER § 10–4D–02 OF THE ECONOMIC DEVELOPMENT ARTICLE.

28 **2–2503.**

1           **A RESEARCH FACILITY THAT FAILS TO PAY THE CONTRIBUTION REQUIRED**  
2 **UNDER § 2-2502(A) OF THIS SUBTITLE MAY BE SUBJECT TO A CIVIL PENALTY OF NOT**  
3 **MORE THAN \$1,000 PER DAY.**

4           SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect  
5 October 1, 2026.
