A BILL ENTITLED

1 AN ACT concerning

2 **On-Farm Organics and Wasted Food Reduction and Diversion Grant**
3 **Programs – Established**

4 FOR the purpose of establishing the On-Farm Organics Diversion and Recycling Grant
5 Program in the Department of Agriculture to award grants to eligible entities to
6 develop and implement on-farm organics recycling and compost use, wasted food
7 prevention, and food rescue; establishing the Wasted Food Reduction and Diversion
8 Grant Program and the County Wasted Food Reduction Block Grant Program in the
9 Department of the Environment to award grants and fund certain projects for
10 infrastructure, programs, and education that reduce, rescue, and divert wasted food
11 in the State and certain counties; and generally relating to wasted food reduction
12 and diversion in the State.

(x) Hazardous waste proximity;

(xi) Wastewater discharge indicator;

(xii) Proximity to a Concentrated Animal Feeding Operation (CAFO);

(xiii) Percent of the population lacking broadband coverage:
