SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
That the Laws of Maryland read as follows:

(A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS INDICATED.

(2) “LOCAL SOURCE” MEANS A BUSINESS ENTITY THAT:

(I) IS HEADQUARTERED IN THE STATE; OR

(II) HAS A PRINCIPAL PLACE OF BUSINESS LOCATED IN THE STATE.

(3) “PORTAL” MEANS THE MARYLAND LOCAL SOURCING PORTAL.

(4) “TARIFF-IMPACTED GOODS” MEANS COMMODITIES, SUPPLIES, OR RAW MATERIALS IDENTIFIED BY THE SECRETARY AS SUBJECT TO FEDERAL IMPORT DUTIES OR TRADE VOLATILITY.

(B) (1) THE DEPARTMENT SHALL DEVELOP AND MAINTAIN A SEARCHABLE ONLINE DATABASE, TO BE KNOWN AS THE MARYLAND LOCAL

1 **SOURCING PORTAL, TO CONNECT BUSINESSES IN THE STATE WITH LOCAL SOURCES**
2 **FOR TARIFF-IMPACTED GOODS AND OTHER SUPPLIES.**

3 **(2) THE PORTAL SHALL BE SEARCHABLE BY NORTH AMERICAN**
4 **INDUSTRY CLASSIFICATION SYSTEM CODES.**

5 **(3) THE PORTAL SHALL COMPLY WITH:**

6 **(I) STATE AND FEDERAL ACCESSIBILITY STANDARDS FOR**
7 **DIGITAL CONTENT; AND**

8 **(II) THE DATA MINIMIZATION AND SECURITY STANDARDS OF**
9 **THE MARYLAND ONLINE DATA PRIVACY ACT.**

10 **(C) (1) PARTICIPATION IN THE PORTAL BY A LOCAL SOURCE SHALL BE**
11 **VOLUNTARY.**

12 **(2) THE PORTAL SHALL ENABLE A LOCAL SOURCE TO LIST:**

13 **(I) THE CATEGORIES OF SUPPLIES OR INVENTORY HELD IN THE**
14 **STATE; AND**

15 **(II) A STATUS INDICATOR SIGNIFYING THAT INVENTORY IS**
16 **CURRENTLY AVAILABLE FOR PURCHASE.**

17 **(3) THE PORTAL IS NOT REQUIRED TO DISPLAY SPECIFIC**
18 **QUANTITIES OR PROPRIETARY STOCK LEVELS.**

19 **(D) THE DEPARTMENT MAY COORDINATE WITH THE STATE DEPARTMENT**
20 **OF ASSESSMENTS AND TAXATION, THE OFFICE OF THE COMPTROLLER, AND THE**
21 **DEPARTMENT OF INFORMATION TECHNOLOGY TO:**

22 **(1) IDENTIFY POTENTIAL LOCAL SOURCES FOR INCLUSION IN THE**
23 **PORTAL; AND**

24 **(2) LEVERAGE EXISTING DIGITAL INFRASTRUCTURE TO MINIMIZE**
25 **THE COST OF DEVELOPING AND MAINTAINING THE PORTAL.**

26 **(E) THE STATE, THE DEPARTMENT, AND THEIR EMPLOYEES SHALL BE**
27 **HELD HARMLESS FOR ANY CLAIMS, DAMAGES, OR LOSSES ARISING FROM:**

28 **(1) THE ACCURACY OR TIMELINESS OF DATA SUBMITTED BY A**
29 **VOLUNTARY PARTICIPANT; OR**

1 **(2) ANY TRANSACTION OR AGREEMENT ENTERED INTO BETWEEN**
2 **PRIVATE PARTIES USING THE PORTAL.**

3 **(F) ON OR BEFORE DECEMBER 31 EACH YEAR, THE DEPARTMENT SHALL**
4 **REPORT TO THE GENERAL ASSEMBLY, IN ACCORDANCE WITH § 2-1257 OF THE**
5 **STATE GOVERNMENT ARTICLE, ON THE USE AND EFFECTIVENESS OF THE PORTAL.**

6 SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect
7 October 1, 2026. It shall remain effective for a period of 5 years and, at the end of September
8 30, 2031, this Act, with no further action required by the General Assembly, shall be
9 abrogated and of no further force and effect.
