1 AN ACT concerning

2 **Alcohol, Tobacco, and Cannabis Commission – Unauthorized Consumable**
3 **Products – Enforcement and Seizure**

4 FOR the purpose of altering the violations of law with respect to which the Field
5 Enforcement Division of the Alcohol, Tobacco, and Cannabis Commission is
6 authorized to issue a citation or charging document; prohibiting a retailer from
7 distributing, selling, exposing for sale, or advertising for sale unauthorized
8 consumable products; authorizing the Executive Director of the Commission to seize,
9 confiscate, or destroy unauthorized consumable products and certain other products;
10 establishing and repealing certain provisions governing the enforcement of certain
11 prohibitions related to unauthorized consumable products; requiring the Maryland
12 Department of Health to report certain changes related to unauthorized consumable
13 products to the Alcohol, Tobacco, and Cannabis Commission within a certain time;
14 and generally relating to enforcement and seizure of unauthorized consumable
15 products by the Alcohol, Tobacco, and Cannabis Commission.

8 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
9 That the Laws of Maryland read as follows:

12 (a) There is a Field Enforcement Division in the Office of the Executive Director.

13 (b) (1) The Field Enforcement Division may employ officers and employees as
14 provided in the State budget.

15 (2) The officers and employees of the Field Enforcement Division:

16 (i) shall be sworn police officers;

17 (ii) shall have the powers, duties, and responsibilities of peace
18 officers to enforce the provisions of this article relating to:

19 1. the unlawful importation of alcoholic beverages, tobacco,
20 and cannabis into the State;

21 2. the unlawful manufacture of alcoholic beverages, tobacco,
22 and cannabis in the State;

23 3. the transportation and distribution throughout the State
24 of alcoholic beverages, tobacco, and cannabis that are manufactured illegally and on which
25 any alcoholic beverages taxes, tobacco taxes, or cannabis taxes imposed by the State are
26 due and unpaid; and

27 4. the manufacture, sale, barter, transportation,
28 distribution, or other form of owning, handling, or dispersing alcoholic beverages, tobacco,
29 or cannabis by any person not licensed or authorized under this article, provisions of the
30 Tax – General Article relating to alcoholic beverages, tobacco, or cannabis, or provisions of
31 the Business Regulation Article relating to alcoholic beverages, tobacco, or cannabis;

32 (iii) may issue a citation or other charging document to a person who
33 has committed a violation of [§ 10–108]:

- 1 1. SECTION 10–108 of the Criminal Law Article;
- 2 2. **TITLE 21, SUBTITLE 2D OF THE HEALTH – GENERAL**
- 3 **ARTICLE;**
- 4 3. **TITLE 21, SUBTITLE 2E OF THE HEALTH – GENERAL**
- 5 **ARTICLE; AND**
- 6 4. **TITLE 21, SUBTITLE 2F OF THE HEALTH – GENERAL**
- 7 **ARTICLE; and**

8 (iv) may make cooperative arrangements for and work and cooperate

9 with the Office of the Comptroller, local State’s Attorneys, sheriffs, bailiffs, police, and other

10 prosecuting and peace officers to enforce this article.

11 (c) The Field Enforcement Division:

12 (1) shall consult with and advise the local State’s Attorneys and other law

13 enforcement officials and police officers regarding enforcement problems in their respective

14 jurisdictions; and

15 (2) may recommend changes to improve the administration of this article,

17 cannabis, and provisions of the Business Regulation Article relating to tobacco.

3 sold, manufactured, stored, or transported in violation of this article:

4 (1) are subject to seizure and forfeiture; and

5 (2) when seized, may be recovered or disposed of only as provided in this
6 subtitle.

7 (b) Property is forfeited if it:

8 (1) was seized as contraband in the possession or control of a defendant
9 who is found guilty of violating this article; [or]

10 (2) is otherwise found to be contraband or in violation of this article; **OR**

12 (3) [On an outdoor billboard or sign board that is within 500 feet of a
13 school] **BY PLACING AN ADVERTISEMENT FOR KRATOM ON THE SIDE OF A BUILDING**
14 **OR ANOTHER PUBLICLY VISIBLE LOCATION OF ANY FORM, INCLUDING A SIGN, A**
15 **POSTER, A PLACARD, A DEVICE, A GRAPHIC DISPLAY, AN OUTDOOR BILLBOARD, OR**
16 **A FREESTANDING SIGNBOARD.**

15 (7) An image of an individual who appears to be under the age of 27 years;
16 **AND**

17 **(8) OTHER IMAGES, GRAPHICS, OR FEATURES OR LIKENESSES TO**
18 **IMAGES, GRAPHICS, OR FEATURES THAT ARE POPULARLY USED TO ADVERTISE TO**
19 **CHILDREN, INCLUDING:**

20 **(I) NEON COLORS, SIGNS, OR OTHER BRIGHTLY COLORED**
21 **DISPLAYS;**

22 **(II) ANIMALS;**

23 **(III) MASCOTS; OR**

24 **(IV) STATEMENTS, ARTWORK, OR DESIGNS THAT COULD**
25 **REASONABLY MISLEAD AN INDIVIDUAL TO BELIEVE THAT THE PACKAGE CONTAINS**
26 **ANYTHING OTHER THAN A PHENIBUT PRODUCT.**

27 (d) It is a violation of subsection (b) of this section for a retailer to advertise or
28 promote a phenibut product:

1 (1) In a newspaper, a magazine, a periodical, or any other publication for
 2 which individuals under the age of 21 years constitute 15% or more of the total audience,
 3 as measured by competent and reliable survey evidence;

4 (2) At a concert, a stadium, a sporting event, or any other public event for
 5 which individuals under the age of 21 years constitute 15% or more of the total audience,
 6 as measured by competent and reliable survey evidence; or

7 (3) [On an outdoor billboard or sign board that is within 500 feet of a
 8 school] **BY PLACING AN ADVERTISEMENT FOR ~~KRATOM~~ PHENIBUT ON THE SIDE OF A**
 9 **BUILDING OR ANOTHER PUBLICLY VISIBLE LOCATION OF ANY FORM, INCLUDING A**
 10 **SIGN, A POSTER, A PLACARD, A DEVICE, A GRAPHIC DISPLAY, AN OUTDOOR**
 11 **BILLBOARD, OR A FREESTANDING SIGNBOARD.**

12 **(E) A RETAILER THAT VIOLATES THIS SECTION IS GUILTY OF A**
 13 **MISDEMEANOR AND ON CONVICTION IS SUBJECT TO A FINE NOT EXCEEDING \$5,000,**
 14 **IMPRISONMENT FOR NOT MORE THAN 90 DAYS, OR BOTH.**

15 SECTION 2. AND BE IT FURTHER ENACTED, That the Maryland Department of
 16 Health shall notify the Alcohol, Tobacco, and Cannabis Commission within 30 days after a
 17 change is made in the regulatory or approval status of kratom products, tianeptine
 18 products, phenibut products, or any other product designated by the Secretary of Health as
 19 an unauthorized consumable product for enforcement by the Executive Director of the
 20 Alcohol, Tobacco, and Cannabis Commission.

21 SECTION 3. AND BE IT FURTHER ENACTED, That this Act shall take effect July
 22 1, 2026.
