A BILL ENTITLED

1 AN ACT concerning

2 **Election Districts – General Assembly and Representatives in Congress**

3 FOR the purpose of clarifying that certain requirements apply only to districts for the
4 election of members of the Senate of Maryland and the House of Delegates;
5 authorizing the General Assembly to grant original jurisdiction to the Supreme
6 Court of Maryland to review the congressional districting of the State; altering
7 districts for the election of Representatives in Congress for certain elections; and
8 generally relating to election districts.

23 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,
24 (Three–fifths of all the members elected to each of the two Houses concurring), That it be
25 proposed that the Maryland Constitution read as follows:

Article III – Legislative Department

4.

Each legislative district **FOR THE ELECTION OF A MEMBER OF THE SENATE AND MEMBERS OF THE HOUSE OF DELEGATES** shall consist of adjoining territory, be compact in form, and of substantially equal population. Due regard shall be given to natural boundaries and the boundaries of political subdivisions.

THE GENERAL ASSEMBLY SHALL HAVE THE POWER TO GRANT ORIGINAL JURISDICTION TO THE SUPREME COURT OF MARYLAND TO REVIEW THE CONGRESSIONAL DISTRICTING OF THE STATE.

Article XVIII – Provisions of Limited Duration**6.**

(A) (1) THIS SECTION SHALL APPLY ONLY TO ELECTIONS FOR THE STATE’S REPRESENTATIVES IN CONGRESS THAT ARE HELD AFTER THE STATEWIDE GENERAL ELECTION HELD IN 2026 AND BEFORE THE EFFECTIVE DATE OF LEGISLATION ESTABLISHING DISTRICTS FOR THE ELECTION OF THE STATE’S REPRESENTATIVES IN CONGRESS FOLLOWING THE 2030 DECENNIAL CENSUS.

(2) THIS SECTION TEMPORARILY IS PART OF ARTICLE III – LEGISLATIVE DEPARTMENT, SECTION 49 OF THE CONSTITUTION.

(3) THIS SECTION SHALL EXPIRE ON THE EFFECTIVE DATE OF LEGISLATION ESTABLISHING DISTRICTS FOR THE ELECTION OF THE STATE’S REPRESENTATIVES IN CONGRESS FOLLOWING THE 2030 DECENNIAL CENSUS.

(B) THE STATE IS DIVIDED INTO EIGHT DISTRICTS FOR THE ELECTION OF THE STATE’S REPRESENTATIVES IN CONGRESS.

23 SECTION 3. AND BE IT FURTHER ENACTED, That the General Assembly

(b) (1) At that general election, the vote on the proposed amendment to the Constitution shall be by ballot, and on each ballot there shall be printed the words “For the Constitutional Amendment” and “Against the Constitutional Amendment”, as now provided by law.

(2) At that general election, a question substantially similar to the following shall be submitted to the qualified voters of the State:

“Question ____ – Constitutional Amendment

The proposed Constitutional Amendment enacts a Congressional Districting Plan for use beginning after the 2026 election and until a new Congressional Districting Plan takes effect after the 2030 census; and authorizes the General Assembly to grant original jurisdiction to the Supreme Court of Maryland to review the congressional districting of the State; and clarifies that certain standards in the Maryland Constitution apply only to districts used to elect members of the General Assembly.”.

(c) Immediately after the election, all returns shall be made to the Governor of the vote for and against the proposed amendment, as directed by Article XIV of the Maryland Constitution, and further proceedings held in accordance with Article XIV.

SECTION 5. AND BE IT FURTHER ENACTED, That Section 2 of this Act is contingent on the passage of Section 1 of this Act, a constitutional amendment, and its ratification by voters of the State.

SECTION 6. AND BE IT FURTHER ENACTED, That, subject to Section 5 of this Act, Section 2 of this Act shall take effect on the proclamation of the Governor that the constitutional amendment, having received a majority of the votes cast at the general election has been adopted by the people of Maryland.
