## A BILL ENTITLED

1 AN ACT concerning

2 **Firearms Dealers – Firearm Hold Agreements**

3 FOR the purpose of providing that a certain federally licensed firearms dealer may not be  
4 held civilly liable for personal injury to or death of any person after the return of a  
5 certain firearm to a certain firearm owner at the termination of a certain agreement,  
6 with a certain exception; and generally relating to firearms dealers.

12 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,  
13 That the Laws of Maryland read as follows:

14 **Article – Public Safety**

15 **5–149.**

16 (A) (1) IN THIS SECTION THE FOLLOWING WORDS HAVE THE MEANINGS  
17 INDICATED.

18 (2) “FEDERALLY LICENSED FIREARMS DEALER” HAS THE MEANING  
19 STATED IN § 5–701 OF THIS TITLE.

20 (3) “FIREARM HOLD AGREEMENT” MEANS A PRIVATE AGREEMENT  
21 BETWEEN A FEDERALLY LICENSED FIREARMS DEALER AND A PERSON WHO OWNS A  
22 FIREARM IN WHICH THE FEDERALLY LICENSED FIREARMS DEALER:

1                   **(I) TAKES PHYSICAL POSSESSION OF THE FIREARM OWNER'S**  
2 **LAWFULLY POSSESSED FIREARM OR FIREARMS AT THE FIREARM OWNER'S**  
3 **REQUEST;**

4                   **(II) HOLDS THE FIREARM OR FIREARMS FOR AN AGREED**  
5 **PERIOD OF TIME; AND**

6                   **(III) RETURNS THE FIREARM OR FIREARMS TO THE FIREARM**  
7 **OWNER IN ACCORDANCE WITH THE TERMS OF THE AGREEMENT.**

8           **(B) THIS SECTION DOES NOT APPLY TO FIREARM TRANSFERS IN**  
9 **ACCORDANCE WITH § 6-234 OF THE CRIMINAL PROCEDURE ARTICLE.**

10           **(C) (1) EXCEPT AS PROVIDED IN PARAGRAPH (2) OF THIS SUBSECTION, A**  
11 **FEDERALLY LICENSED FIREARMS DEALER MAY NOT BE HELD CIVILLY LIABLE FOR**  
12 **PERSONAL INJURY TO OR DEATH OF ANY PERSON AFTER THE RETURN OF A FIREARM**  
13 **TO A FIREARM OWNER BY THE FEDERALLY LICENSED FIREARMS DEALER AT THE**  
14 **TERMINATION OF A FIREARM HOLD AGREEMENT.**

15                   **(2) THE IMMUNITY FROM LIABILITY PROVIDED UNDER PARAGRAPH**  
16 **(1) OF THIS SUBSECTION DOES NOT APPLY TO PERSONAL INJURY OR DEATH CAUSED**  
17 **BY UNLAWFUL CONDUCT ON THE PART OF THE FEDERALLY LICENSED FIREARMS**  
18 **DEALER.**

19           SECTION 2. AND BE IT FURTHER ENACTED, That this Act shall take effect  
20 October 1, 2026.
