3 FOR the purpose of ~~requiring a county board of education that seeks to enter into a service~~
4 ~~contract to submit to the State Department of Education certain information to~~
5 ~~justify the need for the service contract, and to submit a certain plan of assistance~~
6 ~~for employees adversely affected by the service contract,~~ requiring, on or before a
7 certain date, the State Department of Education to design and develop a new system
8 of professional development in public schools for paraeducators and other education
9 support professionals; ~~requiring, on or before a certain date, each county board to~~
10 ~~provide the new system of professional development to each paraeducator and~~
11 ~~education support professional employed in a public school in the county;~~ and
12 generally relating to ~~public school service contracts and~~ professional development in
13 public schools for paraeducators and other education support professionals.

19 SECTION 1. BE IT ENACTED BY THE GENERAL ASSEMBLY OF MARYLAND,

6 REQUIREMENTS THAN IMPOSED UNDER THIS SECTION.

8 1, 2026.
