Truth, Righteousness and Love Ministries (TRL) has served the Temple Hills and greater Prince Georges County community for more than 25 years through outreach programs, educational activities, and initiatives that support families, youth, and individuals in need. The facility has long functioned as a gathering place where residents receive encouragement, community support, and opportunities for engagement that strengthen neighborhood connections. Located on Allentown Road in Temple Hills within Legislative District 26, the property sits along a well-traveled corridor that serves residents throughout the surrounding community and provides accessible opportunities for public programs and outreach activities.

However, portions of the building and surrounding property require significant infrastructure and safety improvements to ensure the facility can continue serving the community effectively. The proposed capital improvements will address critical needs, including accessibility upgrades, exterior building repairs, drainage improvements, and other structural enhancements necessary to maintain a safe and welcoming environment.

Completion of this project will allow Truth, Righteousness and Love Ministries to more fully utilize its 15,265-square-foot facility and expand its ability to serve residents of Temple Hills and Prince Georges County through community programs, outreach initiatives, educational opportunities, and partnerships that strengthen families and neighborhoods.

This investment will help preserve an important community resource and ensure the property remains a safe, accessible, and valuable gathering space for residents of all backgrounds for many years to come.
