10. Description and Purpose of Organization (Limit length to visible area)		
<p>FeedHoCo is a 501c3 nonprofit organization dedicated to reducing hunger through food distribution, fresh produce access, and community partnerships. The organization serves thousands of residents annually through volunteer-driven programs, farm-to-family distribution, and emergency food support. FeedHoCo operates with a dignity-first model, ensuring families receive healthy, reliable, and nutritious food. FeedHoCo builds a more resilient and equitable local food system that supports long-term community well-being and nutritional dignity.</p>		

11. Description and Purpose of Project (Limit length to visible area)

FeedHoCo seeks to construct a 2,400 sq ft Hunger Relief Hub to safely store food, support volunteers, and expand distribution capacity. The facility will include dry storage, cold storage, a small kitchen area for basic food handling and volunteer support, a volunteer workspace, a loading area, and essential administrative space. With enhanced storage capacity, equipment, and cold storage, we will be able to increase the shelf life of the food collected, thus reducing food waste and increasing the amount of food recovered and delivered to vulnerable Howard County residents. The added benefit is the impact of lowering greenhouse gases. This modest, efficient structure replaces inadequate temporary storage, enables FeedHoCo to meet rising community needs, and will strengthen countywide food security.
