10. Description and Purpose of Organization (Limit length to visible area)		
The Baltimore County Dept. of Recreation and Parks provides a wide range of recreational opportunities to the citizens and visitors of the County, through hundreds of parks and recreation sites countywide. Recreational facilities are provided at parks, leased recreation sites, and public school recreation centers-- the latter through a joint-use agreement whereby many indoor and outdoor facilities at public schools are used for both educational and recreational purposes. The Department administers a wide range of parks, from countywide parks up to 1,100 acres in size, to small neighborhood "pocket parks" of less than an acre. The parks feature a wide variety of facilities and free-time recreational opportunities, and hundreds of organized recreation programs are provided through partnerships with non-profit recreation and parks councils formed by volunteers.		

11. Description and Purpose of Project (Limit length to visible area)

This project consists of the next phase of renovations and enhancements to Holland Hills Park, a 6.5-acre neighborhood park in eastern Baltimore County. Various site enhancements will build upon previous site work, which centered upon renovations to the existing playground. The new grant funding will combine with existing funds, including prior State capital grants, to enable the next phase of park improvements.
