10. Description and Purpose of Organization (Limit length to visible area)		
The Holly Court Community Association is a 53 years old non-profit homeowners association that has a mission of promoting the health, safety, and welfare of all residents in a community comprised of 79 townhouse units. Based on that mission, the association has qualified for and been awarded federal tax-exempt status since 1992. The ability to fund the maintenance and preservation of the common space on its property, which includes the roads, parking spaces, sidewalks, trees, and grassy areas, is an especially important goal toward making Holly Court a responsible and valued part of the city of Columbia, Maryland. The association also motivates the owners and renters of Holly Court to do their part in improving their own properties to make Holly Court one of the most livable communities in the area.		

11. Description and Purpose of Project (Limit length to visible area)

The Holly Court Community Association (HCCA) has to maintain 0.39 mi. and 51,000 sq. ft. of road surface, but finds that it cannot raise enough funds to repair the many potholes, large cracks, and failing foundation of its aging roads. It is now a serious public safety issue for access into and out of Holly Court. HCCA's latest Reserve Study states that the condition of Holly Court's roads require immediate reconstruction. However the cost of such repairs has risen so much that it is now not affordable. HCCA's governing documents have placed severe restrictions on how much the annual assessment can be raised. A special assessment was even tried, but because a supermajority of homeowners had to vote for it, it failed to pass. The inability to fund Holly Court's road repairs leads to poor curb appeal and less pride in the community as well as depressed property values and less property tax revenues to the County. It is urgent to avoid that outcome.
